FLOOR SUBSTITUTE

[ payroll deductions - effective date ]

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 70 O.S. 2011, Section 5-139, is  
amended to read as follows:

Section 5-139. School districts ~~shall~~ may make payroll  
deductions for either or both professional organization dues and  
political contributions upon the request of any school employee and  
shall transmit deducted funds to the organization designated by the  
school district employee. Such deductions shall be on a ten-month  
basis unless otherwise designated by the employee organization.  
However, a school employee may request in writing at any time for  
the school district to immediately terminate or initiate payroll

1 deductions to a professional organization if the district chooses to  
2 provide such service. Upon receipt of a request the school district  
3 shall within five (5) business days or by the next pay period,  
4 whichever is earlier, terminate or initiate any future payroll  
5 deductions of the requesting school employee to a professional  
6 organization. Upon receipt of a request the school district shall  
7 notify the professional organization of the initiation or  
8 termination of payroll deductions within fifteen (15) business days.  
9 If the request is to terminate a deduction, the school district  
10 shall not make any advance payments to any professional organization  
11 of any future dues on behalf of the school employee.

12 SECTION 2. This act shall become effective November 1, 2015.
