b. that the contractor shall, in accordance with 1 1 paragraph 1 of subsection A of this section, be paid 1 2 based on the performance of services or other output, 1 3 that the contractor shall be permitted to work any с. hours or schedules he or she chooses, provided that if 1 5 a contractor elects to work specified hours or 1 6 schedules, a contract may require the worker to 1 7 perform work during the selected hours or schedules, 1 8 that the contractor shall be free to engage in any d. 1 9 other occupation or business opportunity, including 2 0 performing services through other qualified marketplace platforms, 2 2

that the contractor shall bear all or substantially е. all of his or her own expenses,

- f. that the qualified marketplace contractor shall be responsible for tax on the qualified marketplace contractor's own income, and
- g. that the contract and the association created thereby may be terminated without cause by either party thereto at any time upon reasonable notice given to the other.

B. For purposes of this section, the term "qualified marketplace platform" shall mean an organization, including, but not limited to, a corporation, limited liability company, partnership, sole proprietor, or any other entity, that operates a digital application or digital platform that facilitates the provision of services by qualified marketplace contractors to individuals or entities seeking such services.

C. For purposes of this section, the term "qualified 1 5 marketplace contractor" or "contractor" shall mean any person or 1 6 organization, including, but not limited to, a natural person, 1 7 corporation, limited liability company, partnership, sole 1 8 proprietor, or other entity, that enters into an agreement with a 1 9 qualified marketplace platform to use the platform's digital 2 0 application or digital platform to provide services to individuals 2 1 or entities seeking such services. 2 2

D. For services performed by a marketplace contractor prior to the enactment of this section, the qualified marketplace contractor

shall be treated as an independent contractor for all purposes under
state and local laws, regulations and ordinances, including but not
limited to the Employment Security Act of 1980 and the
Administrative Workers' Compensation Act, if:

All or substantially all of the remuneration for the
services performed by such contractor was directly related to the
performance of services or other output rather than to the number of
hours worked; and

2. The services performed by the contractor were governed by a
written contract executed between the contractor and a qualified
marketplace platform that conforms to the requirements of paragraph
3 of subsection A of this section.

SECTION 2. This act shall become effective November 1, 2016.
