An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; defining terms; stating legislative intent; summarizing appropriated funds; summarizing dedicated funds; summarizing interagency funds; summarizing other funds; providing totals; making appropriations to the State Board of Education, the Oklahoma Arts Council, the State Board of Career and Technology Education, the Office of Educational Quality and Accountability, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Commissioners of the Land Office, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Office of Management and Enterprise Services, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Oklahoma Space Industry Development Authority, the Department of Transportation, the State Department of Health, the Oklahoma Health Care

2 Developmental Disabilities, the Department of Mental
3 Health and Substance Abuse Services, the Oklahoma

12 Commerce, the Rural Economic Action Plan Fund, the
13 Oklahoma Conservation Commission, the Corporation
14 Commission, the Department of Environmental Quality,
15 the Oklahoma Historical Society, the Oklahoma Horse
16 Racing Commission, the J.M. Davis Memorial
17 Commission, the Department of Labor, the Department
18 of Mines, the Oklahoma Tourism and Recreation
19 Department, the Oklahoma Water Resources Board, the
20 Alcoholic Beverage Laws Enforcement Commission, the
21 Department of Corrections, the Office of the State
22 Fire Marshal, the Oklahoma State Bureau of
23 Investigation, the Council on Law Enforcement
24 Education and Training, the Board of Medicolegal
Investigations, the Oklahoma State Bureau of
Narcotics and Dangerous Drugs Control, the Department
of Public Safety, the Office of the Attorney General,
the Court of Criminal Appeals, district attorneys and
the District Attorneys Council, the Supreme Court,
the Oklahoma Indigent Defense System, the Pardon and
Parole Board and the Special Cash Fund; stating
amounts of the appropriations; stating purposes and
restrictions; authorizing and requiring certain
expenditures; authorizing and requiring certain
transfers; providing for noncodification; and
providing effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law not to be
codified in the Oklahoma Statutes reads as follows:

A. As used in this section:

1 1. "Total" shall mean the aggregate total of all fund sources;

2 2. "Appropriated funds" shall mean those funds identified in

3 Sections 2 through 194 of this act, as well as those identified in

4 Enrolled Senate Bill No. 1584 of the 2nd Session of the 55th

5 Oklahoma Legislature, as appropriated from the General Revenue Fund

6 or from such other funds to the state agencies indicated;

7 3. "Dedicated funds" shall mean funds available for expenditure

8 by a state agency in a revolving fund or other source identified as

9 available for use by that agency;

10 4. "Interagency funds" shall mean funds received by one state

11 agency from another state agency for services rendered as provided

12 by law; and

13 5. "Other funds" shall mean funds received from the federal

14 government or any political subdivision of this state, or pursuant

15 to gifts, grants, contributions or entitlements.

16 B. It is the intent of the Legislature that amounts identified

17 in this section are identified for informational purposes only and

18 such identification shall not limit the agency to such amounts if

19 additional funding is made available for expenditure in fiscal year

20 2017. It is the further intent of the Legislature that no ad

21 valorem tax revenue identified as "other funds" in this section be

22 construed as being used for state purposes.

18 appropriated from the Consumer Credit Administrative Expense
19 Revolving Fund (250 Fund) the sum of Four Million Dollars
20 (\$4,000,000.00) for availability of appropriation.

21 SECTION 177. There is hereby appropriated to the Special Cash
22 Fund of the State Treasury from any monies not otherwise
23 appropriated from the Oklahoma Uniform Building Code Commission
24

1 Revolving Fund (285 Fund) the sum of Eight Hundred Thousand Dollars
2 (\$800,000.00) for availability of appropriation.

3 SECTION 178. There is hereby appropriated to the Special Cash
4 Fund of the State Treasury from any monies not otherwise
5 appropriated from the Electrical Revolving Fund (245 Fund) the sum
6 of Eight Hundred Fifty Thousand Dollars (\$850,000.00) for
7 availability of appropriation.

8 SECTION 179. There is hereby appropriated to the Special Cash
9 Fund of the State Treasury from any monies not otherwise
10 appropriated from the Oklahoma Mechanical Licensing Fund (275 Fund)
11 the sum of Eight Hundred Fifty Thousand Dollars (\$850,000.00) for
12 availability of appropriation.

13 SECTION 180. There is hereby appropriated to the Special Cash
14 Fund of the State Treasury from any monies not otherwise
15 appropriated from the State Transportation Fund the sum of Fifty
16 Million Two Hundred Ten Thousand Nine Hundred Ninety-two Dollars
17 (\$50,210,992.00) for availability of appropriation.

18 SECTION 181. There is hereby appropriated to the Special Cash
19 Fund of the State Treasury from any monies not otherwise
20 appropriated from the County Improvement for Roads and Bridges
21 Revolving Fund (285 Fund) the sum of Fifty Million Dollars
22 (\$50,000,000.00) for availability of appropriation.

23 SECTION 182. There is hereby appropriated to the Special Cash
24 Fund of the State Treasury from any monies not otherwise

1 appropriated from the Construction and Maintenance Fund (310 Fund)
2 the sum of Seventy-three Million Dollars (\$73,000,000.00) for
3 availability of appropriation.

4 SECTION 183. There is hereby appropriated to the Special Cash
5 Fund of the State Treasury from any monies not otherwise
6 appropriated from the Cash-flow Reserve Fund of the Office of
7 Management and Enterprise Services the sum of One Hundred Thirty-two
8 Million Dollars (\$132,000,000.00) for availability of appropriation.

9 SECTION 184. There is hereby appropriated to the Special Cash
10 Fund of the State Treasury from any monies not otherwise
11 appropriated from the Railroad Maintenance Fund (210 Fund) the sum of
12 Twenty-six Million Six Hundred Twenty-eight Thousand Four Hundred
13 Eighty Dollars (\$26,628,480.00) for availability of appropriation.

14 SECTION 185. There is hereby appropriated to the Special Cash
15 Fund of the State Treasury from any monies not otherwise
16 appropriated from the Senate Revolving Fund (200 Fund) the sum of
17 One Million Five Hundred Thousand Dollars (\$1,500,000.00) for
18 availability of appropriation.

19 SECTION 186. TRANSFER The State Treasurer shall transfer from
20 unclaimed deposits received during the five years prior to July 1,
21 2011, the amount of One Hundred Twenty-nine Thousand Six Hundred
22 Forty-six Dollars and Forty cents (\$129,646.40) to the Vault to
23 compensate for cumulative encoding adjustments, settlement
24 discrepancies, and deposit adjustments during the same time period.

1 SECTION 187. TRANSFER The State Treasurer shall transfer from
2 unclaimed deposits received during the five years prior to July 1,
3 2011, the amount of Nine Hundred Thirty-two Dollars and Thirty-six
4 cents (\$932.36) for bad checks net of vault overages as of May 12,
5 2016.

6 SECTION 188. TRANSFER The State Treasurer shall transfer from
7 unclaimed deposits received during the five years prior to July 1,
8 2011, the amount of Seven Hundred Fifty-four Thousand Two Hundred
9 Seventy-five and Two cents (\$754,275.02) to the Special Cash Fund of
10 the State Treasury.

11 SECTION 189. There is hereby appropriated to the Office of
12 Management and Enterprise Services from any monies not otherwise
13 appropriated from the Special Cash Fund of the State Treasury the
14 sum of Eight Million Seventy-eight Thousand One Hundred Twenty
15 Dollars (\$8,078,120.00) or so much thereof as may be necessary to
16 perform the duties imposed upon the Office of Management and
17 Enterprise Services by law.

18 SECTION 190. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 Special Cash Fund of the State Treasury the sum of Forty-seven
21 Million Seventy-four Thousand Ninety-one Dollars (\$47,074,091.00) to
22 be transferred to the Ad Valorem Reimbursement Fund, created
23 pursuant to Section 193 of Title 62 of the Oklahoma Statutes, for
24 the purpose of reimbursing counties for school districts that claim

1 a loss of revenue due to a tax exemption granted pursuant to the
2 provisions of Section 6B of Article X of the Oklahoma Constitution.

3 SECTION 191. There is hereby appropriated to the Special Cash
4 Fund of the State Treasury from any monies not otherwise
5 appropriated from the Rebuilding Oklahoma Access and Driver Safety
6 Fund (275 Fund) the sum of Two Hundred Million Dollars
7 (\$200,000,000.00) for availability of appropriation.

8 SECTION 192. There is hereby appropriated to the Oklahoma
9 Health Care Authority from any monies not otherwise appropriated
10 from the Special Cash Fund of the State Treasury the sum of Two
11 Hundred Million Dollars (\$200,000,000.00) or so much thereof as may
12 be necessary to perform the duties imposed upon the Oklahoma Health
13 Care Authority by law.

14 SECTION 193. There is hereby appropriated to the Special Cash
15 Fund of the State Treasury from any monies not otherwise
16 appropriated from the Unclaimed Property Fund (711 Fund) the sum of
17 Fifteen Million Dollars (\$15,000,000.00) for availability of
18 appropriation.

19 SECTION 194. There is hereby appropriated to the Department of
20 Corrections from any monies not otherwise appropriated from the
21 Special Cash Fund of the State Treasury the sum of Fifteen Million
22 Dollars (\$15,000,000.00) or so much thereof as may be necessary to
23 perform the duties imposed upon the Department of Corrections by
24 law.

1 SECTION 195. Sections 2 through 189 of this act shall become
2 effective July 1, 2016.

3 SECTION 196. Sections 191 through 194 of this act shall become
4 effective December 1, 2016.
