17 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE  
18 1ST SESSION OF THE 55TH OKLAHOMA LEGISLATURE:

19                   SECTION 1. The Secretary of State shall refer to the people for  
20 their approval or rejection, as and in the manner provided by law,  
21 the following proposed amendment to Section 26 of Article V of the  
22 Constitution of the State of Oklahoma to read as follows:

23                   Section 26. A. The Legislature shall meet in regular session  
24 at the seat of government at twelve o'clock noon on the first Monday

1 in February of each year and the regular session shall be finally  
2 adjourned sine die not later than five o'clock p.m. on the last  
3 Friday in May of each year.

4 B. The Legislature shall also meet in regular session at the  
5 seat of government on the first Tuesday after the first Monday in  
6 January of each odd numbered year, beginning at twelve o'clock noon  
7 for the purposes only of performing the duties as required by  
8 Section 5 of Article VI of the Constitution and organizing pursuant  
9 to the provisions of this Article and shall recess not later than  
10 five o'clock p.m. of that same day until the following first Monday  
11 in February of the same year, beginning at twelve o'clock noon.

12 C. During each even-numbered year, the Legislature shall only  
13 consider carry-over measures from the preceding odd-numbered year,  
14 measures related to budgetary or revenue and financial matters,  
15 measures disapproving or approving agency rules, measures  
16 disapproving or approving standards adopted by the State Board of  
17 Education, measures disapproving, repealing or modifying rules of  
18 the Ethics Commission, measures introduced for the purposes of  
19 incorporating and merging different versions of statutes amended in  
20 more than one measure at the same or different sessions of the  
21 Legislature, and measures authored by the President Pro Tempore of  
22 the Senate and the Speaker of the House of Representatives which are  
23 deemed by them to be necessary for the preservation of public peace,  
24

1 health or safety. The Legislature shall not meet for more than  
2 forty-five (45) legislative days during an even-numbered year.

3 D. The changes made to this section pursuant to this amendment  
4 shall become effective January 1, 2017.

5 SECTION 2. The Ballot Title for the proposed Constitutional  
6 amendment as set forth in SECTION 1 of this resolution shall be in  
7 the following form:

10 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

11 This measure amends the Oklahoma Constitution. It amends  
12 Section 26 of Article 5. It would limit the types of measures  
13 that could be considered in the even-numbered year of a  
14 Legislature. It would allow carry-over measures from the  
15 previous year, budgetary measures, measures dealing with agency  
16 rules, measures merging duplicate versions of laws, and certain  
17 measures necessary for the preservation of public peace, health  
18 or safety. It would also limit sessions during even-numbered  
19 years to not more than forty-five (45) legislative days.
