An Act relating to elections; amending 26 O.S. 2011, Sections 14-104 and 14-108, which relate to absentee voting; authorizing hand delivery of ballot to county election board; limiting time period for delivery; requiring proof of identity; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 26 O.S. 2011, Section 14-104, is amended to read as follows:

Section 14-104. Absentee ballots shall be returned to the secretary of each county election board no later than 7:00 p.m. the day of the election; provided, absentee ballots that are hand delivered to the county election board as provided in Section 14-108 of this title shall be delivered no later than the end of regular business hours on the day prior to the date of the election.

SECTION 2. AMENDATORY 26 O.S. 2011, Section 14-108, is amended to read as follows:

1 Section 14-108. A. The voter shall be required to mark the
2 ballot in ink or other manner as prescribed by the Secretary of the
3 State Election Board; seal the ballots in the plain opaque envelope;
4 fill out completely and sign the affidavit, such signature to be
5 notarized at no charge by a notary public; seal the plain opaque
6 envelope inside the envelope bearing the affidavit and return both
7 envelopes, sealed inside the return envelope, by hand delivery,
8 United States mail or by a private mail service, provided such
9 service has delivery documentation, to the county election board.
10 No person who is a candidate for an office on the ballot or who is
11 the chair or treasurer of the campaign of a candidate for office or
12 who is related within the third degree of consanguinity or affinity
13 to a candidate on the ballot may witness any absentee ballot
14 affidavit.

15 B. The ballot shall not be notarized by any person whose name
16 appears on the ballot as a candidate or by any campaign chairperson
17 or campaign treasurer for a candidate whose name appears on the
18 ballot.

19 C. Any voter who hand delivers his or her ballot as provided in
20 subsection A of this section shall provide proof of identity to the
21 county election board and shall hand deliver the ballot no later
22 than the end of regular business hours on the day prior to the date
23 of the election. For purposes of this section, "proof of identity"
24

1 shall have the same meaning as used in subsection A of Section 7-114
2 of this title.

3 SECTION 3. This act shall become effective January 1, 2017.
