SENATE BILL 1523

AS INTRODUCED

An Act relating to the Tobacco Settlement Endowment Trust Fund; amending 62 O.S. 2011, Section 2309, as amended by Section 1, Chapter 98, O.S.L. 2015 (62 O.S. Supp. 2015, Section 2309), which relates to the duties of the Board of Directors; broadening scope of allowable uses of certain funds; clarifying language; and providing conditional effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 62 O.S. 2011, Section 2309, as amended by Section 1, Chapter 98, O.S.L. 2015 (62 O.S. Supp. 2015, Section 2309), is amended to read as follows:

Section 2309. A. The Board of Directors of the Tobacco Settlement Endowment Trust Fund shall be empowered to:

1. Appoint an executive director and other staff necessary to perform the duties of the Board ~~of Directors~~;

2. Make and execute contracts and other instruments necessary or convenient to the exercise of its powers on such terms and for such period of time as the Board ~~of Directors~~ shall determine; and

3. Promulgate rules in accordance with the Administrative Procedures Act and not inconsistent with the Tobacco Settlement

1 Endowment Trust Fund Act to implement its duties and
2 responsibilities as provided by law.

3 B. Funding for capital expenditures and operating expenses
4 incurred by the University of Oklahoma Health Sciences Center and
5 the Oklahoma State University College of Osteopathic Medicine, for
6 educational programs and residency training to maintain or improve
7 the health of Oklahomans or to enhance the provision of health care
8 services to Oklahomans, is hereby deemed to be an allowable purpose
9 for which earnings from the trust fund may be expended pursuant to
10 the provisions of paragraph 3 of subsection E of Section 40 of
11 Article X of the Oklahoma Constitution. Pursuant to its authority
12 as set forth in subsection G of Section 40 of Article X of the
13 Oklahoma Constitution, the Legislature hereby authorizes the Board
14 to expend earnings from the trust fund for such purposes, in
15 addition to other purposes provided by law.

16 C. Funding to increase compensation for full-time certified
17 teachers for the 2017-2018, 2018-2019, 2019-2020, 2020-2021 and
18 2021-2022 school years is hereby deemed to be an allowable purpose
19 for which earnings from the trust fund may be expended pursuant to
20 the provisions of paragraph 3 of subsection E of Section 40 of
21 Article X of the Oklahoma Constitution. Pursuant to its authority
22 as set forth in subsection G of Section 40 of Article X of the
23 Oklahoma Constitution, the Legislature hereby authorizes the Board
24 to expend earnings from the trust fund for such purposes.

1 ~~C.~~ D. The Board shall develop a multiyear strategy by January
2 1, 2002, and annually update it in order to guide the Board's
3 funding for those programs set forth in Section 40 of Article X of
4 the Oklahoma Constitution. The strategy shall be used to maximize
5 the outcomes of the grants awarded by the Board ~~of Directors~~.

6 ~~D.~~ E. The Board ~~of Directors~~ shall develop grant programs for
7 private, nonprofit, and public entities for the purposes set forth
8 in Section 40 of Article X of the Oklahoma Constitution.

9 1. The selection and awarding of grants, whether in the form of
10 professional service contracts or any other funding mechanism
11 developed by the Board ~~of Directors~~, awarded pursuant to grant
12 programs developed under this subsection, shall be exempt from the
13 requirements of The Oklahoma Central Purchasing Act.

14 2. The Board ~~of Directors~~ shall develop competitive processes
15 for awarding grants under programs developed under this subsection.
16 Such competitive processes for selection shall not be required for
17 contracts awarded for program support services, including, but not
18 limited to, professional service contracts to evaluate, audit or
19 provide budgeting, accounting, auditing or legal services for
20 specific programs or program grantees, contractors or participants.

21 3. The Board ~~of Directors~~ may promulgate rules to assist in the
22 implementation and administration of grant programs developed under
23 this subsection.

1 4. The terms of any request for proposals, request for
2 applications, invitation for bid, bid notice, or grant proposal or
3 any other solicitation issued by the Board ~~of Directors~~ to solicit
4 or invite applications, proposals, bids or responses to obtain
5 funding under grant programs developed under this subsection shall
6 be confidential until the date and time at which the solicitation is
7 to be made equally and uniformly known to all prospective applicants
8 and the public, at which point all such documents and information
9 shall be uniformly known to all prospective applicants and the
10 public, at which point all such documents and information shall be
11 subject to the Oklahoma Open Records Act and Oklahoma Open Meeting
12 Act. Any application, proposal, bid, or any other document to
13 obtain funding responsive to any solicitation of the Board ~~of~~
14 ~~Directors~~ under grant programs developed under this subsection shall
15 be confidential until the date and time of award of the grant or
16 contract, at which point all such documents and information shall be
17 subject to the Oklahoma Open Records Act and Oklahoma Open Meeting
18 Act. Any unsolicited application, proposal, bid, or any other
19 document to obtain funding shall not be considered to be
20 confidential and shall be subject to the Oklahoma Open Records Act
21 and Oklahoma Open Meeting Act at all times.

22 E. F. The Board ~~of Directors~~ shall encourage grantees to match
23 grant monies awarded with monetary commitments and in-kind matches.

1 ~~F.~~ G. The Board ~~of Directors~~ shall be required to develop a
2 performance evaluation component for the ~~Board of Directors'~~ Board's
3 activities and those of its grantees so that the performance of
4 grantees can be measured by their attainment of outcomes.

5 ~~G.~~ H. The Board ~~of Directors~~ shall contract periodically for
6 performance evaluations. Copies of the evaluations shall be filed
7 with the Governor, the Speaker of the House of Representatives, and
8 the President Pro Tempore of the Senate.

9 ~~H.~~ I. The Board ~~of Directors~~ shall prepare an annual report
10 detailing the ~~Board of Directors'~~ Board's activities and reporting
11 its expenditures and the outcomes achieved by the expenditures. A
12 copy of the report shall be submitted to the Governor, the Speaker
13 of the House of Representatives, and the President Pro Tempore of
14 the Senate.

15 ~~I.~~ J. All records associated with the expenditure of monies
16 received by the Board ~~of Directors~~ or its grantees pursuant to the
17 Tobacco Settlement Endowment Trust Fund Act shall be subject to the
18 Oklahoma Open Records Act.

19 SECTION 2. This act shall become effective upon certification
20 of election returns favoring passage of the Constitutional Amendment
21 proposed in Senate Joint Resolution No.69 of the 2nd Session of the
22 55th Oklahoma Legislature.
