15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. There is hereby appropriated to the Oklahoma Health
17	Care Authority from any monies not otherwise appropriated from the
18	General Revenue Fund of the State Treasury for the fiscal year
19	ending June 30, 2017, the sum of One Hundred Thousand Dollars
20	(\$100,000.00) or so much thereof as may be necessary to perform the
21	duties imposed upon the Oklahoma Health Care Authority by law.
22	SECTION 2. Appropriations made by this act, not including
23	appropriations made for capital outlay purposes, may be budgeted for
24	the fiscal year ending June 30, 2017 (hereafter FY-17), or may be

    budgeted for the fiscal year ending June 30, 2018 (hereafter FY-18).
    Funds budgeted for FY-17 may be encumbered only through June 30,
 2
    2017, and must be expended by November 15, 2017. Any funds
 3
    remaining after November 15, 2017, and not budgeted for FY-18, shall
 4
 5
    lapse to the credit of the proper fund for the then current fiscal
    year. Funds budgeted for FY-18 may be encumbered only through June
 6

    30, 2018. Any funds remaining after November 15, 2018, shall lapse
    to the credit of the proper fund for the then current fiscal year.

    These appropriations may not be budgeted in both fiscal years
10
    simultaneously. Funds budgeted in FY-17, and not required to pay

    obligations for that fiscal year, may be budgeted for FY-18, after

    the agency to which the funds have been appropriated has prepared
    and submitted a budget work program revision removing these funds
13
    from the FY-17 budget work program and after such revision has been
14
    approved by the Office of Management and Enterprise Services.

        SECTION 3. This act shall become effective July 1, 2016.

        SECTION 4. It being immediately necessary for the preservation

    of the public peace, health and safety, an emergency is hereby

    declared to exist, by reason whereof this act shall take effect and

    be in full force from and after its passage and approval.
