EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma

Education Lottery Trust Fund from any monies not otherwise

appropriated from the Special Cash Fund of the State Treasury, the

sum of Ten Million One Hundred Forty-four Thousand One Hundred

Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be

necessary pursuant to the provisions of subsection E of Section 713

of Title 3A of the Oklahoma Statutes.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2018, the sum of One Billion Twenty-one Million Seventy-two Thousand Two Hundred Sixty-seven Dollars (\$1,021,072,267.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million Four Hundred Seven Thousand One Hundred Thirty-eight Dollars (\$695,407,138.00) or so much thereof as may be necessary for the financial support of public schools.
