9 An Act relating to schools; amending 70 O.S. 2011,
10 Section 5-135.4, which relates to the School District
11 Transparency Act; modifying information to be
12 included in certain database; modifying calculation
13 for certain information; and providing an effective
14 date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 70 O.S. 2011, Section 5-135.4, is
17 amended to read as follows:

18 Section 5-135.4 A. This section shall be known and may be
19 cited as the "School District Transparency Act".

20 B. By January 30, 2011, the State Department of Education shall
21 make school district expenditure data available on its website.

22 Data shall be made available in an open-structured data format that
23 may be downloaded by the public and that allows the user to
24 systematically sort, search, and access all data without any fee or
charge for access.

1 C. The database shall provide information on school district
2 expenditures of state, federal, and local funds, whether
3 appropriated or nonappropriated, excluding payments of voluntary
4 payroll deductions for employees to receiving parties. The database
5 shall further provide information, including, but not limited to,
6 the following:

7 1. Identification of the school district;

8 2. The Oklahoma Cost Accounting System (OCAS) code designation
9 for each expenditure;

10 3. The name and principal location of the entity or recipient
11 of the funds, excluding release of information relating to an
12 individual's place of residence and release of information
13 prohibited by subsection D of Section 24A.7 of Title 51 of the
14 Oklahoma Statutes or by federal law relating to privacy rights;

15 4. The amount of funds expended;

16 5. The type of transaction;

17 6. A descriptive purpose of the funding action or expenditure;

18 7. ~~Copies of all credit card statements, identified by~~
19 ~~department responsible for each credit card;~~

20 ~~8.~~ The budgeted and audited actual expenditure figures for each
21 fiscal year, ensuring each set of figures can be identified as
22 budgeted or audited figures; and

1 ~~9.~~ 8. The per-pupil spending figure, derived by dividing total
2 current expenditures by the total number of students enrolled for
3 each school year.

4 D. The Department shall make the data available on its website
5 within one hundred twenty (120) days of transmission of the
6 expenditures to the Department by the school district.

7 E. School districts shall provide information requested by the
8 Department to accomplish the purposes of this section.

9 F. If a school district maintains a website, the district shall
10 provide the information required in subsection C of this section in
11 the manner prescribed in subsection B of this section on the
12 district website.

13 G. Nothing in this section shall require the disclosure of
14 information which is required to be kept confidential by state or
15 federal law.

16 H. The disclosure of information required by this section shall
17 create no liability whatsoever, civil or criminal, to the State of
18 Oklahoma, the State Department of Education, school districts, or
19 any employee thereof for disclosure of required information or for
20 any error or omission in the disclosure.

21 SECTION 2. This act shall become effective November 1, 2017.
