PROPOSED COMMITTEE SUBSTITUTE

An Act relating to alcoholic beverages; amending Section 16, Chapter 366, O.S.L. 2016 (37A O.S. Supp. 2016, Section 2-104), which relates to winemaker licenses; authorizing certain sales of wine by licensee; amending Section 76, Chapter 366, O.S.L. 2016 (37A O.S. Supp. 2016, Section 3-106), which relates to direct wine shipping permits; eliminating the Direct Wine Consumer's Permit; eliminating certain application criteria; eliminating certain rulemaking authority; eliminating certain labeling requirement; modifying prohibition on certain types of shipments; requiring certain age verification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 16, Chapter 366, O.S.L. 2016 (37A O.S. Supp. 2016, Section 2-104), is amended to read as follows:

Section 2-104. A winemaker license shall authorize the holder thereof:

1 1. To manufacture (including such mixing, blending and cellar
2 treatment as authorized by federal law), bottle, package and store
3 on licensed premises wine containing not more than twenty-four
4 percent (24%) alcohol by volume, provided the bottle or package
5 sizes authorized shall be limited to the capacities approved by the
6 United States Alcohol and Tobacco Tax and Trade Bureau;

7 2. To sell wine in this state to licensed wholesalers and
8 manufacturers;

9 3. To sell ~~bottles of~~ wine produced at the winery from grapes
10 and other fruits and berries grown in this state, if available, for
11 either on-premises or off-premises consumption to consumers on the
12 premises of the winery;

13 4. To serve free samples of wine produced at the winery to
14 visitors twenty-one (21) years of age and older. For purposes of
15 this section, no visitor may sample more than a total of six (6)
16 fluid ounces of wine per day. The winery shall restrict the
17 distribution and consumption of wine samples to an area within the
18 licensed premises designated by the winery. A current floor plan
19 that includes the designated sampling area shall be on file with the
20 ABLE Commission. No visitor under twenty-one (21) years of age
21 shall be permitted to enter the designated sampling area when
22 samples are being distributed and consumed. Samples of wine served
23 by a winery under this section shall not be considered a sale of
24 wine within the meaning of Article XXVIII A of the Oklahoma

1 Constitution or Section ~~3~~ 1-103 of this ~~act~~ title; provided, such
2 samples of wine shall be considered removed or withdrawn from the
3 winery for use or consumption within the meaning of Section ~~113~~ 5-
4 110 of this ~~act~~ title for excise tax determination and reporting
5 requirements;

6 5. To serve samples of wine produced at the winery at public
7 events such as festivals and trade shows;

8 6. To sell wine produced at the winery, in original sealed
9 containers, at public events such as festivals and trade shows;

10 7. To sell wine out of this state to qualified persons; and

11 8. To purchase from licensed winemakers, distillers and
12 rectifiers in this state, and to import into this state wine, brandy
13 and fruit spirits for use in manufacturing in accordance with
14 federal laws and regulations.

15 SECTION 2. AMENDATORY Section 76, Chapter 366, O.S.L.
16 2016 (37A O.S. Supp. 2016, Section 3-106), is amended to read as
17 follows:

18 Section 3-106. A. A Direct Wine Shipper's Permit may be issued
19 by the Oklahoma ABLE Commission to a winery licensed in this or any
20 other state within the United States as a wine producer. A Direct
21 Wine Shipper's Permit allows a winery to ship up to six nine-liter
22 cases of wine annually directly to an Oklahoma resident who is
23 twenty-one (21) years of age or older for such resident's personal
24 use and not for resale. No resident shall be permitted to purchase

1 more than thirty nine-liter cases of wine per year under the
2 provisions of this section.

3 ~~B. A Direct Wine Consumer's Permit may be issued by the ABLE~~
4 ~~Commission to a resident who is twenty-one (21) years of age or~~
5 ~~older and wishes to purchase wine directly from a winery pursuant to~~
6 ~~this section.~~

7 ~~C.~~ The ABLE Commission shall promulgate rules governing the
8 application, issuance and renewal of Direct Wine Shipper's Permits,
9 which shall include but not be limited to:

10 1. Proof of current licensure in this or any other state as a
11 wine producer;

12 2. Payment of a registration fee of Three Hundred Dollars
13 (\$300.00) for original permits and One Hundred Fifty Dollars
14 (\$150.00) for renewal permits; and

15 3. Any other documentation that the ABLE Commission believes is
16 reasonably necessary to verify the identity and physical location of
17 the winery.

18 ~~D. The ABLE Commission shall promulgate rules governing the~~
19 ~~application, issuance and renewal of Direct Wine Consumer's Permits,~~
20 ~~which shall include but not be limited to:~~

21 ~~1. A sworn statement verifying that the applicant is at least~~
22 ~~twenty-one (21) years of age upon the date of application submission~~
23 ~~and that the wine is intended for personal use and not for resale;~~
24 ~~and~~

1 ~~2. Any other documentation that the ABLE Commission believes is~~
2 ~~reasonably necessary to verify the identity or age of the applicant.~~

3 ~~E.~~ C. With regard to direct wine shipments permitted by this
4 section, Direct Wine Shipper permit holders:

5 1. Shall not ship more than six nine-liter cases of wine
6 annually to any person for his or her personal use;

7 2. Shall not ship wine intended for resale;

8 3. Shall ensure that all containers of wine shipped directly to
9 a resident in this state ~~include the Direct Wine Consumer's Permit~~
10 ~~Number issued by the ABLE Commission and~~ are conspicuously labeled
11 with the words "CONTAINS ALCOHOL: SIGNATURE OF PERSON AGE 21 OR
12 OLDER REQUIRED FOR DELIVERY.";

13 4. Shall require the transporter or common carrier that
14 delivers the wine to obtain the signature of a person twenty-one
15 (21) years of age or older at the delivery address at the time of
16 delivery. At the expense of the Direct Wine Shipper, the Direct
17 Wine Shipper shall receive a delivery confirmation from the express
18 company, common carrier or contract carrier indicating the location
19 of delivery, time of delivery and the name and signature of the
20 individual who accepted the delivery. The ABLE Commission shall
21 design and create a label or approve a label that must be affixed to
22 the shipping container by the licensee;

23 5. Shall not ship into the state, wine otherwise available in
24 Oklahoma;

1 6. Shall report to the ABLE Commission annually, by a method
2 prescribed by the ABLE Commission, the total amount of wine shipped
3 into the state the preceding calendar year;

4 7. Shall annually pay to the Oklahoma Tax Commission all
5 applicable taxes due on sales authorized by this section to Oklahoma
6 residents in the preceding calendar year. The amount of such taxes
7 shall be calculated as if the sale were in Oklahoma at the location
8 where delivery is made. Upon request, permit holders shall permit
9 the Tax Commission to perform an audit of the permit holder's
10 records in order to assure compliance; ~~and~~

11 8. Shall be deemed to have consented to the jurisdiction of any
12 agency or court of the State of Oklahoma tasked with the enforcement
13 of or adjudication of controversies related to this section and any
14 related laws or rules; and

15 9. Shall require the consumer to verify, by electronic means or
16 otherwise, that the consumer is at least twenty-one (21) years of
17 age.

18 ~~F.~~ D. No express company, common carrier or contract carrier
19 nor any representative, agent or employee on behalf of the same
20 shall knowingly deliver any shipping container that contains an
21 alcoholic beverage into this state, unless it complies with the
22 provisions of this section. No express company, common carrier or
23 contract carrier nor any representative, agent or employee on behalf
24 of the same shall knowingly deliver any shipping container that is

1 clearly labeled as containing an alcoholic beverage, including but
2 not limited to the lawful shipment of wine under this section, to
3 any person in this state who is under the age of twenty-one (21) at
4 the time of delivery. Any express company, common carrier or
5 contract carrier that carries or transports alcoholic beverages for
6 delivery within this state in violation of this section shall be
7 guilty of a misdemeanor and for the first offense be fined not more
8 than Two Thousand Five Hundred Dollars (\$2,500.00), for a second
9 offense shall be fined not more than Five Thousand Dollars
10 (\$5,000.00) and for a third and subsequent offense be fined not more
11 than Ten Thousand Dollars (\$10,000.00). An express company, common
12 carrier and contract carrier shall be held vicariously liable for
13 the actions of its representatives, agents and employees for actions
14 in violation of this section.

15 SECTION 3. This act shall become effective October 1, 2018.
