An Act relating to state fire marshal; amending 68 O.S. 2011, Section 50001, as amended by Section 569, Chapter 304, O.S.L. 2012 (68 O.S. Supp. 2016, Section 50001), which relates to tax on fire insurance gross premiums; redirecting certain amount of monies collected to the Fire Marshal Fund and General Revenue Fund; amending 74 O.S. 2011, Sections 325.1, as amended by Section 1, Chapter 161, O.S.L. 2012 and 325.3, as amended by Section 3, Chapter 220, O.S.L. 2013 (74 O.S. Supp. 2016, Sections 325.1 and 325.3), which relate to the State Fire Marshal; abolishing the Oklahoma Council on Firefighter Training; transferring duties, equipment and funds to the State Fire Marshal; creating the Firefighter Training Advisory Committee within the Office of the State Fire Marshal; providing for membership of the Committee; directing Committee to advise and assist State Fire Marshal; providing Committee meeting frequency to be determined by State Fire Marshal Commission; transferring certain duties of the Council on Firefighter Training to the State Fire Marshal Commission; amending 68 O.S. 2011, Section 2358.7, as amended by Section 2, Chapter 161, O.S.L. 2012 (68 O.S. Supp. 2016, Section 2358.7), which relates to tax credits for volunteer firefighters; transferring certain duties of the Council on Firefighter Training to the State Fire Marshal Commission; amending Section 1, Chapter 220, O.S.L. 2013 (70 O.S. 1 Commission; providing an effective date; and declaring an emergency. 2 3 4 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 5 SECTION 1. AMENDATORY 68 O.S. 2011, Section 50001, as amended by Section 569, Chapter 304, O.S.L. 2012 (68 O.S. Supp. 6 7 2016, Section 50001), is amended to read as follows: Section 50001. A. There is hereby levied upon percentages of 8 9 fire insurance gross premiums from a sum of the following lines of 10 insurance: fire, allied, homeowners multiperil, commercial 11 multiperil, growing crops, ocean marine, inland marine, auto 12 physical damage (including collision), and aircraft physical damage, 13 less returns and dividends to policyholders, which is issued in this 14 state by companies doing business in this state a tax of five-15 sixteenths of one percent (5/16 of 1%). The percentages of fire 16 insurance gross premiums to be considered for taxation shall be 17 determined annually by the Commissioner. This tax shall be 18 collected annually, by the last day of February, from companies 19 collecting such premiums and shall be collected by the Insurance 20 Commissioner as other taxes on insurance are collected. 21 Insurance Commissioner shall keep a separate account of all such 22 monies received and shall pay the same to the State Treasurer. 23 There is hereby created in the State Treasury a fund for the В.

- <u>D.</u> Employees of the Office of State Fire Marshal, other than the State Fire Marshal, shall have salaries commensurate with those fixed by the Merit System of Personnel Administration. All salaries shall be payable monthly from funds available to the State Fire Marshal. The State Fire Marshal, subject to confirmation by the Fire Marshal Commission, shall appoint and fix the salaries of such employees as are necessary to fulfill the duties of his office.
- 14 SECTION 2. AMENDATORY 74 O.S. 2011, Section 325.1, as
  15 amended by Section 1, Chapter 161, O.S.L. 2012 (74 O.S. Supp. 2016,
  16 Section 325.1), is amended to read as follows:

Any unexpended balance of the 24 Oklahoma Council on Firefighter Training's operational funds as of

1 January 1, 2018, shall be transferred to the Office of State Fire Marshal Revolving Fund. B. There is hereby established within the Oklahoma Council on 3 Firefighter Training Office of the State Fire Marshal, the 4 5 Firefighter Training Advisory Committee. 6 B. C. The Council Committee shall consist of ten (10) members, three of whom shall be ex officio and nonvoting, as follows: 7 1. One member to be appointed by the Oklahoma State 8 Firefighters Association who shall be a member of an Oklahoma fire 10 department representing all members of paid, volunteer and 11 combination fire departments;

2. One member to be appointed by the Professional Fire Fighters of Oklahoma who shall be a fire union officer, chief officer, or fire service instructor from a full-time paid fire department;

3. One member to be appointed by the Oklahoma Fire Chiefs'
Association who shall be a chief officer from an Oklahoma career or

4. One member to be appointed by the State Fire Marshal Commission who shall be a representative of the Oklahoma Fire Service with preferred skills in arson investigation or code enforcement;

5. One member to be appointed by the Oklahoma Rural Fire

Coordinators who shall be a chief officer or fire service instructor

from a volunteer fire department;

6. One member to be appointed by the Director of the State
Department of Health-Emergency Medical Services Division who shall
be a chief officer or fire service EMS instructor from an Oklahoma
<pre>fire department;</pre>
7. One member to be appointed by the Director of the Oklahoma
Department of Homeland Security who shall be a municipal emergency
management official;
8. The Director of Fire Service Training, Oklahoma State
University, ex officio and nonvoting;
9. The Director of Fire Service Publications, Oklahoma State
University, ex officio and nonvoting; and
10. The Director of the Oklahoma Department of Career and
Technology Education or the Director's designee, ex officio and
nonvoting.
C. The initial term of office for the members of the Council
shall be:
1. Three (3) years for persons appointed pursuant to paragraphs
1 through 3 of subsection B of this section;
2. Two (2) years for persons appointed pursuant to paragraphs 4
and 5 of subsection B of this section; and
3. One (1) year for persons appointed pursuant to paragraphs 6
and 7 of subsection B of this section.

D. After the expiration of the initial terms of office
prescribed by subsection C of this section, the term of office for
each member of the Council shall be for a period of three (3) years.

- E. Each member of the Council shall serve at the pleasure of the appointing authority.
- F. Appointments made to fill a vacancy in any position shall be for the period of time remaining for such appointed position and shall be made in the same manner as for the original appointment.

  Any vacancy in the Council shall be filled in the same manner as provided for in the original appointment.
- G. representatives of the Oklahoma Fire Service, with the total number and length of appointments to be determined by the State Fire Marshal Commission.
  - D. The Council Committee shall be responsible for:
- 1. Identifying Advise and assist the State Fire Marshal

  Commission in identifying firefighter training needs and setting the firefighter training goals for the State of Oklahoma;
- 2. Interacting Advise and assist the State Fire Marshal

  Commission in interacting with the Homeland Security Department's

  Preparedness and Awareness Division on firefighter training and

  grants;
- 3. Administering Advise and assist the State Fire Marshal

  Commission in administering and maintaining the incentive and recognition programs established for Oklahoma firefighters; and

4. Ensuring Advise and assist the State Fire Marshal Commission in ensuring that the state has consistent basic and continuing education programs that include steps for all ranks or positions of career and volunteer firefighters, by setting minimum standards for career, recommended levels for volunteer, identifying training programs and courses required for fire service members to achieve those levels.

H. E. The Council Committee shall advise assist the State Fire

Marshal Commission in advising the Governor, the Speaker of the

House of Representatives, the President Pro Tempore of the State

Senate and the Oklahoma State Fire Service on fire and emergency

service training needs for the state. The Council State Fire

Marshal Commission shall submit an annual report or recommendations

regarding fire and emergency service training needs to the Governor,

the Speaker of the House of Representatives and the President Pro

Tempore of the State Senate not later than December 31 each year.

I. After the initial appointments to the Council have been made and at the beginning of each fiscal year thereafter, the Council shall select from among its membership a chairperson and vice—chairperson. The chairperson and vice—chairperson shall be selected annually at the first regularly scheduled meeting of the Board on or after July 1. Either the current chairperson or current vice—chairperson shall be a current volunteer member of a combination or volunteer—fire—department.

J. At least four members of the Council must be present to constitute a quorum at the meetings of the Council. A simple majority of the members in attendance and voting shall constitute passage of any vote.

K. The chair of the Council shall recommend to the appointing authority the replacement of any Council member who misses more than two consecutive regular meetings or who attends less than fifty percent (50%) of the Council's regularly scheduled meetings in a twelve-month period without an excused absence.

L. The Council may seek federal and private grants where applicable.

M. The Council shall conduct six meetings annually. Meetings of the Council shall be held at a location and time to be determined by the chair. The chair shall have the discretion to cancel or reschedule any regular meeting by written notice within a reasonable time prior to the meeting. Council members shall be notified of the time and place of all such meetings at least seven (7) days prior to the meeting date.

N. Special meetings of the Council may be called at the discretion of the chair or by a written request of at least three members of the Council. An agenda, together with a written notice of the time and place of any such meeting must be provided to the Council members at least seven (7) days in advance. Only matters contained in the agenda shall be voted on at any special meeting.

are canceled only with their consent.

- F. The Committee shall meet at the discretion of the State Fire Marshal Commission.
- SECTION 3. AMENDATORY 74 O.S. 2011, Section 325.3, as
  amended by Section 3, Chapter 220, O.S.L. 2013 (74 O.S. Supp. 2016,
  Section 325.3), is amended to read as follows:
- 9 Section 325.3 A. Oklahoma State University Fire Service 10 Training in conjunction with the Oklahoma Office of Homeland 11 Security and the Oklahoma Council on Firefighter Training (COFT) 12 State Fire Marshal Commission shall develop a program to educate 13 firefighters on a unified command protocol for emergency incidents 14 occurring in this state. This program shall be offered statewide by 15 Oklahoma State University Fire Service Training. Methods of 16 training may include, but are not limited to:
  - 1. Live classroom sessions with approved instructors;
  - 2. Live exercises and drills with approved instructors;
  - 3. Interactive television;
  - 4. Independent study; and
  - 5. Web-based methods.

B. The training program shall be in compliance with the
National Incident Management System (NIMS) and shall include

- provisions consistent with the National Fire Protection Association training courses.
  - C. The program shall have curriculum and training materials that are consistently utilized by all training providers at all training locations.

- D. Subject to funding, these programs shall be offered at facilities approved by Oklahoma State University Fire Service Training and shall include, but not be limited to, other institutions of higher education, technology center school facilities, local fire departments and other qualified entities.
- E. Oklahoma State University Fire Service Training shall carry out all duties and responsibilities in accordance with Section 1

  3401.2 of this act Title 70 of the Oklahoma Statutes.
- SECTION 4. AMENDATORY 68 O.S. 2011, Section 2358.7, as amended by Section 2, Chapter 161, O.S.L. 2012 (68 O.S. Supp. 2016, Section 2358.7), is amended to read as follows:
  - Section 2358.7 A. For taxable years beginning after December 31, 2004, there shall be allowed as a credit against the tax imposed pursuant to Section 2355 of this title an amount equal to:
  - 1. Two Hundred Dollars (\$200.00) each year for which a volunteer firefighter provides proof of certification as required by subsection B of this section; and
  - 2. Four Hundred Dollars (\$400.00) each year following the taxable years for which a taxpayer is eligible for the credit

provided by paragraph 1 of this subsection for a volunteer firefighter providing proof of certification as required by subsection D of this section.

- In order to claim the tax credit authorized by paragraph 1 В. of subsection A of this section, a volunteer firefighter shall be required to provide adequate documentation to the Oklahoma Tax Commission of at least twelve (12) credited hours toward the State Support or State Basic Firefighter or Firefighter I from an internationally recognized accrediting assembly or board, their equivalent, or other related fire or emergency medical services training approved by the Council on Firefighter Training State Fire Marshal Commission and offered by Oklahoma State University Fire Service Training or Oklahoma Department of Career and Technology Education prior to or during the first taxable year for which a tax credit is claimed pursuant to paragraph 1 of subsection A of this section. For the purpose of this subsection, the local fire chief shall be the authority having jurisdiction and shall choose and approve all volunteer firefighter training in the applicable department.
- C. For each year subsequent to the first year for which a volunteer firefighter may claim the tax credit authorized by paragraph 1 of subsection A of this section, in order to claim any further tax credits pursuant to paragraph 1 of subsection A of this section, the volunteer firefighter shall be required to provide

documentation that the firefighter has completed an additional six (6) hours of State Support or State Basic Firefighter or Firefighter I from an internationally recognized accrediting assembly or board, their equivalent, or other related fire or emergency medical services training approved by the Council on Firefighter Training State Fire Marshal Commission until such program or its equivalent is completed. For purposes of this subsection, equivalency shall be determined by the Oklahoma Council on Firefighter Training State Fire Marshal Commission and Oklahoma State University Fire Service Training. For purposes of this subsection, Firefighter I or Firefighter II certifications or their equivalents may be provided in lieu of the State Support or State Basic Firefighter completion.

D. After having completed the State Support or State Basic Firefighter program, in order to be eligible for the tax credit authorized by paragraph 2 of subsection A of this section, the volunteer firefighter shall:

1. Complete at least six (6) hours of continuing education each year until the volunteer firefighter completes Intermediate or Advanced Firefighter or Firefighter I from an internationally recognized accrediting assembly or board, their equivalent, or other related fire or emergency medical services training approved by the Council on Firefighter Training State Fire Marshal Commission or its equivalent. For purposes of this paragraph, equivalency shall be determined by the Oklahoma Council on Firefighter Training State

Fire Marshal Commission and Oklahoma State University Fire Service Training;

- 2. After completion of Intermediate or Advanced Firefighter or Firefighter I from an internationally recognized accrediting assembly or board, their equivalent, or other related fire or emergency medical services training approved by the Council on Firefighter Training State Fire Marshal Commission, the volunteer firefighter shall complete six (6) hours of training per year to claim the tax credit. For the purpose of this subsection, the local fire chief shall be the authority having jurisdiction and shall choose and approve all volunteer firefighter training in the applicable department;
- 3. Provide documentation from the fire chief of the applicable department that the firefighter has been provided and participated in all annual training as required by federal and state authorities; and
- 4. Provide documentation from the fire chief of the applicable department that the volunteer firefighter has met the requirements under the fire department's constitution and bylaws and is a member in good standing of the department together with a record of the total number of years of service in good standing with such department.
- E. The Office of the State Fire Marshal and the Oklahoma

  Council on Firefighter Training shall prescribe a reporting form for

use by volunteer fire departments and by volunteer firefighters in order to provide the certifications required by this section.

- F. The Oklahoma Tax Commission may require copies of such reporting form provided by the Oklahoma Council on Firefighter

  Training State Fire Marshal Commission regarding training history to verify eligibility for the tax credits provided by this section.

  SECTION 5. AMENDATORY Section 1, Chapter 220, O.S.L.
- Section 3401.2 A. The purpose of Oklahoma State University Fire Service Training (OSU FST) shall be to develop, deliver, support and evaluate training, education and professional certification programs for fire service in this state to ensure emergency responders may safely and successfully perform their duties.

2013 (70 O.S. Supp. 2016, Section 3401.2), is amended to read as

B. OSU FST shall:

follows:

- 1. Deliver and support training and education programs for fire service and other emergency responders in this state to meet local and state needs by:
  - a. collaborating with technology center schools and other training providers to ensure training, training support and support of certification testing is readily available to all areas of the state to accomplish the Oklahoma Council on Firefighter

Training (COFT) State Fire Marshal Commission annual

state training plan and regional training plans which

are voluntarily developed and adopted, and

- b. collaborating with technology center schools and other training providers to develop and maintain a database of available instructors to teach fire and emergency responder topics. The database shall be maintained on the OSU FST website and made available to other training providers;
- 2. Collaborate with COFT the State Fire Marshal Commission on efforts which shall include, but not be limited to, participation in the activities of the COFT the State Fire Marshal Commission training task force and initiatives intended to accomplish COFT the State Fire Marshal Commission firefighter training goals and the state-specific standards certification program;
- 3. Develop or adopt and disseminate curriculum and instructional materials to fire departments and training providers consistent with state and federal statutory requirements for classes, courses and programs for delivery to fire service in this state, with every effort being made to provide the curriculum and materials at minimal or no cost. Unless required by state or federal regulations, selection, adoption and/or use of the OSU-FST-disseminated curriculum and training materials or instructors shall

be at the discretion of each training provider or local fire department;

- 4. Maintain and make available by electronic means, in a manner consistent with state and federal regulations, to the Oklahoma Council on Firefighter Training, fire chiefs, training officers and other agencies as required by law, as requested, all training and certification records of Oklahoma firefighters who participate in training sponsored by OSU FST or records provided to OSU FST by local fire departments or other training agencies. The provisions of this paragraph shall not apply to state and federal wild-land fire agencies;
- 5. Develop, administer and evaluate an accredited certification program available to all firefighters and other emergency responders based on National Fire Protection Association standards and/or state and federal standards. The program shall:
  - a. be accredited through the International Fire Service

    Accreditation Congress and/or the National Board on

    Fire Service Professional Qualifications at levels

    deemed beneficial to fire service in this state,
  - b. provide for dissemination to recognized certification partners and posting to the OSU FST's website a list of qualified proctors and evaluators for use during OSU FST certification events,

- c. develop, as requested, special certifications based on state-specific standards adopted by COFT or other state agencies that are designed for emergency responders in this state, which may not be accredited,
- d. maintain certification records and disseminate certifications of COFT the State Fire Marshal Commission-adopted or approved Oklahoma state-specific certifications. The certifications may be jointly labeled as COFT the State Fire Marshal Commission, OSU FST, the Oklahoma Career and Technology Education System or other COFT State Fire Marshal Commission approved training providers administering statespecific certifications,
- e. ensure that the Oklahoma state-specific certifications shall not duplicate certifications accredited by the International Fire Service Accreditation Congress or the National Board on Fire Service Professional Qualifications, or titles of certification levels listed in the National Fire Protection Association professional qualifications standards, and
- f. when requested by an Oklahoma fire department or state agency, facilitate delivery of International Fire Service Accreditation Congress and National Board on Fire Service Professional Qualifications accredited

certification processes which are not currently available through OSU FST; and

- 6. Fulfill any other statutory requirements set forth by the Legislature.
- C. OSU FST shall be the Oklahoma state government representative to the United States Fire Administration's National Fire Academy and shall be responsible for delivering and disseminating training courses provided by, or made available through, the National Fire Academy.
- D. Beginning September 15, 2014, and continuing on September 15 every following year, OSU FST shall submit an annual report regarding its programs, activity and accomplishments to the Chair of the Board of Regents for the Oklahoma Agricultural and Mechanical Colleges, the President of Oklahoma State University and the Dean of the Oklahoma State University College of Engineering, Architecture and Technology.
- E. Nothing in this section shall be construed to divert funding from one entity to another. Nothing in this section shall be construed to limit, preclude or exempt an organization, agency or local department from delivery of training; development, adoption or dissemination of training curriculum or materials; participation in a COFT certification program based on an Oklahoma state-specific standard adopted or approved by COFT; or issuance of a certificate of completion of training.
