15	SECTION 1. NEW LAW A new section of law to be codified

18	A. Once every four (4) years all rules promulgated by every		
19	agency, board and commission shall sunset.

- C. During the year preceding the sunset of each board's rules, a joint review committee shall be formed by members of both the Oklahoma House of Representatives and the Oklahoma State Senate.
- D. During the year preceding the sunset of each commission's rules, a joint review committee shall be formed by members of both the Oklahoma House of Representatives and the Oklahoma State Senate.
- E. The Speaker of the Oklahoma House of Representatives shall appoint five members of the House to each review committee, and shall designate a chair in odd years and vice-chair in even years.
- F. The President Pro Tempore of the Oklahoma State Senate shall appoint five members of the Senate to each review committee, and shall designate a chair in even years and vice-chair in odd years.
- G. The membership for the review committees does not have to be the same for each agency, board or commission.
- H. Review of each of the rules shall be conducted during the interim with a recommendation being made for the rejection and removal of any rules as needed.
- SECTION 2. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
