COMMITTEE SUBSTITUTE

An Act relating to the Department of Human Services;
making appropriations; stating purposes; directing
certain transfers; establishing procedure; making
appropriations nonfiscal; making appropriations
exempt from certain agency category and budget
limits; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Department of
Human Services from any monies not otherwise appropriated from the
Constitutional Reserve Fund of the State Treasury, the sum of Four
Million Two Hundred Three Thousand Five Hundred Two Dollars
(\$4,203,502.00) or so much thereof as may be necessary for the
Developmental Disabilities Services Division waivers.

1 SECTION 2. There is hereby appropriated to the Department of
2 Human Services from any monies not otherwise appropriated from the
3 Unclaimed Property Fund (711 Fund) of the State Treasury, the sum of
4 Eighteen Million Six Thousand Four Hundred Ninety-eight Dollars
5 (\$18,006,498.00) or so much thereof as may be necessary for the
6 Developmental Disabilities Services Division waivers.

7 SECTION 3. There is hereby appropriated to the Department of
8 Human Services from any monies not otherwise appropriated from the
9 Unclaimed Property Fund (711 Fund) of the State Treasury, the sum of
10 Eleven Million Seven Hundred Ninety Thousand Dollars
11 (\$11,790,000.00) or so much thereof as may be necessary for the
12 Aging Services Division waivers.

13 SECTION 4. The Director of the Office of Management and
14 Enterprise Services shall transfer monies appropriated in this act
15 from the Constitutional Reserve Fund and Unclaimed Property Fund to
16 the Department of Human Services' disbursing funds in the amounts
17 and ratios requested by the agency; provided, that the cumulative
18 amounts transferred shall not exceed the amounts of the
19 appropriations from the Constitutional Reserve Fund and Unclaimed
20 Property Fund.

21 SECTION 5. The appropriations made by this act shall not be
22 subject to fiscal year limitations and shall be available for
23 encumbrance and expenditure purposes for a period of thirty (30)
24 months from the date this act is approved.

1 SECTION 6. The appropriations made by this act shall not be
2 subject to fiscal years 2017 and 2018 agency category and budget
3 limits.

4 SECTION 7. It being immediately necessary for the preservation
5 of the public peace, health or safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
