There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the Unclaimed Property Fund (711 Fund) of the State Treasury, the sum of Eighteen Million Six Thousand Four Hundred Ninety-eight Dollars (\$18,006,498.00) or so much thereof as may be necessary for the Developmental Disabilities Services Division waivers.

SECTION 3. There is hereby appropriated to the Department of Human Services from any monies not otherwise appropriated from the Unclaimed Property Fund (711 Fund) of the State Treasury, the sum of Eleven Million Seven Hundred Ninety Thousand Dollars (\$11,790,000.00) or so much thereof as may be necessary for the Aging Services Division waivers.

SECTION 4. The Director of the Office of Management and Enterprise Services shall transfer monies appropriated in this act from the Constitutional Reserve Fund and Unclaimed Property Fund to the Department of Human Services' disbursing funds in the amounts and ratios requested by the agency; provided, that the cumulative amounts transferred shall not exceed the amounts of the appropriations from the Constitutional Reserve Fund and Unclaimed Property Fund.

SECTION 5. The appropriations made by this act shall not be subject to fiscal year limitations and shall be available for encumbrance and expenditure purposes for a period of thirty (30) months from the date this act is approved.
