15	SECTION 1. AMENDATORY 57 O.S. 2011, Section 503, is		
16	amended to read as follows:		
17	Section 503. A. There is hereby created the State Board of		
18	Corrections which shall be the governing board of the Department of		
19	Corrections herein created.		
20	B. The Board shall consist of $\frac{8}{8}$ mine (9) members $\frac{8}{8}$		
21	shall to be appointed as follows:		
22	1. Seven members shall be appointed by the Governor with the		
23	advice and consent of the Senate. One member shall be appointed		
24	from each congressional district and any remaining members shall be

appointed from the state at large. However, when congressional districts are redrawn, each member appointed prior to July 1 of the year in which such modification becomes effective shall complete the current term of office and appointments made after July 1 of the year in which such modification becomes effective shall be based on the redrawn districts. Appointments made after July 1 of the year in which such modification becomes effective shall be from any redrawn districts which are not represented by a board member until such time as each of the modified congressional districts are represented by a board member. No appointments may be made after July 1 of the year in which such modification becomes effective if such appointment would result in more than two members serving from the same modified district;

- 2. One member shall be appointed by the Speaker of the Oklahoma

 House of Representatives and shall be a duly elected county sheriff

 from a county with a population that exceeds fifty thousand (50,000;

 and
- 3. One member shall be appointed by the President Pro Tempore of the Oklahoma State Senate and shall be a duly elected county sheriff from a county with a population that does not exceed fifty thousand (50,000).
- C. The terms of office of two members shall expire on March 15, 1969, and each six (6) years thereafter; the terms of two members shall expire on March 15, 1971, and each six (6) years thereafter;
