9 An Act relating to transportation; creating the
10 Oklahoma State Safety Oversight Program; designating
11 oversight, implementation and enforcement authority;
12 requiring the development and enforcement of certain
standards; authorizing the application for, reception
and expenditure of certain funds; providing an
effective date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 4019 of Title 69, unless there
18 is created a duplication in numbering, reads as follows:

19 A. There is hereby created the Oklahoma State Safety Oversight
20 Program. Oversight for the program shall be provided by the
21 Oklahoma Department of Transportation. The Department shall develop
22 and enforce the Oklahoma State Safety Oversight Program standards
23 for all private and public rail fixed-guideway public transportation
24 systems statewide that are not administered by the federal Railroad

1 Administration. The Department shall have the complete authority to
2 implement, enforce and oversee the Oklahoma State Safety Oversight
3 Program in accordance with requirements outlined in the 49 CFR,
4 Section 674, as amended.

5 B. The Department is hereby authorized to apply for, receive
6 and expend federal State Safety Oversight Program funds in strict
7 accordance with applicable state and federal law, rules and
8 regulations.

9 SECTION 2. This act shall become effective July 1, 2018.

10 SECTION 3. It being immediately necessary for the preservation
11 of the public peace, health or safety, an emergency is hereby
12 declared to exist, by reason whereof this act shall take effect and
13 be in full force from and after its passage and approval.
