last amended by Sections 23 and 25, Chapter 210,
O.S.L. 2016 (47 O.S. Supp. 2016, Sections 1135.3 and
1135.5), which relate to special license plates;
correcting certain references; reclassifying Ducks
Unlimited and Jenks Trojans License Plate as a
financial assistance plate; modifying Historic Route
66 License Plate to authorize motorcycle plate;
providing for design of, and authorizing certain
licensing agreements related to, such plates;
authorizing and limiting certain payments; creating
Jenks Trojans License Plate; providing for design of,
and authorizing certain licensing agreements related
to, such plates; authorizing and limiting certain
payments; creating the Bixby Spartans License Plate;
providing for design of, and authorizing certain
licensing agreements related to, such plates;
authorizing and limiting certain payments; creating
the Oklahoma Aeronautics Commission License Plate;
providing for design of license plates; requiring
certain portion of fees be deposited in certain
fund; creating Ducks Unlimited License Plate;
providing for design of, and authorizing certain
licensing agreements related to, such plates;
authorizing and limiting certain payments; creating
Prisoner of War and Missing in Action License Plate;

1 providing for design of plate; requiring certain
2 portion of funds be deposited in specified fund;
3 amending 3 O.S. 2011, Section 91, as amended by

6 Aeronautics Commission Revolving Fund; authorizing
7 deposit of certain fees from license plates;
8 authorizing expenditure of funds for certain purpose;
9 creating the Prisoner of War and Missing in Action
10 License Plate Revolving Fund; placing fund with the
11 Oklahoma Department of Veterans Affairs; providing
12 for budget and expenditure procedures related to such
13 fund; providing for codification; and providing an
14 effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.3, as
last amended by Section 23, Chapter 210, O.S.L. 2016 (47 O.S. Supp.
2016, Section 1135.3), is amended to read as follows:

Section 1135.3. A. The Oklahoma Tax Commission is hereby
authorized to design and issue appropriate official special license
plates to persons wishing to demonstrate support, interest, or
membership to or for an organization, occupation, cause or other
subject as provided by this section.

Special license plates shall not be transferred to any other
person but shall be removed from the vehicle upon transfer of
ownership and retained. The special license plate may then be used
on another vehicle but only after such other vehicle has been
registered for the current year.

1 Special license plates shall be renewed each year by the Tax
2 Commission or a motor license agent. The Tax Commission shall
3 annually notify by mail all persons issued special license plates.
4 The notice shall contain all necessary information and shall contain
5 instructions for the renewal procedure upon presentation to a motor
6 license agent or the Tax Commission. The license plates shall be
7 issued on a staggered system.

8 The Tax Commission is hereby directed to develop and implement a
9 system whereby motor license agents are permitted to accept
10 applications for special license plates authorized under this
11 section. The motor license agent shall confirm the applicant's
12 eligibility, if applicable, collect and deposit any amount
13 specifically authorized by law, accept and process the necessary
14 information directly into such system and generate a receipt
15 accordingly. For performance of these duties, motor license agents
16 shall retain the fee provided in Section 1141.1 of this title for
17 registration of a motor vehicle. The motor license agent fees for
18 acceptance of applications and renewals shall be paid out of the
19 Oklahoma Tax Commission Reimbursement Fund.

20 If fewer than one hundred of any type of special license plates
21 authorized prior to January 1, 2004, are issued prior to January 1,
22 2006, the Tax Commission shall discontinue issuance and renewal of
23 that type of special license plate. Any such authorized special
24 license plate registrant shall be allowed to display the license

1 plate upon the designated vehicle until the registration expiration
2 date. After such time the expired special license plate shall be
3 removed from the vehicle.

4 Except as otherwise provided in this section, for special
5 license plates authorized on or after July 1, 2004, no special
6 license plates shall be developed or issued by the Tax Commission
7 until the Commission receives one hundred (100) prepaid applications
8 therefor. The prepaid applications must be received by the Tax
9 Commission within one hundred eighty (180) days of the effective
10 date of the authorization or the authority to issue shall be null
11 and void. In the event one hundred (100) prepaid applications are
12 not received by the Tax Commission within such prescribed time
13 period any payment so received shall be refunded accordingly.

14 B. The special license plates provided by this section are as
15 follows:

16 1. Round and Square Dance License ~~Plates~~ Plate - such plates
17 shall be designed and issued to any person wishing to demonstrate
18 support for round and square dancing;

19 2. National Association for the Advancement of Colored People
20 License ~~Plates~~ Plate - such plates shall be designed, subject to the
21 criteria to be presented to the Tax Commission by the NAACP, and
22 issued to any person wishing to demonstrate support for the NAACP;

23 3. National Rifle Association License ~~Plates~~ Plate - such
24 plates shall be designed, subject to the criteria to be presented to

1 the Tax Commission by the National Rifle Association, and issued to
2 any person wishing to demonstrate support for the National Rifle
3 Association;

4 4. Masonic Fraternity License ~~Plates~~ Plate - such plates shall
5 be designed and issued to any resident of this state who is a member
6 of a Masonic Fraternity of Oklahoma. Such persons may apply for a
7 Masonic Fraternity license plate for each vehicle with a rated
8 carrying capacity of one (1) ton or less upon proof of a Masonic
9 Fraternity membership or upon the presentment of an application for
10 a Masonic Fraternity license plate authorized and approved by the
11 Grand Lodge of Oklahoma. The license plates shall be designed in
12 consultation with the Masonic Fraternities of Oklahoma and shall
13 contain the Masonic emblem;

14 5. Shriner's Hospitals for Burned and Crippled Children License
15 ~~Plates~~ Plate - such plates shall be designed to demonstrate support
16 for Shriner's Hospitals for Burned and Crippled Children and shall
17 be issued to any resident of this state who is a member of a
18 Shriner's Temple in Oklahoma. The license plate shall be designed
19 in consultation with the Shriner's Temples in Oklahoma and shall
20 contain the Shriner's emblem;

21 6. Balloonists License Plate - such plates shall be designed
22 and issued to any person wishing to demonstrate support for hot air
23 ballooning in this state;

1 7. Order of the Eastern Star License ~~Plates~~ Plate - such plates
2 shall be designed and issued to any resident of this state who is a
3 member of an Order of the Eastern Star. Such persons may apply for
4 an Order of the Eastern Star license plate for each vehicle with a
5 rated carrying capacity of one (1) ton or less upon proof of an
6 Order of the Eastern Star membership or upon the presentment of an
7 application for an Order of the Eastern Star license plate
8 authorized and approved by the organization. The license plate
9 shall be designed in consultation with the Order of the Eastern Star
10 and shall contain the Order of the Eastern Star emblem;

11 8. Knights of Columbus License ~~Plates~~ Plate - such plates shall
12 be designed and issued to any resident of this state who is a member
13 of the Knights of Columbus. Such persons may apply for a Knights of
14 Columbus license plate for each vehicle with a rated carrying
15 capacity of one (1) ton or less upon proof of a Knights of Columbus
16 membership or upon the presentment of an application for a Knights
17 of Columbus license plate authorized and approved by the
18 organization. The license plate shall be designed in consultation
19 with the Knights of Columbus and shall contain the Knights of
20 Columbus emblem;

21 9. Jaycees License ~~Plates~~ Plate - such plates shall be designed
22 and issued to members of the Jaycees. Persons applying for such
23 license plate must show proof of membership in the Jaycees. The
24 license plates shall be designed in consultation with the Jaycees;

1 10. ~~Ducks Unlimited License Plates~~ such plates shall be
2 ~~designed and issued to persons wishing to demonstrate support for~~
3 ~~Ducks Unlimited. The license plates shall be designed in~~
4 ~~consultation with Ducks Unlimited;~~

5 ~~11.~~ Kiwanis International License ~~Plates~~ Plate - such plates
6 shall be designed and issued to members of Kiwanis International.
7 Persons applying for such license plate must show proof of
8 membership in Kiwanis International. The license plates shall be
9 designed in consultation with Kiwanis International;

10 ~~12.~~ 11. Certified Public Accountants License ~~Plates~~ Plate -
11 such plates shall be designed and issued to any resident of this
12 state who is a Certified Public Accountant. Such persons may apply
13 for a Certified Public Accountant license plate for each vehicle
14 with a rated carrying capacity of one (1) ton or less upon proof of
15 status as a Certified Public Accountant. The license plates shall
16 be designed in consultation with the Oklahoma Society of Certified
17 Public Accountants;

18 ~~13.~~ 12. Civil Emergency Management License ~~Plates~~ Plate - such
19 plates shall be designed and issued to persons wishing to
20 demonstrate support for the state civil emergency management system.
21 Persons applying for such license plate must show proof of official
22 affiliation by presenting a nonexpired proof of employment,
23 affiliation or retirement in the form of an identification card or
24

1 letter on official letterhead from a municipal, county or state
2 emergency management department head;

3 ~~14.~~ 13. Civilian Conservation Corps License ~~Plates~~ Plate - such
4 plates shall be designed, subject to criteria to be presented to the
5 Tax Commission, by the Civilian Conservation Corps Association, and
6 issued to any person wishing to demonstrate support of the Civilian
7 Conservation Corps;

8 ~~15.~~ 14. Rotarian License ~~Plates~~ Plate - such plates shall be
9 designed and issued to any resident of this state who is a member of
10 a Rotarian Club of Oklahoma. Such persons may apply for a Rotarian
11 license plate for each vehicle with a rated carrying capacity of one
12 (1) ton or less upon proof of a Rotarian Club membership or upon the
13 presentment of an application for a Rotarian license plate
14 authorized and approved by a Rotarian Club of Oklahoma. The license
15 plates shall be designed in consultation with the five Rotarian
16 District Governors and shall contain the Rotarian emblem;

17 ~~16.~~ 15. Benevolent Protective Order of Elks License Plate -
18 such plates shall be designed, subject to criteria to be presented
19 to the Tax Commission, by the Benevolent Protective Order of Elks,
20 and issued to any resident of this state who is a member of the
21 Benevolent Protective Order of Elks;

22 ~~17.~~ 16. Humane Society License ~~Plates~~ Plate - such plates shall
23 be designed and issued to any person wishing to demonstrate support
24 for the Humane Society of the United States. The plates shall be

1 issued to any person in any combination of numbers and letters from
2 one to a maximum of seven, as for personalized license plates. The
3 plate shall contain the official Humane Society logo;

4 ~~18.~~ 17. Oklahoma Mustang Club License Plate - such plates shall
5 be designed, subject to criteria to be presented to the Tax
6 Commission, by the Oklahoma Mustang Club, and issued to any resident
7 of this state who is a member of the Oklahoma Mustang Club. Such
8 persons may apply for an Oklahoma Mustang Club license plate upon
9 presentment of proof of membership in the Oklahoma Mustang Club.
10 The plates shall be issued to any person in any combination of
11 numbers and letters from one to a maximum of seven, as for
12 personalized license plates;

14 such plates shall be designed and issued to members of American
15 Business Clubs. Persons applying for such license plate must show
16 proof of membership in AMBUCS. The license plates shall be designed

19 such plates shall be designed and issued to any person wishing to

3 annually notify by mail all persons issued special license plates.
4 The notice shall contain all necessary information and shall contain
5 instructions for the renewal procedure upon presentation to a motor
6 license agent or the Tax Commission. The license plates shall be
7 issued on a staggered system.

8 The Tax Commission is hereby directed to develop and implement a
9 system whereby motor license agents are permitted to accept
10 applications for special license plates authorized under this
11 section. The motor license agent shall confirm the applicant's
12 eligibility, if applicable, collect and deposit any amount
13 specifically authorized by law, accept and process the necessary
14 information directly into such system and generate a receipt
15 accordingly. For performance of these duties, motor license agents
16 shall retain the fee provided in Section 1141.1 of this title for
17 registration of a motor vehicle. The motor license agent fees for
18 acceptance of applications and renewals shall be paid out of the
19 Oklahoma Tax Commission Reimbursement Fund.

20 If fewer than one hundred of any type of special license plates
21 authorized prior to January 1, 2004, are issued prior to January 1,
22 2006, the Tax Commission shall discontinue issuance and renewal of
23 that type of special license plate. Any such authorized special
24 license plate registrant shall be allowed to display the license

1 plate upon the designated vehicle until the registration expiration
2 date. After such time the expired special license plate shall be
3 removed from the vehicle.

4 For special license plates authorized on or after July 1, 2004,
5 no special license plates shall be developed or issued by the Tax
6 Commission until the Commission receives one hundred prepaid
7 applications therefor. The prepaid applications must be received by
8 the Tax Commission within one hundred eighty (180) days of the

10 be null and void. In the event one hundred prepaid applications are

18 identification card or letter from the chief of the fire department.
19 Retirees who are eligible for such plates shall provide proof of
20 eligibility upon initial application, but shall not be required to
21 provide proof of eligibility annually. The surviving spouse of any
22 deceased firefighter, if the spouse has not since remarried, may
23 apply for a firefighter license plate for one vehicle with a rated
24 carrying capacity of one (1) ton or less or for a motorcycle upon

1 proof that the deceased firefighter was a member of a fire
2 department by either an identification card or letter from the chief
3 of the fire department. The license plate shall be designed in
4 consultation with the Oklahoma Firefighters Association.

5 As provided in this section, an amount of the fee collected
6 shall be deposited to the Oklahoma State Firemen's Museum Building &
7 Memorial Fund for support of the Oklahoma Firefighters Museum and
8 the Oklahoma ~~Firefighter~~ Fallen and Living Firefighters Memorial;

9 4. Wildlife Conservation License ~~Plates~~ Plate - such plates
10 shall be designed, subject to the criteria to be presented to the
11 Tax Commission by the Oklahoma Department of Wildlife Conservation
12 in consultation with the Oklahoma Arts Council, and issued to any
13 person wishing to demonstrate support for wildlife conservation in
14 this state through the Wildlife Diversity Fund, provided for in
15 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
16 be designed and issued to any person as for personalized license
17 plates.

18 As provided in this section, an amount of the fee collected
19 shall be apportioned pursuant to subsection D of Section 3-310 of
20 Title 29 of the Oklahoma Statutes;

21 5. Child Abuse Prevention License ~~Plates~~ Plate - such plates
22 shall be designed, subject to the criteria to be presented to the
23 Tax Commission by the Office of Child Abuse Prevention in the State
24 Department of Health and the Oklahoma Committee to Prevent Child

1 Abuse, and issued to any person wishing to demonstrate support for
2 the prevention of child abuse.

3 As provided in this section, an amount of the fee collected
4 shall be deposited in the Child Abuse Prevention Fund;

5 6. United States Olympic Committee Supporter License ~~Plates~~
6 Plate - such plates shall be designed and issued to any person
7 wishing to demonstrate support for the United States Olympic
8 Committee. The plates shall be issued to any person in any
9 combination of numbers and letters from one to a maximum of seven,

11 official United States Olympic Committee logo. The Tax Commission
12 shall be authorized, if necessary, to enter into a licensing
13 agreement with the United States Olympic Committee for any licensing
14 fees which may be required in order to use the United States Olympic
15 Committee logo or design. The licensing agreement shall provide for
16 a payment of not more than Twenty-five Dollars (\$25.00) for each
17 license plate issued;

14 be designed, subject to criteria to be presented to the Tax
15 Commission by the State Department of Education in consultation with
16 the Oklahoma Arts Council, and issued to any person wishing to

18 agents shall display a sample of the Support Education License plate
19 in the area of the business accessed by the public. Twenty-three

11 be issued to any person in any combination of numbers and letters
12 from one to a maximum of seven, as for personalized license plates.
13 The plate shall contain the official Boy Scouts of America logo.
14 The Tax Commission shall be authorized, if necessary, to enter into
15 a licensing agreement with the Boy Scouts of America for any
16 licensing fees which may be required in order to use the Boy Scouts
17 of America logo or design. The licensing agreement shall provide
18 for a payment to the Boy Scouts of America of not more than Twenty
19 Dollars (\$20.00) for each license plate issued;

20 20. Urban Forestry and Beautification License ~~Plates~~ Plate -
21 such plates shall be designed, subject to criteria to be presented
22 to the Tax Commission, by the Oklahoma Department of Agriculture,
23 Food, and Forestry in consultation with nonprofit organizations in
24 this state that develop and operate programs to encourage urban

1 forestry and beautification, and issued to any person wishing to
2 demonstrate support of such programs. As provided in this section,
3 an amount of the fee collected shall be apportioned as provided in

Twenty Dollars (\$20.00) of the fee collected shall be designated by the purchaser of the plate to be deposited in the Oklahoma Pet Overpopulation Fund created in Section 2368.13 of Title 68 of the Oklahoma Statutes or the Animal Friendly Revolving Fund created in Section 1104.10 of this title;

32. Patriot License Plate - such plates shall be designed in consultation with the Military Department of Oklahoma and issued to any person wishing to demonstrate support for Oklahoma residents who are members of the Oklahoma National Guard and deployed on active duty. The plates shall be issued to any person in any combination of numbers and letters from one to a maximum of seven, as for personalized license plates. As provided in this section, a portion of the fee collected shall be deposited in the Patriot License Plate Revolving Fund created in Section 1104.11 of this title;

1 33. Global War on Terrorism License Plate - such plate shall be
2 designed in consultation with the Military Department of Oklahoma
3 and issued to any person wishing to demonstrate support for Oklahoma

19 design. The licensing agreement shall provide for a payment to
20 Support Our Troops Incorporated of Twenty-five Dollars (\$25.00) for
21 each license plate issued;

22 40. Folds of Honor Supporter License Plate - such plates shall
23 be designed and issued to any person wishing to demonstrate support
24 for Folds of Honor Incorporated, a nonprofit charitable organization

1 exempt from taxation pursuant to the provisions of the Internal

16 15.4 of Title 73 of the Oklahoma Statutes and the State Capitol
17 Preservation Commission created pursuant to Section 4102 of Title 74
18 of the Oklahoma Statutes. As provided in this section, an amount of
19 the fee collected shall be deposited in the Oklahoma Friends of the
20 Capitol License Plate Revolving Fund established in Section 1104.18
21 of this title;

22 46. Eastern Red Cedar Tree License ~~Plates~~ Plate - such plates
23 shall be designed, subject to criteria to be presented to the Tax
24 Commission and issued to any person wishing to demonstrate support

1 for the removal of Eastern Red Cedar trees from lands in the state
2 and to develop marketable uses for the harvested trees. The license
3 plate shall be designed in consultation with the Eastern Red Cedar

12 shall be issued to any person wishing to provide financial support
13 for the Oklahoma Chapters of the Juvenile Diabetes Research
14 Foundation. The license plates shall be designed in consultation

16 Foundation. As provided in this section, an amount of the fee
17 collected shall be deposited in the Juvenile Diabetes Research
18 License Plate Revolving Fund created in Section 1104.22 of this
19 title;

20 51. Deer Creek Schools Foundation License Plate - such plates
21 shall be issued to any person wishing to provide financial support
22 for the Deer Creek Schools Foundation. The license plates shall be
23 designed in consultation with the Deer Creek Schools Foundation.
24 The plates shall be issued to any person in any combination of

1 numbers and letters from one to a maximum of seven, as for
2 personalized license plates. As provided in this section, an amount

54. Crossings Christian School License Plate - such plates shall be designed and issued to any person wishing to demonstrate support for Crossings Christian School located in Oklahoma City. The license plates shall be designed in consultation with the administration of Crossings Christian School. The Tax Commission shall be authorized to enter into a licensing agreement with Crossings Christian School for any licensing fees which may be required in order to use the school's logo or design. The licensing agreement shall provide for a payment to the Crossings Christian School of not more than Twenty Dollars (\$20.00) for each license plate issued;

55. Hilldale Education Foundation License ~~Plates~~ Plate - such plates shall be designed and issued to any person wishing to demonstrate support for the Hilldale Education Foundation. The license plates shall be designed in consultation with the administration of the Hilldale Education Foundation. The Tax Commission shall be authorized to enter into a licensing agreement

1 with the Hilldale Education Foundation for any licensing fees which
2 may be required in order to use the foundation's logo or design.
3 The licensing agreement shall provide for a payment to the Hilldale
4 Education Foundation of not more than Twenty Dollars (\$20.00) for
5 each license plate issued;

6 56. Oklahoma Nurses License Plate - such plates shall be issued
7 to any person licensed pursuant to the Oklahoma Nursing Practice Act
8 and providing such documentation of current licensure as may be
9 required by the Oklahoma Tax Commission. The license plates shall
10 be designed in consultation with the Oklahoma Nurses Association.
11 As provided in this section, an amount of the fee collected shall be
12 deposited in the Oklahoma Nurses License Plate Revolving Fund
13 created in Section 1104.26 of this title;

14 57. Oklahoma Sports Hall of Fame License Plate - such plates
15 shall be issued to any person wishing to demonstrate support for the
16 Oklahoma Sports Hall of Fame. The license plates shall be designed
17 in consultation with the administration of the Oklahoma Sports Hall
18 of Fame. The Oklahoma Tax Commission shall be authorized to enter
19 into a licensing agreement with the Oklahoma Sports Hall of Fame for
20 any licensing fees which may be required in order to use the Hall of
21 Fame's logo or design. The licensing agreement shall provide for a
22 payment to the Oklahoma Sports Hall of Fame of not more than Twenty
23 Dollars (\$20.00) for each license plate issued;

1 58. Childhood Cancer Awareness License Plate - such plates
2 shall be issued to any person wishing to demonstrate support for the
3 Oklahoma Children's Cancer Association. The license plates shall be
4 designed in consultation with the administration of the Oklahoma
5 Children's Cancer Association. The Oklahoma Tax Commission shall be
6 authorized to enter into a licensing agreement with the Oklahoma
7 Children's Cancer Association for any licensing fees which may be
8 required in order to use the Oklahoma Children's Cancer
9 Association's logo or design. The licensing agreement shall provide
10 for a payment to the Oklahoma Children's Cancer Association of not
11 more than Twenty Dollars (\$20.00) for each license plate issued;

12 59. Oklahoma Educational Television Authority License Plate -
13 such plates shall be designed and issued to any person wishing to
14 demonstrate support for the Oklahoma Educational Television
15 Authority and such plates shall be designed in consultation with the
16 Authority. As provided in this section, an amount of the fee
17 collected shall be deposited in the Educational Television Authority
18 Revolving Fund created in Section 156 of Title 62 of the Oklahoma
19 Statutes; ~~and~~

20 60. Remembering Fallen Heroes License Plate - such plates shall
21 be designed and issued to any person wishing to demonstrate support
22 for Concerns of Police Survivors, Inc. Such plates shall be
23 designed in consultation with the Oklahoma chapter of Concerns of
24 Police Survivors, Inc. As provided in this section, an amount of

1 the fee collected shall be deposited in the Oklahoma Concerns of
2 Police Survivors License Plate Revolving Fund created in Section
3 1104.27 of this title;

4 61. Jenks Trojans License Plate - such plates shall be designed
5 and issued to any person wishing to demonstrate support for the
6 Jenks School District. The license plates shall be designed in
7 consultation with the administration of the Jenks School District.
8 The Tax Commission shall be authorized to enter into a licensing
9 agreement with the Jenks School District for any licensing fees
10 which may be required in order to use the school district's logo or
11 design. The licensing agreement shall provide for a payment to the
12 Jenks School District of not more than Twenty Dollars (\$20.00) for
13 each license plate issued;

14 62. Bixby Spartans License Plate - such plates shall be
15 designed and issued to any person wishing to demonstrate support for
16 the Bixby School District. The license plates shall be designed in
17 consultation with the administration of the Bixby School District.
18 The Tax Commission shall be authorized to enter into a licensing
19 agreement with the Bixby School District for any licensing fees
20 which may be required in order to use the school district's logo or
21 design. The licensing agreement shall provide for a payment to the
22 Bixby School District of not more than Twenty Dollars (\$20.00) for
23 each license plate issued;

1 63. Oklahoma Aeronautics Commission License Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 support for the Oklahoma aviation industry and to promote awareness
4 of aviation and aerospace. Such plates shall be designed in
5 consultation with the Oklahoma Aeronautics Commission and shall be
6 issued to any person in any combination of numbers and letters from
7 one to a maximum of seven, as for personalized plates. Twenty-four
8 Dollars (\$24.00) of the fee collected shall be deposited in the
9 Oklahoma Aeronautics Commission Revolving Fund, for expenditure as
10 provided in Section 91 of Title 3 of the Oklahoma Statutes;

11 64. Ducks Unlimited License Plate - such plates shall be
12 designed and issued to any person wishing to demonstrate support for
13 Ducks Unlimited. Such plates shall be designed in consultation with
14 Ducks Unlimited. The Oklahoma Tax Commission shall be authorized to
15 enter into a licensing agreement with Ducks Unlimited for any
16 licensing fee which may be required in order to use the Ducks
17 Unlimited logo or design. The licensing agreement shall provide for
18 a payment to Ducks Unlimited of not more than Twenty Dollars
19 (\$20.00) for each license plate issued; and

20 65. Prisoner of War and Missing in Action License Plate - such
21 plates shall be issued to any person wishing to increase awareness
22 of those who are currently prisoners of war or missing in action and
23 provide financial support for current veterans. The license plates
24 shall be designed in consultation with Rolling Thunder Oklahoma. As

1 provided in this section, an amount of the fee collected shall be
2 deposited in the Prisoner of War and Missing in Action License Plate
3 Revolving Fund created in Section 4 of this act.

4 C. The fee for such plates shall be Thirty-five Dollars
5 (\$35.00) and shall be in addition to all other registration fees
6 provided by the Oklahoma Vehicle License and Registration Act. The
7 fee shall be apportioned as follows:

8 1. Twenty Dollars (\$20.00) or any other amount as provided in
9 this title of the fee shall be apportioned as provided or deposited
10 in a fund as specified within the paragraph authorizing the special
11 license plate;

12 2. Eight Dollars (\$8.00) of the fee shall be deposited in the
13 Oklahoma Tax Commission Reimbursement Fund to be used for the
14 administration of the Oklahoma Vehicle License and Registration Act;
15 and

16 3. Any remaining amounts of the fee shall be apportioned as
17 provided in Section 1104 of this title.

18 SECTION 3. AMENDATORY 3 O.S. 2011, Section 91, as
19 amended by Section 21, Chapter 304, O.S.L. 2012 (3 O.S. Supp. 2016,
20 Section 91), is amended to read as follows:

21 Section 91. There is hereby created in the State Treasury a
22 revolving fund for the Oklahoma Aeronautics Commission to be
23 designated as the Oklahoma Aeronautics Commission Revolving Fund.
24 The fund shall be a continuing fund, not subject to fiscal year

1 limitations, and shall consist of a monthly allocation by the
2 Oklahoma Tax Commission of Three Thousand Dollars (\$3,000.00) from
3 the motor fuel excise tax levied and collected pursuant to the
4 provisions of Title 68 of the Oklahoma Statutes, such amount being a
5 part of the estimated amount of tax paid on gasoline consumed by
6 engines to propel aircraft in Oklahoma, sale of surplus property,
7 fees and receipts collected pursuant to the Oklahoma Open Records
8 Act, donations, gifts, bequests, contribution, devices, interagency
9 reimbursements, federal funds unless otherwise provided by federal
10 law or regulation, sale of leases and aircraft registration fees and
11 taxes, fees authorized by Section 1135.5 of Title 47 of the Oklahoma
12 Statutes or any other source. All monies accruing to ~~said~~ the fund
13 are hereby appropriated and may be budgeted and expended by the
14 Oklahoma Aeronautics Commission for airport construction and
15 rehabilitation programs ~~and,~~ general operations of the agency, for
16 promoting the awareness of aviation and aerospace, and providing
17 financial support for aviation education programs to address the
18 need for a skilled and competent aviation workforce. Expenditures
19 from ~~said~~ the fund shall be made upon warrants issued by the State
20 Treasurer against claims filed as prescribed by law with the
21 Director of the Office of Management and Enterprise Services for
22 approval and payment.

SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1104.28 of Title 47, unless there is created a duplication in numbering, reads as follows:

A. Twenty Dollars (\$20.00) of the fee authorized by Section 1135.5 of Title 47 of the Oklahoma Statutes for the Prisoner of War and Missing in Action License Plate shall be deposited in the Prisoner of War and Missing in Action License Plate Revolving Fund created in subsection B of this section.

B. There is hereby created in the State Treasury a revolving fund for the Oklahoma Department of Veterans Affairs to be designated the "Prisoner of War and Missing in Action License Plate Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of all monies received by the Department pursuant to the provisions of subsection A of this section. All monies accruing to the credit of the fund are hereby appropriated and may be budgeted and expended by the Department for any purpose related to Oklahoma residents who are American veterans. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.

SECTION 5. This act shall become effective November 1, 2017.
