16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. AMENDATORY Section 2, Chapter 248, O.S.L.
18	2015, as amended by Section 1, Chapter 186, O.S.L. 2016 (47 O.S.
19	Supp. 2017, Section 11-901d), is amended to read as follows:
20	Section 11-901d. A. It shall be unlawful for any person to
21	operate a motor vehicle on any street or highway within this state
22	while using a hand-held electronic communication device to manually
23	compose, send or read an electronic text message while the motor
24	vehicle is in motion.

- B. Any person who violates the provisions of subsection A of this section shall, upon conviction, be punished by a fine of not more than One Hundred Dollars (\$100.00).
- C. The Department of Public Safety shall not record or assess points for violations of this section on any license holder's traffic record maintained by the Department.
- D. The provisions of subsection A of this section shall not apply if the person is using a hands-free accessory which allows the person to communicate without the use of his or her hands.
- E. The provisions of subsection A of this section shall not apply if the person is using the cellular telephone or electronic communication device for the sole purpose of communicating with any of the following regarding an imminent emergency situation:
 - 1. An emergency response operator;
 - 2. A hospital, physician's office or health clinic;
 - 3. A provider of ambulance services;
 - 4. A provider of firefighting services; or
 - 5. A law enforcement agency.

E. F. Municipalities may enact and municipal police officers may enforce ordinances prohibiting and penalizing conduct under the provisions of this section. The provisions of such ordinances shall be the same as provided for in this section; the enforcement provisions of those ordinances shall not be more stringent than those of this section; and the fine and court costs for municipal

ordinance violations shall be the same or a lesser amount as provided for in this section.

Fr. G. For the purpose of this section:

1. "Cellular telephone" means an analog or digital wireless

1. "Cellular telephone" means an analog or digital wireless
telephone authorized by the Federal Communications Commission to
operate in the frequency bandwidth reserved for cellular telephones;

2. "Compose", "send" or "read" with respect to a text message means the manual entry, sending or retrieval of a text message to communicate with any person or device;

3. "Electronic communication device" means an electronic device that permits the user to manually transmit a communication of written text by means other than through an oral transfer or wire communication, or any analog or digital wireless telephone authorized by the Federal Communications Commission to operate in the frequency bandwidth reserved for cellular telephones. This term does not include:
