10 A Joint Resolution directing the Secretary of State
11 to refer to the people for their approval or
12 rejection a proposed amendment to Section 33 of
13 Article V of the Oklahoma Constitution; modifying
14 requirement for approval of certain measures;
15 establishing new requirement for approval of certain
16 measures; providing ballot title; and directing
17 filing.

18 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
19 2ND SESSION OF THE 56TH OKLAHOMA LEGISLATURE:

20 SECTION 1. The Secretary of State shall refer to the people for
21 their approval or rejection, as and in the manner provided by law,
22 the following proposed amendment to Section 33 of Article V of the
23 Oklahoma Constitution to read as follows:

24 Section 33. A. All bills for raising revenue shall originate
in the House of Representatives. The Senate may propose amendments
to revenue bills.

1 B. No revenue bill shall be passed during the five last days of
2 the session.

3 C. Any revenue bill originating in the House of Representatives
4 shall not become effective until it has been referred to the people
5 of the state at the next general election held throughout the state
6 and shall become effective and be in force when it has been approved
7 by a majority of the votes cast on the measure at such election and
8 not otherwise, except as otherwise provided in subsection D of this
9 section.

10 D. Any revenue bill originating in the House of Representatives
11 may become law without being submitted to a vote of the people of
12 the state if such bill receives the approval of ~~three-fourths (3/4)~~
13 sixty percent (60%) of the membership of the House of
14 Representatives and ~~three-fourths (3/4)~~ sixty percent (60%) of the
15 membership of the Senate and is submitted to the Governor for
16 appropriate action. Any such revenue bill shall not be subject to
17 the emergency measure provision authorized in Section 58 of this
18 Article and shall not become effective and be in force until ninety
19 days after it has been approved by the Legislature, and acted on by
20 the Governor.

21 SECTION 2. The Ballot Title for the proposed Constitutional
22 amendment as set forth in SECTION 1 of this resolution shall be in
23 the following form:

2 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

3 This measure amends Section 33 of Article 5 of the Oklahoma
4 Constitution. The section sets out certain requirements for
5 bills for raising revenue for the support of state government.
6 Under current law, a revenue bill must be approved by three-
7 fourths (3/4) of the membership of the House and the Senate.
8 This would change the amount to sixty percent (60%).
