All Judges of the Court of Criminal Appeals may seek retention in office pursuant to the provisions of Section 2 of Article VII-B of the Oklahoma Constitution and each Judge shall be voted for by the qualified voters of the state at-large.
 - B. Beginning January 8, 2019, the boundaries of the Court of Criminal Appeals Judicial Districts shall be the boundaries of the five Oklahoma Congressional Districts as constituted on January 8, 2019, as follows:

- 1. The Court of Criminal Appeals Judicial District No. 1 shall embrace and include the following counties: Craig, Delaware, Mayes, Nowata, Ottawa, Rogers, Tulsa, and Wagoner. Congressional District
 No. 1;
- 2. The Court of Criminal Appeals Judicial District No. 2 shall embrace and include the following counties: Adair, Cherokee, Cleveland, Creek, Kay, Lincoln, Logan, Muskogee, Noble, Okfuskee, Okmulgee, Osage, Pawnee, Payne, Pottawatomie, and Washington.
