- B. The Committee shall be composed of nineteen (19) members as follows:
 - 1. The Superintendent of Public Instruction or designee;
- 6 2. The Chancellor of the Oklahoma State Regents for Higher 7 Education or designee;
- 8 3. The Secretary of Education and Workforce Development or 9 designee;
- 4. The Executive Director of the Office of Educational Quality and Accountability or designee;
- 5. A student with dyslexia, appointed by the Speaker of the Oklahoma House of Representatives;
- 6. A parent of a student with dyslexia, appointed by the President Pro Tempore of the Oklahoma State Senate;
 - 7. A classroom teacher, appointed by the Governor;
- 8. A special education teacher, appointed by the Speaker of the Oklahoma House of Representatives;
- 9. A school principal, appointed by the President Pro Tempore of the Oklahoma State Senate;
- 21 10. A school counselor, appointed by the Governor;
- 22 11. A school district director of special services, appointed 23 by the Speaker of the Oklahoma House of Representatives;

12. A school superintendent, appointed by the President Pro
Tempore of the Oklahoma State Senate;

- 13. A school psychologist, appointed by the Governor;
- 14. A member who is part of an organization that advocates on behalf of students with dyslexia, appointed by the Speaker of the Oklahoma House of Representatives;
- 15. A member who is an Academic Language Therapy Association certified Academic Language Therapist Qualified Instructor who is also a dyslexia therapist certified by the International Dyslexia Association, appointed by the President Pro Tempore of the Oklahoma State Senate;
- 16. A member who is an attorney who represents families and students that have been affected by dyslexia, appointed by the Governor;
- 17. A member who is part of a not-for-profit organization that encourages cooperation between educators, taxpayers and elected officials, appointed by the Speaker of the Oklahoma House of Representatives;
- 18. A member of the Oklahoma House of Representatives, appointed by the Speaker of the Oklahoma House of Representatives; and
- 19. A member of the Oklahoma State Senate, appointed by the
 President Pro Tempore of the Oklahoma State Senate.

- C. Appointments to the Task Force shall be made by September 1, 2017. Members of the Task Force shall serve at the pleasure of the appointing authority. A vacancy on the Task Force shall be filled by the appointing authority.
 - D. The Task Force shall conduct an organizational meeting not later than October 1, 2017. The Task Force shall elect a chair and vice-chair at the organizational meeting. A majority of the members present at a meeting shall constitute a quorum to conduct business.
 - E. The Task Force shall be authorized to meet at such times as may be required in order to fulfill the duties imposed upon the Task Force by law. Members of the Task Force shall not be reimbursed for travel expenses.
 - F. The Task Force shall:

- 14 1. Study how to effectively identify students who have dyslexia;
 - 2. Make recommendations for appropriate interventions for students with dyslexia; and
 - 3. Make this information available in a handbook for schools, teachers and families to use as a resource.
 - G. The Task Force shall be subject to the Oklahoma Open Meeting
 Act and the Oklahoma Open Records Act.
- H. Staff assistance for the Task Force shall be provided by the
 Oklahoma House of Representatives and the Oklahoma State Senate.
