9 COMMITTEE SUBSTITUTE

10 An Act relating to game and fish; amending 29 O.S.  
11 2011, Section 4-130, which relates to waterfowl  
12 hunting stamps; providing waterfowl license fee;  
13 specifying the Oklahoma Wildlife Conservation  
14 Commission shall be authorized to issue any waterfowl  
15 stamps; and providing an effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 29 O.S. 2011, Section 4-130, is  
18 amended to read as follows:

19 Section 4-130. A. Except as otherwise provided in the Oklahoma  
20 Wildlife Conservation Code, no person may hunt or take any waterfowl  
21 during the open season on waterfowl unless the person has first  
22 obtained an Oklahoma waterfowl hunting stamp or license from the  
23 Director or authorized agents of the Director. Each person shall  
24 have the stamp or license in their possession when hunting or taking  
any waterfowl. When a stamp is purchased, the stamp shall be

1 validated by the signature of the licensee written across the face  
2 of the stamp.

3 B. Persons excepted from the Oklahoma waterfowl hunting stamp  
4 or license requirement of this section are:

5 1. Legal residents of Oklahoma under sixteen (16) years of age;  
6 and

7 2. Legal residents of Oklahoma sixty-five (65) years of age or  
8 older.

9 C. 1. The Oklahoma waterfowl hunting stamp fee and waterfowl  
10 license shall each be Nine Dollars (\$9.00). The remainder of the  
11 fee shall be deposited in the Wildlife Conservation Fund, to be used  
12 exclusively in the State of Oklahoma, for the purpose of developing,  
13 managing, preserving, restoring and maintaining wetland habitats and  
14 for the conservation and management of waterfowl and ecologically  
15 related species.

16 2. The collection and remittance procedures applicable to  
17 hunting license fees under this title shall apply to waterfowl stamp  
18 or license fees.

19 3. The waterfowl stamp or license issued pursuant to this  
20 section shall expire on June 30 of each year.

21 D. The Oklahoma Wildlife Conservation Commission ~~shall~~ may  
22 prescribe, by regulation, the form, design and manner of issuance,  
23 if any, of the waterfowl stamp, which could include the selection of  
24 art for such stamp from an art contest regulated by the Commission.

1 ~~The art for the stamp shall be selected from an art contest which~~  
2 ~~shall be regulated by the Commission.~~

3 E. 1. Any person arrested for hunting or taking any waterfowl  
4 during the open season on waterfowl without a valid Oklahoma  
5 waterfowl hunting stamp or license as required by the provisions of  
6 subsection A of this section may purchase a substitute temporary  
7 thirty-day stamp or license from the arresting game warden in lieu  
8 of posting bond. Proof of hunter safety certification shall not be  
9 required for the temporary substitute stamp or license. The fee for  
10 a substitute stamp or license purchased pursuant to the provisions  
11 of this subsection shall be:

- 12 a. for legal residents - Fifty Dollars (\$50.00), and
- 13 b. for nonresidents - One Hundred Forty-five Dollars  
14 (\$145.00).

15 2. The fees from the temporary stamp and license purchased  
16 pursuant to the provisions of this subsection shall be deposited in  
17 the Wildlife Conservation Fund, to be used exclusively in the State  
18 of Oklahoma, for the purpose of developing, managing, preserving,  
19 restoring and maintaining wetland habitats and for the conservation  
20 and management of waterfowl and ecologically related species.

21 F. Any person convicted of violating any of the provisions of  
22 this section shall be punished by a fine of not less than Twenty-  
23 five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00).

1       G. Nothing in this title shall prohibit a person from hunting  
2 waterfowl exclusively on their own property without an Oklahoma  
3 waterfowl hunting stamp or license.

4       SECTION 2. This act shall become effective November 1, 2018.
