8 An Act relating to school superintendents;  
9 establishing minimum and maximum salary schedule for  
10 superintendents; prohibiting school district boards  
11 of education from entering into or renewing contracts  
12 above certain caps; allowing the State Board of  
13 Education to approve waivers to certain maximum  
14 amounts for certain districts; providing definition;  
15 providing for promulgation of rules; providing for  
16 codification; providing an effective date; and  
17 declaring an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. NEW LAW A new section of law to be codified  
20 in the Oklahoma Statutes as Section 18-114.15 of Title 70, unless  
21 there is created a duplication in numbering, reads as follows:

22 A. Beginning with the 2017-2018 school year, a school district  
23 board of education shall not enter into a new contract or renew a  
24 contract with a superintendent after the effective day of this act  
that is less than the minimum compensation or exceeds the maximum  
compensation amounts provided for in the following schedule:

- 1        1. Twenty Thousand Dollars (\$20,000.00) to Sixty-Five Thousand  
2 Dollars (\$65,000.00) for the superintendent of a district or  
3 districts with an average daily membership (ADM) of under 100;
- 4        2. A maximum of Eighty-Five Thousand Dollars (\$85,000.00) for  
5 the superintendent of a district or districts with an ADM of one  
6 hundred fifty (150) or less but more than one hundred (100);
- 7        3. A maximum of Ninety-five Thousand Dollars (\$95,000.00) for  
8 the superintendent of a district or districts with an ADM of two  
9 hundred (200) or less but more than one hundred fifty-one (150);
- 10       4. A maximum of One Hundred Thousand Dollars (\$100,000.00) for  
11 the superintendent of a district or districts with an ADM of two  
12 hundred-fifty (250) or less but more than two hundred (200);
- 13       5. A maximum of One Hundred Thousand Dollars (\$100,000.00) for  
14 the superintendent of a district or districts with an average daily  
15 membership (ADM) of two hundred fifty (250) or less;
- 16       6. A maximum of One Hundred Ten Thousand Dollars (\$110,000.00)  
17 for the superintendent of a district or districts with an ADM of  
18 seven hundred fifty (750) or less but more than two hundred fifty  
19 (250);
- 20       7. A maximum of One Hundred Twenty Thousand Dollars  
21 (\$120,000.00) for the superintendent of a district or districts with  
22 an ADM of one thousand five hundred (1,500) or less but more than  
23 seven hundred fifty (750);

1           8. A maximum of One Hundred Thirty Thousand Dollars  
2 (\$130,000.00) for the superintendent of a district or districts with  
3 an ADM of three thousand (3,000) or less but more than one thousand  
4 five hundred (1,500);

5           9. A maximum of One Hundred Forty Thousand Dollars  
6 (\$140,000.00) for the superintendent of a district or districts with  
7 an ADM of six thousand five hundred (6,500) or less but more than  
8 three thousand (3,000); and

9           10. A maximum of One Hundred Fifty Thousand Dollars  
10 (\$150,000.00) for the superintendent of a district or districts with  
11 an ADM of more than six thousand five hundred (6,500).

12           B. A school district board of education may enter into a new  
13 contract or renew a contract with a superintendent that exceeds the  
14 maximum compensation amounts provided for in subsection A of this  
15 section provided that no state appropriated funds are used for any  
16 amount above the maximum amount allowed.

17           C. The State Board of Education, upon written application by  
18 the school district board of education, may approve a waiver of the  
19 maximum compensation amounts for any district or districts with an  
20 ADM of fifteen thousand (15,000) or more.

21           D. For the purposes of this section, "compensation" shall mean  
22 base salary and fringe benefits.

23           E. The State Board of Education shall promulgate rules  
24 necessary to implement the provisions of this act.

1 SECTION 2. This act shall become effective July 1, 2017.

2 SECTION 3. It being immediately necessary for the preservation  
3 of the public peace, health or safety, an emergency is hereby  
4 declared to exist, by reason whereof this act shall take effect and  
5 be in full force from and after its passage and approval.
