7 An Act relating to elections; amending 26 O.S. 2011,
8 Sections 2-111.1 and 2-118, as amended by Section 98,
9 Chapter 304, O.S.L. 2012 (26 O.S. Supp. 2017, Section
10 2-118), which relate to county election boards;
11 modifying terms and salaries of secretaries of county
12 election boards; deleting obsolete language;
13 clarifying language; and providing an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 26 O.S. 2011, Section 2-111.1, is
16 amended to read as follows:

17 Section 2-111.1. The State Election Board shall appoint the
18 secretary of each county election board for a term of two (2) years
19 beginning May 1, 1983, and every two (2) years thereafter; provided,
20 ~~however, that on October 1, 1981, a secretary shall be appointed in~~
21 ~~each county for the balance of a term of two (2) years ending April~~
22 ~~30, 1983~~ beginning May 1, 2019, the State Election Board shall
23 appoint the secretary of each county election board for a term of
24 four (4) years beginning May 1, 2019, and every (4) years
thereafter.

1 SECTION 2. AMENDATORY 26 O.S. 2011, Section 2-118, as
2 amended by Section 98, Chapter 304, O.S.L. 2012 (26 O.S. Supp. 2017,
3 Section 2-118), is amended to read as follows:

4 Section 2-118. A. 1. Except as provided by subsection C of
5 this section the secretary of each county election board shall be
6 paid an annual salary to be determined by the following schedule.
7 However, the salary of a county election board secretary shall not
8 fall below the level of the April 30, 2003, salary, and the salary
9 of any person who is reappointed to the position of county election
10 board secretary shall not fall below the salary received in the
11 immediately preceding term, regardless of the number of active
12 registered voters in the county. ~~A county election board secretary~~
13 ~~serving on April 30, 2004, shall not receive a salary increase if~~
14 ~~said secretary is paid an amount greater than the salary indicated~~
15 ~~in this section according to the number of registered voters in said~~
16 ~~county.~~ A county election board secretary shall not receive a
17 salary increase while the county is under the administrative
18 supervision of the State Election Board.

B. The salary and fringe benefits paid to each secretary shall be paid from county funds on a monthly basis and shall be reimbursed from funds appropriated by the Legislature for that purpose at a rate of not to exceed one hundred thirty-five percent (135%) of the above-specified salaries. Claims for ~~said~~ reimbursement shall be filed according to procedures prescribed by the Secretary of the State Election Board and approved by the Director of the Office of Management and Enterprise Services. ~~Said claims~~ Claims for reimbursement shall only be paid for actual expenditures made by the county. The number of registered voters, for the purposes of this

1 section, shall be determined by the number of registered voters,
2 excluding inactive voters, in the county on January 1, ~~1979~~, and
3 ~~every two (2) years thereafter~~ of each odd-numbered year.

4 C. The provisions of this section shall not preclude a county
5 from providing additional compensation, payable from county funds,
6 to the secretary of the county election board; provided, any such
7 additional compensation shall not be considered part of the
8 secretary's salary, and shall not be reimbursed by the State
9 Election Board.

10 SECTION 3. This act shall become effective November 1, 2018.
