Supp. 2017, Section 697.25), which relates to powers and duties; 8 providing that graduates of certain foreign medical 9 schools shall not be given preference over graduates of medical schools located in this state; and providing an effective date. 10 11 12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 13 SECTION 1. Section 4, Chapter 348, O.S.L. 14 AMENDATORY 15 2012, as amended by Section 1, Chapter 304, O.S.L. 2017 (70 O.S. Supp. 2017, Section 697.25), is amended to read as follows: 16 Section 697.25. A. The Oklahoma Health Care Authority shall, 17 in consultation with the Oklahoma State University College of 18 Osteopathic Medicine and the University of Oklahoma College of 19 Medicine, designate eligible hospitals for the creation of new 20 residency training programs to serve medically underserved areas. 21 The Oklahoma Health Care Authority is authorized to contract 22 with the Oklahoma State University of Osteopathic Medicine and the 23 University of Oklahoma College of Medicine to provide funding for 24

- the establishment of new residency training programs created under the Oklahoma Hospital Residency Training Program Act.
- The Oklahoma Health Care Authority shall, with the 3 C. assistance of the Oklahoma State University College of Osteopathic 4 5 Medicine and the University of Oklahoma College of Medicine, provide technical assistance and funding for the colleges' costs incurred in 6 7 supporting the programs to ensure that residency training programs established pursuant to the Oklahoma Hospital Residency Training 9 Program Act become funded by the Centers for Medicaid and Medicare 10 Services. Any student who is a resident of this state or who is in good academic standing with an accredited medical college in this 11 12 state shall receive priority consideration in the process of assigning clinical rotations at a health care facility that accepts 13 state funding. Graduates of medical schools located in other 14 15 countries which give any type of monetary contribution to a health 16 facility located in this state shall not be given preference for residency programs over graduates of a medical school located in 17 this state. For purposes of this section, "resident" means an 18 individual who resided in this state at the time of graduation from 19 an Oklahoma high school. 20
 - D. The Oklahoma Health Care Authority shall establish reporting mechanisms for eligible hospitals for the monitoring of progress of the new residency training programs.
