7 An Act relating to memorial highway designations;
8 designating the Robert B. Robison Memorial Highway;
9 designating the Sergeant Jeffrey Lee Drake Memorial
10 Highway; designating the SSGT Jason R. Hendrex
11 Memorial Bridge; designating the James Robert "Bob"
Kalsu Memorial Highway; designating the Nancy
Randolph Davis Memorial Highway; requiring certain
markers; providing for codification; and providing an
effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 1698.269 of Title 69, unless
17 there is created a duplication in numbering, reads as follows:

18 The portion of SH-66 in Rogers County beginning at the
19 intersection of County Road S4110 extending north to the
20 intersection of Fisher Road in the Town of Verdigris shall be
21 designated as the "Robert B. Robison Memorial Highway". The
22 Department of Transportation shall cause suitable permanent markers
23 bearing that name to be placed on the highway.

1 SECTION 2. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.270 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The portion of State Highway 169 beginning at the intersection
5 of U.S. 266 and extending south to the intersection of East 36th
6 Street North within the municipal limits of Tulsa shall be
7 designated as the "Sergeant Jeffrey Lee Drake Memorial Highway".
8 The Department of Transportation shall cause suitable permanent
9 markers bearing that name to be placed on the highway.

10 SECTION 3. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 1698.271 of Title 69, unless
12 there is created a duplication in numbering, reads as follows:

13 The bridge over Caney Creek on U.S. Highway 169, located 1.9
14 miles north of SH-20 in Rogers County, shall be designated as the
15 "SSGT Jason R. Hendrex Memorial Bridge". The Department of
16 Transportation shall cause suitable permanent markers bearing that
17 name to be placed on the bridge.

18 SECTION 4. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 1698.272 of Title 69, unless
20 there is created a duplication in numbering, reads as follows:

21 The section of Interstate Highway 44 between SW 104th Street and
22 SW 119th Street in Cleveland County shall be designated as the
23 "James Robert "Bob" Kalsu Memorial Highway". The Department of

1 Transportation shall cause suitable permanent markers bearing that
2 name to be placed on the highway.

3 SECTION 5. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.273 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The section of Interstate 35 in Payne County beginning one mile
7 north of the intersection with State Highway 51 and extending south
8 for two miles shall be designated as the "Nancy Randolph Davis
9 Memorial Highway". The Department of Transportation shall cause
10 suitable permanent markers bearing that name to be placed on the
11 highway.

12 SECTION 6. This act shall become effective November 1, 2018.
