As used in the Electrical License Act: 16 1. "Board" means the Construction Industries Board; 17 "Committee" means the Committee of Electrical Examiners 18 appointed by the Board; 19 "Electrical apprentice" means any person sixteen (16) years 20 of age or older whose principal occupation is the learning of and 21 assisting in the installation of electrical work under the direct 22 supervision of a licensed journeyman electrician or electrical 23 contractor;

- 4. "Journeyman electrician" means any person other than an electrical contractor who engages in the actual installation, alteration, repair or renovation of electrical facilities or electrical construction work unless specifically exempted by the provisions of the Electrical License Act;
- 5. "Electrical contractor" means any person skilled in the planning, superintending and practical installation of electrical facilities who is familiar with the laws, rules and regulations governing such work. Electrical contractor also means any individual, firm, partnership, corporation, limited liability company, or business performing skills of an electrical contractor or an electrician or the business of contracting, or furnishing labor or labor and materials for the installation, repair, maintenance or renovation of electrical facilities or electrical construction work according to the provisions of the Electrical License Act;
- 6. "Electrical facilities" means all wiring, fixtures, appurtenances, and appliances for, and in connection with, a supply of electricity within or adjacent to any building, structure or conveyance on the premises but not including the connection with a power supply meter or other power supply source;
- 7. "Category" means the classification by which licenses and electrical work may be limited. Such categories shall include but

- 1 shall not be limited to installation, maintenance, repair,
 2 alteration, residential, oilfield, and commercial;
 - 8. "Temporary journeyman electrician" means any person other than a person permanently licensed as a journeyman electrician or electrical contractor in this state who meets the temporary licensure requirements of Section 1685.1 of this title;
 - 9. "Variance and Appeals Board" means the Oklahoma State Electrical Installation Code Variance and Appeals Board; and
 - 10. "Electrical construction work" means installation, fabrication or assembly of equipment or systems included in "premises wiring" as defined in the National Electrical Code (reference 158:40-1-4. Standard of Installation), and which is hereby adopted and incorporated by reference. Electrical construction work includes, but is not limited to, installation of raceway systems used for any electrical purposes, and installation of field-assembled systems such as ice and snow melting, pipetracing, and manufactured wiring systems. Electrical construction work shall not include in-plant work performed by employees of the company owning the plant, work performed by telecommunications employees for telecommunications companies, or installation of factory-assembled appliances or machinery which is not part of the premises wiring unless wiring interconnections external to the equipment are required in the field; and

- 1 11. "Electrical work" means work consisting primarily of the
- 2 | layout, installation, maintenance, repair, testing or replacement of
- 3 | all or part of electrical wires, conduits, apparatus, fixtures,
- 4 appliances or equipment for transmitting, carrying, controlling or
- 5 using electricity in, on, outside or attached to a building,
- 6 | structure, property or premises. "Electrical work" shall not mean
- 7 | work that is related to or facilitates the construction,

- 11 SECTION 2. AMENDATORY 59 O.S. 2011, Section 1692, is

- 13 | Section 1692. A. The provisions of the Electrical License Act
- 14 | shall not apply to:
- 1. Minor repairs, consisting of repairing or replacing outlets
- 16 or minor working parts of electrical fixtures;
 - 2. Maintenance work for state and federal institutions;
- 18 3. The construction, installation, maintenance, repair and
- 19 renovation by a public utility regulated by the Corporation
- 20 Commission;

- 21 4. Public service corporations, telephone and telegraph
- 22 | companies, rural electric associations or municipal utilities;
- 23 5. The construction, installation, maintenance, repair and
- 24 renovation of telephone equipment or computer systems by a person,

- 1 firm, or corporation engaged in the telecommunications or
- 2 | information systems industry when such activities involve work
- 3 exclusively for communication of data, voice, or for other signaling
- 4 purposes; except fire alarm systems, security systems and
- 5 environmental control systems that are not an integral part of a
- 6 | telecommunications system; or
- 7 | 6. The installation, maintenance, repair or replacement of
- 8 | water supply pumps, provided such work is performed from the output
- 9 | side of a fused disconnect or breaker box; or
- 7. Alarm and locksmiths, or low voltage providers, who perform
- 11 | installation, maintenance, repair, replacement and renovation of
- 12 | Class 2 and Class 3 circuits; provided the work is performed in
- 13 | accordance with the National Electrical Code, NFPA 70, requirements
- 14 | for such Class 2 or Class 3 circuits.
- B. Nothing in the Electrical License Act shall be construed to
- 16 require:
- 17 | 1. Employment of a licensed electrical contractor, journeyman
- 18 | electrician or electrical apprentice except as required by local
- 19 ordinances and resolutions;
- 20 2. Any regular employee of any firm or corporation to hold a
- 21 license before doing any electrical work on the property of the firm
- 22 or corporation whether or not the property is owned, leased or
- 23 rented except as may be required by local ordinances and
- 24 resolutions; or

1	3. An individual to hold a license before doing electrical work
2	on his own property or residence except as may be required by local
3	ordinances and resolutions.
4	SECTION 3. NEW LAW A new section of law to be codified
5	in the Oklahoma Statutes as Section 1698 of Title 59, unless there
6	is created a duplication in numbering, reads as follows:
7	No more than three registered apprentice electricians shall work
8	under the supervision of a single journeyman or contractor.
9	SECTION 4. NEW LAW A new section of law not to be
10	codified in the Oklahoma Statutes reads as follows:
11	The Construction Industries Board shall amend its rules,
12	wherever applicable, to conform to the definition and requirement of
13	this act.
14	SECTION 5. This act shall become effective November 1, 2018.
