8 expenses of various agencies of the executive,
9 legislative and judicial departments of the state;
10 making appropriations to the State Board of
11 Education, the Oklahoma Arts Council, the State Board

Veterans Affairs, the Oklahoma Commission on Children
and Youth, the Office of Disability Concerns, the

1 Department of Human Services, the Office of Juvenile
2 Affairs, the State Department of Rehabilitation
3 Services, the Oklahoma Department of Agriculture,
4 Food, and Forestry, the Oklahoma Department of
5 Commerce, the Rural Economic Action Plan Fund, the
6 Oklahoma Conservation Commission, the Corporation
7 Commission, the Department of Environmental Quality,
8 the Oklahoma Historical Society, the J.M. Davis
9 Memorial Commission, the Department of Labor, the
10 Department of Mines, the Oklahoma Tourism and
11 Recreation Department, the Oklahoma Water Resources
12 Board, the Alcoholic Beverage Laws Enforcement
13 Commission, the Department of Corrections, the
14 Oklahoma State Bureau of Investigation, the Council
15 on Law Enforcement Education and Training, the Board
16 of Medicolegal Investigations, the Oklahoma State
17 Bureau of Narcotics and Dangerous Drugs Control, the
18 Department of Public Safety, the Court of Criminal
19 Appeals, district attorneys and the District
20 Attorneys Council, the Supreme Court, the Oklahoma
21 Indigent Defense System, the Pardon and Parole Board,
22 the Oklahoma Quick Action Closing Fund and the State
23 Emergency Fund; stating amounts of the
24 appropriations; stating purposes and restrictions;
reappropriating certain funds; authorizing transfers
and deposits; repealing Sections 1 through 18 of
Enrolled House Bill No. 3705 of the 2nd Session of
the 56th Oklahoma Legislature, which relate to the
State Board of Education funding; repealing Sections
2 and 3 of Enrolled House Bill No. 1022XX of the 2nd
Extraordinary Session of the 56th Oklahoma
Legislature, which relate to Oklahoma Health Care
Authority funding; and providing effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of
Education from any monies not otherwise appropriated from the
General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2019, the sum of One Billion Three Hundred Seventy-
2 three Million Two Hundred One Thousand Three Hundred One Dollars
3 (\$1,373,201,301.00) or so much thereof as may be necessary for the
4 financial support of public schools. Of those funds appropriated,
5 the State Board of Education shall designate adequate amounts for
6 increased compensation for certified personnel as provided in the
7 provisions of Enrolled House Bill No. 1023 of the 2nd Extraordinary
8 Session of the 56th Oklahoma Legislature, and for increased
9 compensation for support employees as provided in the provisions of
10 Enrolled House Bill No. 1026 of the 2nd Extraordinary Session of the
11 56th Oklahoma Legislature.

12 SECTION 2. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Education Reform Revolving Fund created in Section 34.89 of Title 62
15 of the Oklahoma Statutes, the sum of Eight Hundred Eighteen Million
16 One Hundred Sixty-six Thousand Nine Hundred Seventy-six Dollars
17 (\$818,166,976.00) or so much thereof as may be necessary for the
18 financial support of public schools.

19 SECTION 3. The State Board of Education is hereby authorized to
20 expend during the fiscal year ending June 30, 2019, from the Common
21 Education Technology Revolving Fund of the State Treasury, the sum
22 of Fifty Million Four Hundred Seventy Thousand Seven Hundred Fifty-
23 one Dollars (\$50,470,751.00) or so much thereof as may be necessary
24 for the financial support of public schools.

1 SECTION 4. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Mineral Leasing Fund of the State Treasury for the fiscal year
4 ending June 30, 2019, the sum of Two Million Eight Hundred Fifty
5 Thousand Dollars (\$2,850,000.00) or so much thereof as may be
6 necessary for the financial support of public schools.

7 SECTION 5. There is hereby appropriated to the State Board of
8 Education from any monies not otherwise appropriated from the
9 Mineral Leasing Fund of the State Treasury for the fiscal year
10 ending June 30, 2017, the sum of Two Hundred Ten Thousand Nine
11 Hundred Eighty-four Dollars (\$210,984.00) or so much thereof as may
12 be necessary for the financial support of public schools.

13 SECTION 6. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Mineral Leasing Fund of the State Treasury for the fiscal year
16 ending June 30, 2015, the sum of Nine Hundred Nine Thousand Nine
17 Hundred Four Dollars (\$909,904.00) or so much thereof as may be
18 necessary for the financial support of public schools.

19 SECTION 7. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the
22 fiscal year ending June 30, 2019, the sum of Thirty Million Three
23 Hundred Twenty-six Thousand Seven Hundred Thirty-five Dollars
24

1 (\$30,326,735.00) or so much thereof as may be necessary for the
2 financial support of public schools.

3 SECTION 8. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2017, the sum of One Million Nine
7 Hundred Eighty-five Thousand Six Hundred Thirty-eight Dollars
8 (\$1,985,638.00) or so much thereof as may be necessary for the
9 financial support of public schools.

10 SECTION 9. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2019, the sum of Ninety-one Million Three Hundred
14 Nineteen Thousand Twenty-six Dollars (\$91,319,026.00) or so much
15 thereof as may be necessary for the support of public schools
16 activities.

17 SECTION 10. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 General Revenue Fund of the State Treasury for the fiscal year
20 ending June 30, 2019, the sum of Thirty-three Million Dollars
21 (\$33,000,000.00) or so much thereof as may be necessary for the
22 purchase of textbooks and instructional materials.

23 SECTION 11. There is hereby appropriated to the State Board of
24 Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2019, the sum of Three Hundred Fifteen Million Four
3 Hundred Seventy-eight Thousand Thirty Dollars (\$315,478,030.00) or
4 so much thereof as may be necessary for the Certified Employee
5 Health Benefit Allowance.

6 SECTION 12. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 General Revenue Fund of the State Treasury for the fiscal year
9 ending June 30, 2019, the sum of One Hundred Seventy-one Million
10 Nine Hundred Five Thousand Eighty-six Dollars (\$171,905,086.00) or
11 so much thereof as may be necessary for the Support Personnel Health
12 Benefit Allowance.

13 SECTION 13. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2019, the sum of Fifteen Million Nine Hundred Eighty
17 Thousand One Hundred Ninety Dollars (\$15,980,190.00) or so much
18 thereof as may be necessary for administrative and support functions
19 of the State Department of Education.

20 SECTION 14. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the
23 fiscal year ending June 30, 2019, the sum of Three Million Three
24 Hundred Sixty-nine Thousand Six Hundred Thirty-seven Dollars

1 (\$3,369,637.00) or so much thereof as may be necessary for transfer
2 to the School Consolidation Assistance Fund.

3 SECTION 15. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2017, the sum of Two Hundred Twenty
7 Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much
8 thereof as may be necessary for transfer to the School Consolidation
9 Assistance Fund.

10 SECTION 16. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the
13 fiscal year ending June 30, 2019, the sum of Three Million Three
14 Hundred Sixty-nine Thousand Six Hundred Thirty-seven Dollars
15 (\$3,369,637.00) or so much thereof as may be necessary for transfer
16 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

17 SECTION 17. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the
20 fiscal year ending June 30, 2017, the sum of Two Hundred Twenty
21 Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much
22 thereof as may be necessary for transfer to the Teachers' Retirement
23 System Dedicated Revenue Revolving Fund.

1 SECTION 18. There is hereby appropriated to the Oklahoma Arts
2 Council from any monies not otherwise appropriated from the General
3 Revenue Fund of the State Treasury for the fiscal year ending June
4 30, 2019, the sum of Two Million Seven Hundred Ninety-nine Thousand
5 Two Hundred Sixty-six Dollars (\$2,799,266.00) or so much thereof as
6 may be necessary to perform the duties imposed upon the Oklahoma
7 Arts Council by law.

8 SECTION 19. There is hereby appropriated to the State Board of
9 Career and Technology Education from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2019, the sum of One Hundred Twenty
12 Million Three Hundred Eighty-eight Thousand Three Hundred Seventy-
13 one Dollars (\$120,388,371.00) or so much thereof as may be necessary
14 to perform the duties imposed upon the State Board of Career and
15 Technology Education by law.

16 SECTION 20. There is hereby appropriated to the State Board of
17 Career and Technology Education from any monies not otherwise
18 appropriated from the Oklahoma Education Lottery Trust Fund of the
19 State Treasury for the fiscal year ending June 30, 2019, the sum of
20 Three Million Seven Hundred Six Thousand Six Hundred One Dollars
21 (\$3,706,601.00) pursuant to paragraph 2 of subsection C of Section
22 713 of Title 3A of the Oklahoma Statutes for allocation by the State
23 Board of Career and Technology Education for the education and
24 general operating budgets of the institutions and for other

1 programs, construction, renovations or repairs administered by the
2 State Board of Career and Technology Education.

3 SECTION 21. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2017, the sum of
7 Two Hundred Forty-two Thousand Six Hundred Eighty-nine Dollars
8 (\$242,689.00) pursuant to paragraph 2 of subsection C of Section 713
9 of Title 3A of the Oklahoma Statutes for allocation by the State
10 Board of Career and Technology Education for the education and
11 general operating budgets of the institutions and for other
12 programs, construction, renovations or repairs administered by the
13 State Board of Career and Technology Education.

14 SECTION 22. There is hereby appropriated to the Office of
15 Educational Quality and Accountability from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2019, the sum of One Million One
18 Hundred Twenty-four Thousand Seven Hundred Ninety-one Dollars
19 (\$1,124,791.00) or so much thereof as may be necessary to perform
20 the duties imposed upon the Office of Educational Quality and
21 Accountability by law.

22 SECTION 23. There is hereby appropriated to the Office of
23 Educational Quality and Accountability from any monies not otherwise
24 appropriated from the Special Cash Fund of the State Treasury the

1 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
2 thereof as may be necessary to perform the duties imposed upon the
3 Office of Educational Quality and Accountability by law.

4 SECTION 24. There is hereby appropriated to the Oklahoma
5 Educational Television Authority from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2019, the sum of Two Million Seven
8 Hundred Seventy-nine Thousand Two Hundred Eighty-three Dollars
9 (\$2,779,283.00) or so much thereof as may be necessary to perform
10 the duties imposed upon the Oklahoma Educational Television
11 Authority by law.

12 SECTION 25. There is hereby appropriated to the Oklahoma State
13 Regents for Higher Education from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2019, the sum of Six Hundred Thirty-
16 four Million Nine Hundred Sixty-eight Thousand Two Hundred Ninety
17 Dollars (\$634,968,290.00) or so much thereof as may be necessary for
18 allocation by the Oklahoma State Regents for Higher Education
19 pursuant to the provisions of Article XIII-a of the Oklahoma
20 Constitution for the education and general operating budgets of the
21 institutions and for other programs, construction, renovations or
22 repairs administered by the Oklahoma State Regents for Higher
23 Education. Of those funds appropriated, the sum of Three Million
24 Twenty-four Thousand Six Hundred Forty-two Dollars (\$3,024,642.00)

1 shall be transferred to the Oklahoma Tuition Equalization Grant
2 Trust Fund to implement the provisions of the Oklahoma Tuition
3 Equalization Grant Act.

4 SECTION 26. The Oklahoma State Regents for Higher Education are
5 hereby authorized to expend during the fiscal year ending June 30,
6 2019, the sum of Fifty Million Four Hundred Seventy Thousand Seven
7 Hundred Fifty-one Dollars (\$50,470,751.00) from the Higher Education
8 Capital Revolving Fund of the State Treasury for allocation by the
9 Oklahoma State Regents for Higher Education pursuant to the
10 provisions of Article XIII-a of the Oklahoma Constitution for the
11 education and general operating budgets of the institutions and for
12 other programs, construction, renovations or repairs administered by
13 the Oklahoma State Regents for Higher Education.

14 SECTION 27. The Oklahoma State Regents for Higher Education are
15 hereby authorized to expend during the fiscal year ending June 30,
16 2019, the sum of Fifty Million Four Hundred Seventy Thousand Seven
17 Hundred Fifty-one Dollars (\$50,470,751.00) from the Oklahoma Student
18 Aid Revolving Fund of the State Treasury for allocation by the
19 Oklahoma State Regents for Higher Education pursuant to the
20 provisions of Article XIII-a of the Oklahoma Constitution for the
21 education and general operating budgets of the institutions and for
22 other programs, construction, renovations or repairs administered by
23 the Oklahoma State Regents for Higher Education.

1 SECTION 28. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2019, the sum of Eight Million Four
5 Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars
6 (\$8,464,823.00) or so much thereof as may be necessary for
7 expenditures for concurrent enrollment pursuant to Section 628.13 of
8 Title 70 of the Oklahoma Statutes.

9 SECTION 29. There is hereby appropriated to the Oklahoma State
10 Regents for Higher Education from any monies not otherwise
11 appropriated from the Oklahoma Education Lottery Trust Fund of the
12 State Treasury for the fiscal year ending June 30, 2019, the sum of
13 Twenty-six Million Six Hundred Twenty Thousand One Hundred Thirty-
14 four Dollars (\$26,620,134.00) pursuant to paragraph 2 of subsection
15 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation
16 by the Oklahoma State Regents for Higher Education pursuant to the
17 provisions of Article XIII-a of the Oklahoma Constitution for
18 construction, renovations or repairs administered by the Oklahoma
19 State Regents for Higher Education or for any other purpose
20 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
21 of the Oklahoma Statutes.

22 SECTION 30. There is hereby appropriated to the Oklahoma State
23 Regents for Higher Education from any monies not otherwise
24 appropriated from the Oklahoma Education Lottery Trust Fund of the

1 State Treasury for the fiscal year ending June 30, 2017, the sum of
2 One Million Seven Hundred Forty-two Thousand Nine Hundred Forty-nine
3 Dollars (\$1,742,949.00) pursuant to paragraph 2 of subsection C of
4 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
5 the Oklahoma State Regents for Higher Education pursuant to the
6 provisions of Article XIII-a of the Oklahoma Constitution for
7 construction, renovations or repairs administered by the Oklahoma
8 State Regents for Higher Education or for any other purpose
9 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
10 of the Oklahoma Statutes.

11 SECTION 31. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the General Revenue Fund of the State Treasury for
14 the fiscal year ending June 30, 2019, the sum of Three Million Nine
15 Hundred Sixty-nine Thousand Four Hundred Sixty-nine Dollars
16 (\$3,969,469.00) or so much thereof as may be necessary for the
17 general operating budget of the Administrative Offices of the
18 Oklahoma State Regents for Higher Education.

19 SECTION 32. There is hereby appropriated to the Commissioners
20 of the Land Office from any monies not otherwise appropriated from
21 the Commissioners of the Land Office Fund of the State Treasury for
22 the fiscal year ending June 30, 2019, the sum of Eight Million Six
23 Hundred Fifty-four Thousand Three Hundred Seventy-one Dollars
24

1 (\$8,654,371.00) or so much thereof as may be necessary to perform
2 the duties imposed upon the Commissioners of the Land Office by law.

3 SECTION 33. There is hereby appropriated to the Oklahoma
4 Department of Libraries from any monies not otherwise appropriated
5 from the General Revenue Fund of the State Treasury for the fiscal
6 year ending June 30, 2019, the sum of Four Million Four Hundred
7 Eighty-three Thousand Ten Dollars (\$4,483,010.00) or so much thereof
8 as may be necessary to perform the duties imposed upon the Oklahoma
9 Department of Libraries by law.

10 SECTION 34. There is hereby appropriated to the Physician
11 Manpower Training Commission from any monies not otherwise
12 appropriated from the General Revenue Fund of the State Treasury for
13 the fiscal year ending June 30, 2019, the sum of Two Million Nine
14 Hundred Thousand Seven Hundred Eighty-one Dollars (\$2,900,781.00) or
15 so much thereof as may be necessary to perform the duties imposed
16 upon the Physician Manpower Training Commission by law.

17 SECTION 35. There is hereby appropriated to the Physician
18 Manpower Training Commission from any monies not otherwise
19 appropriated from the Special Cash Fund of the State Treasury the
20 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
21 thereof as may be necessary to perform the duties imposed upon the
22 Physician Manpower Training Commission by law.

23 SECTION 36. There is hereby appropriated to the Board of
24 Trustees of the Oklahoma School of Science and Mathematics from any

monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Six Million Two Hundred Five Thousand Four Hundred Sixteen Dollars (\$6,205,416.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 37. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Thirteen Million Three Hundred Fifty-six Thousand Nine Hundred Twenty-seven Dollars (\$13,356,927.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law. Of those funds appropriated, the sum of Five Million Three Hundred Thirty-three Thousand Five Hundred Forty-two Dollars (\$5,333,542.00) shall be deposited in the Research Support Revolving Fund, created pursuant to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those funds appropriated, the sum of Two Million Nine Hundred Thirty-three Thousand Four Hundred Forty-eight Dollars (\$2,933,448.00) shall be deposited in the Seed-capital Revolving Fund, created pursuant to Section 5060.21 of Title 74 of the Oklahoma Statutes.

GENERAL GOVERNMENT AND TRANSPORTATION

1 SECTION 38. There is hereby appropriated to the Office of the
2 Attorney General from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2019, the sum of Nine Million Three Hundred Sixty-
5 two Thousand Fifty-one Dollars (\$9,362,051.00) or so much thereof as
6 may be necessary to perform the duties imposed upon the Office of
7 the Attorney General by law.

8 SECTION 39. There is hereby appropriated to the Office of the
9 Attorney General from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2019, the sum of Eight Hundred Ninety-nine Thousand
12 Three Hundred Fifty-two Dollars (\$899,352.00) to transfer to the
13 Legal Services Revolving Fund, created pursuant to subsection G of
14 Section 921.1 of Title 12 of the Oklahoma Statutes.

15 SECTION 40. For the fiscal year ending June 30, 2019, the
16 Office of the Attorney General is authorized to transfer an amount
17 not to exceed Three Hundred Twenty Thousand Four Hundred Thirty
18 Dollars (\$320,430.00) from the Office of the Attorney General's
19 Evidence Fund (700 Fund), created by Section 19 of Title 74 of the
20 Oklahoma Statutes, to the Office of the Attorney General's Revolving
21 Fund (200 Fund), created by Section 20 of Title 74 of the Oklahoma
22 Statutes.

23 SECTION 41. There is hereby appropriated to the Office of the
24 State Auditor and Inspector from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2019, the sum of Three Million Four
3 Hundred Twenty-six Thousand Two Hundred Seventy-two Dollars
4 (\$3,426,272.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the Office of the State Auditor and
6 Inspector by law.

7 of Labor by law.

8 SECTION 91. There is hereby appropriated to the Department of
9 Labor from any monies not otherwise appropriated from the Special
10 Occupational Health and Safety Fund for the fiscal year ending June
11 30, 2019, the sum of One Million Three Hundred Thirty Thousand
12 Dollars (\$1,330,000.00) or so much thereof as may be necessary to
13 perform the duties imposed upon the Department of Labor by law.

14 SECTION 92. Of the funds appropriated in Sections 90 and 91 of
15 this act, a maximum of One Million Two Hundred Seventy-five Thousand
16 Dollars (\$1,275,000.00) may be transferred to the Department of
17 Labor Revolving Fund created by Section 141.19 of Title 40 of the
18 Oklahoma Statutes, to be expended in accordance with law.

19 SECTION 93. There is hereby appropriated to the Department of
20 Mines from any monies not otherwise appropriated from the General
21 Revenue Fund of the State Treasury for the fiscal year ending June
22 30, 2019, the sum of Seven Hundred Seventy-five Thousand Eight
23 Hundred Fifty-nine Dollars (\$775,859.00) or so much thereof as may
24

1 be necessary to perform the duties imposed upon the Department of
2 Mines by law.

3 SECTION 94. There is hereby appropriated to the Oklahoma
4 Tourism and Recreation Department from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2019, the sum of Eighteen Million
7 Ninety-five Thousand Nine Hundred Fifty-one Dollars (\$18,095,951.00)
8 or so much thereof as may be necessary to perform the duties imposed
9 upon the Oklahoma Tourism and Recreation Department by law.

10 SECTION 95. There is hereby appropriated to the Oklahoma Water
11 Resources Board from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2019, the sum of Five Million Three Hundred Forty-
14 two Thousand Nine Hundred Forty-six Dollars (\$5,342,946.00) or so
15 much thereof as may be necessary to perform the duties imposed upon
16 the Oklahoma Water Resources Board by law.

17 SECTION 96. The Director of the Office of Management and
18 Enterprise Services shall transfer monies from the appropriation
19 made to the Oklahoma Water Resources Board in Section 95 of this act
20 to the Rural Economic Action Plan Water Projects Fund (225 Fund)
21 created pursuant to Section 2002.1 of Title 62 of the Oklahoma
22 Statutes in amounts and ratios requested by the agency for the Rural
23 Economic Action Plan program except that the cumulative amounts
24 transferred shall not exceed the cumulative amounts of equal monthly

1 allotments of the appropriations made to Oklahoma Water Resources
2 Board.

3 PUBLIC SAFETY

4 SECTION 97. There is hereby appropriated to the Alcoholic
5 Beverage Laws Enforcement Commission from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2019, the sum of Two Million Four
8 Hundred Eighty-nine Thousand Seven Hundred Twenty-eight Dollars
9 (\$2,489,728.00) or so much thereof as may be necessary to perform
10 the duties imposed upon the Alcoholic Beverage Laws Enforcement
11 Commission by law.

12 SECTION 98. There is hereby appropriated to the Alcoholic
13 Beverage Laws Enforcement Commission from any monies not otherwise
14 appropriated from the Special Cash Fund of the State Treasury, the
15 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
16 thereof as may be necessary to perform the duties imposed upon the
17 Alcoholic Beverage Laws Enforcement Commission by law.

18 SECTION 99. There is hereby appropriated to the Department of
19 Corrections from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2019, the sum of Five Hundred Twelve Million Eight
22 Hundred Seventy-five Thousand Five Hundred Forty-two Dollars
23 (\$512,875,542.00) or so much thereof as may be necessary to perform
24 the duties imposed upon the Department of Corrections by law.

1 SECTION 100. There is hereby appropriated to the Department of
2 Corrections from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of Four Million Three Hundred Seventy-
5 nine Thousand Nine Hundred Sixty-one Dollars (\$4,379,961.00) or so
6 much thereof as may be necessary to perform the duties imposed upon
7 the Department of Corrections by law.

8 SECTION 101. There is hereby appropriated to the Oklahoma State
9 Bureau of Investigation from any monies not otherwise appropriated
10 from the General Revenue Fund of the State Treasury for the fiscal
11 year ending June 30, 2019, the sum of Twelve Million Three Hundred
12 Sixty-three Thousand Seven Hundred Fifty Dollars (\$12,363,750.00) or
13 so much thereof as may be necessary to perform the duties imposed
14 upon the Oklahoma State Bureau of Investigation by law. Of the
15 funds appropriated herein, a maximum of One Hundred Thousand Dollars
16 (\$100,000.00) may be transferred to an agency special account for
17 the purpose of purchasing evidence items, paying fees to informers
18 or special employees, paying expenses incurred in the prosecution
19 and defense of civil actions, and paying other expenses as incurred
20 under the Evidence Fund activity in trying to apprehend and convict
21 violators of the laws of the state. The Oklahoma State Bureau of
22 Investigation shall report income to the Evidence Fund annually
23 pursuant to the provisions of Sections 34.42 and 34.36 of Title 62
24 of the Oklahoma Statutes.

1 SECTION 102. There is hereby appropriated to the Council on Law
2 Enforcement Education and Training from any monies not otherwise
3 appropriated from the C.L.E.E.T. Fund for the fiscal year ending
4 June 30, 2019, the sum of Two Million Seven Hundred Sixty-five
5 Thousand Twenty-five Dollars (\$2,765,025.00) or so much thereof as
6 may be necessary to perform the duties imposed upon the Council on
7 Law Enforcement Education and Training by law.

8 SECTION 103. There is hereby appropriated to the Council on Law
9 Enforcement Education and Training from any monies not otherwise
10 appropriated from the C.L.E.E.T. Fund for the fiscal year ending
11 June 30, 2017, the sum of Eighty-three Thousand Three Hundred Twelve
12 Dollars (\$83,312.00) or so much thereof as may be necessary to
13 perform the duties imposed upon the Council on Law Enforcement
14 Education and Training by law.

15 SECTION 104. There is hereby appropriated to the Board of
16 Medicolegal Investigations from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2019, the sum of Eleven Million One
19 Hundred Thirty-one Thousand One Hundred Eighty-two Dollars
20 (\$11,131,182.00) or so much thereof as may be necessary to perform
21 the duties imposed upon the Board of Medicolegal Investigations by
22 law.

23 SECTION 105. There is hereby appropriated to the Oklahoma State
24 Bureau of Narcotics and Dangerous Drugs Control from any monies not

1 otherwise appropriated from the General Revenue Fund of the State
2 Treasury for the fiscal year ending June 30, 2019, the sum of Three
3 Million One Hundred Forty-one Thousand Seven Hundred Twelve Dollars
4 (\$3,141,712.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the Oklahoma State Bureau of Narcotics and
6 Dangerous Drugs Control by law.

7 SECTION 106. There is hereby appropriated to the Department of
8 Public Safety from any monies not otherwise appropriated from the
9 General Revenue Fund of the State Treasury for the fiscal year
10 ending June 30, 2019, the sum of Seventy-four Million Nine Hundred
11 Sixty-two Thousand Two Hundred Forty-eight Dollars (\$74,962,248.00)
12 or so much thereof as may be necessary to perform the duties imposed
13 upon the Department of Public Safety by law.

14 SECTION 107. There is hereby appropriated to the Department of
15 Public Safety from any monies not otherwise appropriated from the
16 State Public Safety Fund of the State Treasury for the fiscal year
17 ending June 30, 2019, the sum of Twenty-one Million Seven Hundred
18 Forty-three Thousand Five Hundred Eighty Dollars (\$21,743,580.00) or
19 so much thereof as may be necessary to perform the duties imposed
20 upon the Department of Public Safety by law.

21 SECTION 108. There is hereby appropriated to the Department of
22 Public Safety from any monies not otherwise appropriated from the
23 State Public Safety Fund of the State Treasury for the fiscal year
24 ending June 30, 2017, the sum of Four Hundred Ten Thousand Nine

1 Hundred Seventy-five Dollars (\$410,975.00) or so much thereof as may
2 be necessary to perform the duties imposed upon the Department of
3 Public Safety by law.

4 SECTION 109. There is hereby appropriated to the Department of
5 Public Safety from any monies not otherwise appropriated from the
6 C.L.E.E.T. Fund for the fiscal year ending June 30, 2019, the sum of
7 Four Hundred Ninety-four Thousand One Hundred Sixty-five Dollars
8 (\$494,165.00) or so much thereof as may be necessary to perform the
9 duties imposed upon the Department of Public Safety by law.

10 JUDICIARY

11 SECTION 110. There is hereby appropriated to the Court of
12 Criminal Appeals from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2019, the sum of Three Million Nine Hundred Fifty-
15 one Thousand Seven Hundred Forty-three Dollars (\$3,951,743.00) or so
16 much thereof as may be necessary to perform the duties imposed upon
17 the Court of Criminal Appeals by law.

18 SECTION 111. There is hereby appropriated to the District
19 Attorneys Council from any monies not otherwise appropriated from
20 the General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2019, the sum of Thirty-six Million Seventy-three
22 Thousand Ninety-three Dollars (\$36,073,093.00) or so much thereof as
23 may be necessary to perform the duties imposed upon the district
24 attorneys and the District Attorneys Council by law. Of the funds

1 appropriated herein, the District Attorneys Council shall transfer
2 up to the sum of Four Hundred Ninety-one Thousand Fourteen Dollars
3 (\$491,014.00) or so much thereof as may be required by the district
4 attorneys and District Attorneys Council to the District Attorneys
5 Evidence Fund for necessary expenses relative to any case within the
6 official responsibility of the offices of the district attorneys as
7 provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

8 SECTION 112. For the fiscal year ending June 30, 2019, the
9 District Attorneys Council is authorized to transfer an amount not
10 to exceed One Million Dollars (\$1,000,000.00), on an as-needed
11 basis, from the Crime Victims Compensation Revolving Fund created by
12 Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual
13 Assault Examination Fund, created by Section 142.20 of Title 21 of
14 the Oklahoma Statutes.

15 SECTION 113. For the fiscal year ending June 30, 2019, up to
16 Eight Hundred Sixty Thousand Dollars (\$860,000.00) is authorized to
17 be transferred from the Crime Victims Compensation Revolving Fund,
18 created by Section 142.17 of Title 21 of the Oklahoma Statutes, to
19 the District Attorneys Council to support the Crime Victims
20 Compensation Board.

21 SECTION 114. For the fiscal year ending June 30, 2019, up to
22 One Million Five Hundred One Thousand Three Hundred Seventy-five
23 Dollars (\$1,501,375.00) is authorized to be transferred from the
24 Crime Victims Compensation Revolving Fund, created by Section 142.17

1 of Title 21 of the Oklahoma Statutes, to the District Attorneys
2 Council for duties to support Victim-witness Services.

3 SECTION 115. The Supreme Court is hereby authorized to expend
4 during the fiscal year ending June 30, 2019, from the State Judicial
5 Revolving Fund of the State Treasury, the sum of Forty Million
6 Dollars (\$40,000,000.00) or so much thereof as may be necessary for
7 the financial support of the District Courts.

8 SECTION 116. There is hereby appropriated to the Supreme Court
9 from any monies not otherwise appropriated from the General Revenue
10 Fund of the State Treasury for the fiscal year ending June 30, 2019,
11 the sum of Fourteen Million Four Hundred Twenty-two Thousand Six
12 Hundred Thirteen Dollars (\$14,422,613.00) or so much thereof as may
13 be necessary to perform the duties imposed upon the District Courts
14 by law.

15 SECTION 117. There is hereby appropriated to the Oklahoma
16 Indigent Defense System from any monies not otherwise appropriated
17 from the General Revenue Fund of the State Treasury for the fiscal
18 year ending June 30, 2019, the sum of Seventeen Million One Hundred
19 Twenty-eight Thousand Six Hundred Thirty-three Dollars
20 (\$17,128,633.00) or so much thereof as may be necessary to perform
21 the duties imposed upon the Oklahoma Indigent Defense System by law.

22 SECTION 118. There is hereby appropriated to the Pardon and
23 Parole Board from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2019, the sum of Two Million Three Hundred Thirty-
2 three Thousand One Hundred Fifty-four Dollars (\$2,333,154.00) or so
3 much thereof as may be necessary to perform the duties imposed upon
4 the Pardon and Parole Board by law.

5 SECTION 119. There is hereby appropriated to the Supreme Court
6 from any monies not otherwise appropriated from the General Revenue
7 Fund of the State Treasury for the fiscal year ending June 30, 2019,
8 the sum of Eight Million One Hundred Ninety-eight Thousand Two
9 Hundred Twenty-three Dollars (\$8,198,223.00) or so much thereof as
10 may be necessary to perform the duties imposed upon the Supreme
11 Court or Court of Civil Appeals by law.

12 SECTION 120. The Supreme Court is hereby authorized to expend
13 during the fiscal year ending June 30, 2019, from the State Judicial
14 Revolving Fund of the State Treasury, the sum of Six Million Five
15 Hundred Thousand Dollars (\$6,500,000.00) or so much thereof as may
16 be necessary for the financial support of the Supreme Court or Court
17 of Civil Appeals.

18 SECTION 121. There is hereby appropriated to the Special Cash
19 Fund of the State Treasury from any monies not otherwise
20 appropriated from the State Transportation Fund the sum of Forty-
21 seven Million Two Hundred Thirty Thousand Five Hundred Dollars
22 (\$47,230,500.00) for availability of appropriation.

23 SECTION 122. There is hereby appropriated to the Special Cash
24 Fund of the State Treasury from any monies not otherwise

1 appropriated from the Ethics Commission Fund (200 Fund) the sum of
2 Seven Hundred Ten Thousand Three Hundred Fifty-one Dollars
3 (\$710,351.00) for availability of appropriation.

4 SECTION 123. There is hereby appropriated to the Special Cash
5 Fund of the State Treasury from any monies not otherwise
6 appropriated from the CMIA Revolving Fund (250 Fund) of the Office
7 of Management and Enterprise Services, the sum of Four Hundred
8 Twenty-four Thousand Five Hundred Ninety-five Dollars (\$424,595.00)
9 for availability of appropriation.

10 SECTION 124. There is hereby appropriated to the Special Cash
11 Fund of the State Treasury from any monies not otherwise
12 appropriated from the Unclaimed Property Fund (711 Fund) the sum of
13 Eighteen Million Dollars (\$18,000,000.00) for availability of
14 appropriation.

15 SECTION 125. There is hereby appropriated to the Special Cash
16 Fund of the State Treasury from any monies not otherwise
17 appropriated from the State Insurance Commissioner Revolving Fund
18 (200 Fund) the sum of Six Million Dollars (\$6,000,000.00) for
19 availability of appropriation.

20 SECTION 126. There is hereby appropriated to the Special Cash
21 Fund of the State Treasury from any monies not otherwise
22 appropriated from the Revolving Fund for the Office of the Secretary
23 of State (200 Fund) the sum of Eight Million Dollars (\$8,000,000.00)
24 for availability of appropriation.

1 SECTION 127. There is hereby appropriated to the Special Cash
2 Fund of the State Treasury from any monies not otherwise
3 appropriated from the State Highway Construction and Maintenance
4 Fund (Fund 310) the sum of Eighty Million Dollars (\$80,000,000.00)
5 for availability of appropriation.

6 SECTION 128. There is hereby appropriated to the Special Cash
7 Fund of the State Treasury from any monies not otherwise
8 appropriated from the Oklahoma Railroad Maintenance Revolving Fund
9 (Fund 210) the sum of Twelve Million Dollars (\$12,000,000.00) for
10 availability of appropriation.

11 SECTION 129. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Special Cash Fund of the State Treasury the sum of Ninety-two
14 Million Seven Hundred Thousand Dollars (\$92,700,000.00) to be
15 transferred to the Ad Valorem Reimbursement Fund, created pursuant
16 to Section 193 of Title 62 of the Oklahoma Statutes, for the purpose
17 of reimbursing counties for school districts that claim a loss of
18 revenue due to a tax exemption granted pursuant to the provisions of
19 Section 6B of Article X of the Oklahoma Constitution.

20 SECTION 130. REAPPROPRIATION The amount of Four Hundred
21 Ninety-five Thousand Six Hundred Sixty-four Dollars (\$495,664.00)
22 originally appropriated to the State Board of Career and Technology
23 Education from the Oklahoma Education Lottery Trust Fund of the
24 State Treasury for the fiscal year ending June 30, 2016, by Section

1 20, Chapter 348, O.S.L. 2015, is hereby continued and reappropriated
2 in the current amount and for the original purpose, as adjusted for
3 transfer, less any amount that has been expended upon the effective
4 date of this act.

5 SECTION 131. There is hereby appropriated to the Office of
6 Management and Enterprise Services from any monies not otherwise
7 appropriated from the Special Cash Fund of the State Treasury, the
8 sum of Thirty Thousand Dollars (\$30,000.00) or so much thereof as
9 may be necessary to perform the duties related to Governor's Office
10 transition imposed upon the Office of Management and Enterprise
11 Services by law.

12 SECTION 132. There is hereby appropriated to the Office of
13 Management and Enterprise Services from any monies not otherwise
14 appropriated from the Special Cash Fund of the State Treasury, the
15 sum of Five Million Six Hundred Thousand Dollars (\$5,600,000.00) or
16 so much thereof as may be necessary to reconcile costs associated
17 with the funding of state pension systems.

18 SECTION 133. There is hereby appropriated to the Oklahoma Quick
19 Action Closing Fund from any monies not otherwise appropriated from
20 the Special Cash Fund of the State Treasury, the sum of Four Million
21 Dollars (\$4,000,000.00) to be budgeted and expended by the Governor
22 as authorized by law.

23 SECTION 134. There is hereby appropriated to the Office of
24 Management and Enterprise Services from any monies not otherwise

1 appropriated from the Special Cash Fund of the State Treasury, the
2 sum of Thirteen Million Eight Hundred Sixty-four Thousand Six
3 Hundred Sixty-two Dollars (\$13,864,662.00) or so much thereof as may
4 be necessary to perform the duties imposed upon the Office of
5 Management and Enterprise Services by law.

6 SECTION 135. There is hereby appropriated to the Department of
7 Corrections from any monies not otherwise appropriated from the
8 Special Cash Fund of the State Treasury, the sum of Eight Million
9 Seven Hundred Fifty Thousand Dollars (\$8,750,000.00) or so much
10 thereof as may be necessary to perform the duties imposed upon the
11 Department of Corrections by law.

12 SECTION 136. There is hereby appropriated to the State
13 Emergency Fund created pursuant to Section 139.42 of Title 62 of the
14 Oklahoma Statutes from any monies not otherwise appropriated from
15 the Special Cash Fund of the State Treasury, the sum of Four Million
16 Dollars (\$4,000,000.00), or so much thereof as may be necessary for
17 matching federal disaster funds and for other disaster-related
18 assistance.

19 SECTION 137. REPEALER Sections 1 through 18 of Enrolled
20 House Bill No. 3705 of the 2nd Session of the 56th Oklahoma
21 Legislature, are hereby repealed.

22 SECTION 138. REPEALER Sections 2 and 3 of Enrolled House
23 Bill No. 1022XX of the 2nd Extraordinary Session of the 56th
24 Oklahoma Legislature, are hereby repealed.

1 SECTION 139. Sections 1 through 123 and 130 through 133 of this
2 act shall become effective July 1, 2018.

3 SECTION 140. Sections 127 through 129 of this act shall become
4 effective June 15, 2018.
