7 An Act relating to the County Community Safety
8 Investment Fund; amending Section 2, State Question
9 No. 781, Initiative Petition No. 405, as adopted on
10 November 8, 2016, which relates to administration;
11 transferring certain authority to the Department of
12 Mental Health and Substance Abuse Services; directing
13 promulgation of rules; providing an effective date;
14 and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY Section 2, State Question No. 781,
17 Initiative Petition No. 405, as adopted on November 8, 2016, is
18 amended to read as follows:

19 Section 631. A. There is hereby created in the State Treasury
20 a revolving fund to be designated the "County Community Safety
21 Investment Fund". The fund shall be a continuing fund, not subject
22 to fiscal year limitations, and shall consist of all monies received
23 pursuant to Section 633 of ~~Title 57 of the Oklahoma Statutes~~ this
24 title.

25 B. All monies appropriated and accruing to the credit of the
26 fund shall be budgeted and expended by the ~~Office of Management and~~

1 ~~Enterprise Services~~ Department of Mental Health and Substance Abuse
2 Services for the sole purpose of providing funds to ~~counties to~~
3 ~~provide~~ community rehabilitative programming, including but not
4 limited to mental health and substance abuse services within the
5 counties. Funds shall be disbursed in proportion to county
6 population, as reported in the most recent census.

7 C. Expenditures from the fund shall be made upon warrants
8 issued by the State Treasurer against claims filed as prescribed by
9 law with the Director of the Office of Management and Enterprise
10 Services for approval and payment.

11 D. ~~The Director of the Office of Management and Enterprise~~
12 ~~Services~~ The Commissioner of Mental Health and Substance Abuse
13 Services shall promulgate rules necessary to implement the
14 provisions of this act.

15 SECTION 2. This act shall become effective July 1, 2017.

16 SECTION 3. It being immediately necessary for the preservation
17 of the public peace, health or safety, an emergency is hereby
18 declared to exist, by reason whereof this act shall take effect and
19 be in full force from and after its passage and approval.
