The Department of Rehabilitation Services may direct all or a portion of federal and state funds received and appropriated for services to Older Individuals that are Blind (OIB) to qualified community-based, non-profit organizations accredited by the National Accreditation Council For Blind and Low Vision to administer, pursuant to contract, services for older individuals with vision impairments including, but not limited to, assisting in correcting or modifying visual disabilities including optical vision aids, inhome training, orientation and mobility, Braille instruction, adaptive skills training, information and referral, peer counseling and other appropriate services designed to assist an older individual who is blind with daily living activities.
- C. Funds received by the Commission for OIB Rehabilitation

 Services from the Federal Rehabilitation Services Administration and state matching funds may, in their entirety, be used to fund the
