2 Department of Human Services, the Office of Juvenile
3 Affairs, the State Department of Rehabilitation
4 Services, the Oklahoma Department of Agriculture,
5 Food, and Forestry, the Oklahoma Department of
6 Commerce, the Rural Economic Action Plan Fund, the
7 Oklahoma Conservation Commission, the Corporation
8 Commission, the Department of Environmental Quality,
9 the Oklahoma Historical Society, the J.M. Davis
10 Memorial Commission, the Department of Labor, the
11 Department of Mines, the Oklahoma Tourism and
12 Recreation Department, the Oklahoma Water Resources
13 Board, the Alcoholic Beverage Laws Enforcement
14 Commission, the Department of Corrections, the
15 Oklahoma State Bureau of Investigation, the Council
16 on Law Enforcement Education and Training, the Board
17 of Medicolegal Investigations, the Oklahoma State
18 Bureau of Narcotics and Dangerous Drugs Control, the
19 Department of Public Safety, the Court of Criminal
20 Appeals, district attorneys and the District
21 Attorneys Council, the Supreme Court, the Oklahoma
22 Indigent Defense System and the Pardon and Parole
23 Board; stating amounts of the appropriations; stating
24 purposes and restrictions; reappropriating and
redesignating certain funds; reappropriating certain
funds; authorizing transfers; and providing an
effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma
Education Lottery Trust Fund from any monies not otherwise
appropriated from the Special Cash Fund of the State Treasury, the
sum of Ten Million One Hundred Forty-four Thousand One Hundred
Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be
necessary pursuant to the provisions of subsection E of Section 713
of Title 3A of the Oklahoma Statutes.

1 SECTION 2. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of One Billion Thirty-six Million Four
5 Hundred Twenty-nine Thousand Four Hundred Thirty-seven Dollars
6 (\$1,036,429,437.00) or so much thereof as may be necessary for the
7 financial support of public schools.

8 SECTION 3. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Education Reform Revolving Fund created in Section 34.89 of Title 62
11 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million
12 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars
13 (\$695,407,138.00) or so much thereof as may be necessary for the
14 financial support of public schools.

15 SECTION 4. The State Board of Education is hereby authorized to
16 expend during the fiscal year ending June 30, 2018, from the Common
17 Education Technology Revolving Fund of the State Treasury, the sum
18 of Forty-seven Million Three Hundred Seventy-two Thousand Two
19 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
20 may be necessary for the financial support of public schools.

21 SECTION 5. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 Mineral Leasing Fund of the State Treasury for the fiscal year
24 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-

1 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be
2 necessary for the financial support of public schools.

3 SECTION 6. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Mineral Leasing Fund of the State Treasury for the fiscal year
6 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four
7 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as
8 may be necessary for the financial support of public schools.

9 SECTION 7. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Oklahoma Education Lottery Trust Fund of the State Treasury for the
12 fiscal year ending June 30, 2018, the sum of Twenty-five Million
13 Nine Hundred Thirty-nine Thousand Nine Hundred Ten Dollars
14 (\$25,939,910.00) or so much thereof as may be necessary for the
15 financial support of public schools.

16 SECTION 8. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 Oklahoma Education Lottery Trust Fund of the State Treasury for the
19 fiscal year ending June 30, 2016, the sum of Five Million Four
20 Hundred Twenty-nine Thousand Eight Hundred Forty-four Dollars
21 (\$5,429,844.00) or so much thereof as may be necessary for the
22 financial support of public schools.

23 SECTION 9. Notwithstanding any other provision of law, the
24 State Board of Education is hereby authorized to expend during the

1 fiscal year ending June 30, 2018, from the School Consolidation
2 Assistance Fund (260 Fund), the sum of Two Million Five Hundred
3 Thousand Dollars (\$2,500,000.00) or so much thereof as may be
4 necessary for the financial support of public schools.

5 SECTION 10. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of Ninety-two Million Seventy-four
9 Thousand Thirty-three Dollars (\$92,074,033.00) or so much thereof as
10 may be necessary for the support of public schools activities.

11 SECTION 11. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million
15 Three Hundred Twenty Thousand Three Hundred Forty Dollars
16 (\$299,320,340.00) or so much thereof as may be necessary for the
17 Certified Employee Health Benefit Allowance.

18 SECTION 12. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2018, the sum of One Hundred Sixty-three Million
22 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars
23 (\$163,375,627.00) so much thereof as may be necessary for the
24 Support Personnel Health Benefit Allowance.

1 SECTION 13. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of Fifteen Million Six Hundred Eighty-
5 one Thousand One Hundred Five Dollars (\$15,681,105.00) or so much
6 thereof as may be necessary for administrative and support functions
7 of the State Department of Education.

8 SECTION 14. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2018, the sum of Two Million Eight
12 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
13 (\$2,882,213.00) or so much thereof as may be necessary for transfer
14 to the School Consolidation Assistance Fund.

15 SECTION 15. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2016, the sum of Six Hundred Three
19 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
20 thereof as may be necessary for transfer to the School Consolidation
21 Assistance Fund.

22 SECTION 16. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2018, the sum of Two Million Eight
2 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
3 (\$2,882,213.00) or so much thereof as may be necessary for transfer
4 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

5 SECTION 17. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the
8 fiscal year ending June 30, 2016, the sum of Six Hundred Three
9 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
10 thereof as may be necessary for transfer to the Teachers' Retirement
11 System Dedicated Revenue Revolving Fund.

12 SECTION 18. There is hereby appropriated to the Oklahoma Arts
13 Council from any monies not otherwise appropriated from the General
14 Revenue Fund of the State Treasury for the fiscal year ending June
15 30, 2018, the sum of Two Million Seven Hundred Ninety-five Thousand
16 One Hundred Eighty-one Dollars (\$2,795,181.00) or so much thereof as
17 may be necessary to perform the duties imposed upon the Oklahoma
18 Arts Council by law.

19 SECTION 19. There is hereby appropriated to the State Board of
20 Career and Technology Education from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2018, the sum of One Hundred Eight
23 Million One Hundred Eighty-one Thousand Four Hundred Seventy-seven
24 Dollars (\$108,181,477.00) or so much thereof as may be necessary to

1 perform the duties imposed upon the State Board of Career and
2 Technology Education by law.

3 SECTION 20. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2018, the sum of
7 Three Million One Hundred Seventy Thousand Four Hundred Thirty-three
8 Dollars (\$3,170,433.00) pursuant to paragraph 2 of subsection C of
9 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
10 the State Board of Career and Technology Education for the education
11 and general operating budgets of the institutions and for other
12 programs, construction, renovations or repairs administered by the
13 State Board of Career and Technology Education.

14 SECTION 21. There is hereby appropriated to the State Board of
15 Career and Technology Education from any monies not otherwise
16 appropriated from the Oklahoma Education Lottery Trust Fund of the
17 State Treasury for the fiscal year ending June 30, 2016, the sum of
18 Six Hundred Sixty-three Thousand Six Hundred Forty-eight Dollars
19 (\$663,648.00) pursuant to paragraph 2 of subsection C of Section 713
20 of Title 3A of the Oklahoma Statutes for allocation by the State
21 Board of Career and Technology Education for the education and
22 general operating budgets of the institutions and for other
23 programs, construction, renovations or repairs administered by the
24 State Board of Career and Technology Education.

1 SECTION 22. Notwithstanding any other provision of law, the
2 State Board of Career and Technology Education is hereby authorized
3 to expend during the fiscal year ending June 30, 2018, from the
4 State Board of Career and Technology Education Revolving Fund (200
5 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so
6 much thereof as may be necessary to perform the duties imposed upon
7 the State Board of Career and Technology Education by law.

8 SECTION 23. There is hereby appropriated to the Office of
9 Educational Quality and Accountability from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2018, the sum of One Million One
12 Hundred Nineteen Thousand Eight Hundred Ninety-eight Dollars
13 (\$1,119,898.00) or so much thereof as may be necessary to perform
14 the duties imposed upon the Office of Educational Quality and
15 Accountability by law.

16 SECTION 24. There is hereby appropriated to the Office of
17 Educational Quality and Accountability from any monies not otherwise
18 appropriated from the Special Cash Fund of the State Treasury the
19 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
20 thereof as may be necessary to perform the duties imposed upon the
21 Office of Educational Quality and Accountability by law.

22 SECTION 25. There is hereby appropriated to the Oklahoma
23 Educational Television Authority from any monies not otherwise
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2018, the sum of Two Million Six
2 Hundred Ninety-nine Thousand Nine Hundred Twenty-seven Dollars
3 (\$2,699,927.00) or so much thereof as may be necessary to perform
4 the duties imposed upon the Oklahoma Educational Television
5 Authority by law.

6 SECTION 26. There is hereby appropriated to the Oklahoma State
7 Regents for Higher Education from any monies not otherwise
8 appropriated from the General Revenue Fund of the State Treasury for
9 the fiscal year ending June 30, 2018, the sum of Six Hundred Forty-
10 six Million Six Hundred Eighty-two Thousand Three Hundred Ninety-six
11 Dollars (\$646,682,396.00) or so much thereof as may be necessary for
12 allocation by the Oklahoma State Regents for Higher Education
13 pursuant to the provisions of Article XIII-a of the Oklahoma
14 Constitution for the education and general operating budgets of the
15 institutions and for other programs, construction, renovations or
16 repairs administered by the Oklahoma State Regents for Higher
17 Education. Of those funds appropriated, the sum of Three Million
18 Thirteen Thousand One Hundred Thirty-nine Dollars (\$3,013,139.00)
19 shall be transferred to the Oklahoma Tuition Equalization Grant
20 Trust Fund to implement the provisions of the Oklahoma Tuition
21 Equalization Grant Act.

22 SECTION 27. The Oklahoma State Regents for Higher Education are
23 hereby authorized to expend during the fiscal year ending June 30,
24 2018, the sum of Forty-seven Million Three Hundred Seventy-two

1 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
2 Higher Education Capital Revolving Fund of the State Treasury for
3 allocation by the Oklahoma State Regents for Higher Education
4 pursuant to the provisions of Article XIII-a of the Oklahoma
5 Constitution for the education and general operating budgets of the
6 institutions and for other programs, construction, renovations or
7 repairs administered by the Oklahoma State Regents for Higher
8 Education.

9 SECTION 28. The Oklahoma State Regents for Higher Education are
10 hereby authorized to expend during the fiscal year ending June 30,
11 2018, the sum of Forty-seven Million Three Hundred Seventy-two
12 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
13 Oklahoma Student Aid Revolving Fund of the State Treasury for
14 allocation by the Oklahoma State Regents for Higher Education
15 pursuant to the provisions of Article XIII-a of the Oklahoma
16 Constitution for the education and general operating budgets of the
17 institutions and for other programs, construction, renovations or
18 repairs administered by the Oklahoma State Regents for Higher
19 Education.

20 SECTION 29. There is hereby appropriated to the Oklahoma State
21 Regents for Higher Education from any monies not otherwise
22 appropriated from the General Revenue Fund of the State Treasury for
23 the fiscal year ending June 30, 2018, the sum Nine Hundred Seventy
24 Thousand Nine Hundred Forty Dollars (\$970,940.00) or so much thereof

1 as may be necessary for expenditures for concurrent enrollment
2 pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

3 SECTION 30. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2018, the sum of
7 Twenty-two Million Seven Hundred Sixty-nine Thousand Four Hundred
8 Seventy-seven Dollars (\$22,769,477.00) pursuant to paragraph 2 of
9 subsection C of Section 713 of Title 3A of the Oklahoma Statutes for
10 allocation by the Oklahoma State Regents for Higher Education
11 pursuant to the provisions of Article XIII-a of the Oklahoma
12 Constitution for construction, renovations or repairs administered
13 by the Oklahoma State Regents for Higher Education or for any other
14 purpose authorized by paragraph 2 of subsection C of Section 713 of
15 Title 3A of the Oklahoma Statutes.

16 SECTION 31. There is hereby appropriated to the Oklahoma State
17 Regents for Higher Education from any monies not otherwise
18 appropriated from the Oklahoma Education Lottery Trust Fund of the
19 State Treasury for the fiscal year ending June 30, 2016, the sum of
20 Four Million Seven Hundred Sixty-six Thousand One Hundred Ninety-
21 seven Dollars (\$4,766,197.00) pursuant to paragraph 2 of subsection
22 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation
23 by the Oklahoma State Regents for Higher Education pursuant to the
24 provisions of Article XIII-a of the Oklahoma Constitution for

1 construction, renovations or repairs administered by the Oklahoma
2 State Regents for Higher Education or for any other purpose
3 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
4 of the Oklahoma Statutes.

5 SECTION 32. There is hereby appropriated to the Oklahoma State
6 Regents for Higher Education from any monies not otherwise
7 appropriated from the General Revenue Fund of the State Treasury for
8 the fiscal year ending June 30, 2018, the sum of Three Million Six
9 Hundred Sixty-four Thousand Fifty-two Dollars (\$3,664,052.00) or so
10 much thereof as may be necessary for the general operating budget of
11 the Administrative Offices of the Oklahoma State Regents for Higher
12 Education.

13 SECTION 33. There is hereby appropriated to the Commissioners
14 of the Land Office from any monies not otherwise appropriated from
15 the Commissioners of the Land Office Fund of the State Treasury for
16 the fiscal year ending June 30, 2018, the sum of Eight Million Five
17 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or
18 so much thereof as may be necessary to perform the duties imposed
19 upon the Commissioners of the Land Office by law.

20 SECTION 34. There is hereby appropriated to the Oklahoma
21 Department of Libraries from any monies not otherwise appropriated
22 from the General Revenue Fund of the State Treasury for the fiscal
23 year ending June 30, 2018, the sum of Four Million Three Hundred
24 Eighty-six Thousand Seven Hundred Eighty Dollars (\$4,386,780.00) or

1 so much thereof as may be necessary to perform the duties imposed
2 upon the Oklahoma Department of Libraries by law.

3 SECTION 35. There is hereby appropriated to the Physician
4 Manpower Training Commission from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2018, the sum of Two Million Nine
7 Hundred Fourteen Thousand Eight Hundred Forty Dollars
8 (\$2,914,840.00) or so much thereof as may be necessary to perform
9 the duties imposed upon the Physician Manpower Training Commission
10 by law.

11 SECTION 36. There is hereby appropriated to the Physician
12 Manpower Training Commission from any monies not otherwise
13 appropriated from the Special Cash Fund of the State Treasury the
14 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
15 thereof as may be necessary to perform the duties imposed upon the
16 Physician Manpower Training Commission by law.

17 SECTION 37. There is hereby appropriated to the Board of
18 Trustees of the Oklahoma School of Science and Mathematics from any
19 monies not otherwise appropriated from the General Revenue Fund of
20 the State Treasury for the fiscal year ending June 30, 2018, the sum
21 of Six Million One Hundred Twenty-one Thousand Seven Hundred Nine
22 Dollars (\$6,121,709.00) or so much thereof as may be necessary to
23 perform the duties imposed upon the Board of Trustees of the
24 Oklahoma School of Science and Mathematics by law.

1 SECTION 38. There is hereby appropriated to the Oklahoma Center
2 for the Advancement of Science and Technology from any monies not
3 otherwise appropriated from the General Revenue Fund of the State
4 Treasury for the fiscal year ending June 30, 2018, the sum of
5 Thirteen Million Four Hundred Twenty-two Thousand Eight Hundred
6 Ninety-two Dollars (\$13,422,892.00) or so much thereof as may be
7 necessary to perform the duties imposed upon the Oklahoma Center for
8 the Advancement of Science and Technology by law. Of those funds
9 appropriated, the sum of Five Million Three Hundred Sixty-nine
10 Thousand One Hundred Fifty-seven Dollars (\$5,369,157.00) shall be
11 deposited in the Research Support Revolving Fund, created pursuant
12 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those
13 funds appropriated, the sum of Two Million Nine Hundred Fifty-three
14 Thousand Thirty-six Dollars (\$2,953,036.00) shall be deposited in
15 the Seed-capital Revolving Fund, created pursuant to Section 5060.21
16 of Title 74 of the Oklahoma Statutes.

17 GENERAL GOVERNMENT AND TRANSPORTATION

18 SECTION 39. There is hereby appropriated to the Office of the
19 Attorney General from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2018, the sum of Nine Million One Hundred Sixty-four
22 Thousand Four Hundred Fifty-nine Dollars (\$9,164,459.00) or so much
23 thereof as may be necessary to perform the duties imposed upon the
24 Office of the Attorney General by law.

1 SECTION 40. There is hereby appropriated to the Office of the
2 Attorney General from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of Nine Hundred Four Thousand Seven
5 Hundred Twenty-six Dollars (\$904,726.00) to transfer to the Legal
6 Services Revolving Fund, created pursuant to subsection G of Section
7 921.1 of Title 12 of the Oklahoma Statutes.

8 SECTION 41. REAPPROPRIATION AND REDESIGNATION The amount
9 of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) of the
10 original appropriation of Five Million Dollars (\$5,000,000.00),
11 appropriated to the Office of the Attorney General by Section 154,
12 Chapter 311, O.S.L. 2012, from any monies not otherwise appropriated
13 from the Special Cash Fund of the State Treasury, for the
14 prosecution and defense of claims related to water and water rights
15 in Oklahoma, is hereby reappropriated and redesignated to perform
16 the duties imposed upon the Office of the Attorney General by law.
17 If, on the date this act is approved, any of the amount originally
18 appropriated, as adjusted by expenditures, encumbrances and
19 transfers, results in an unencumbered balance less than the
20 reappropriated and redesignated amount, that reappropriated and
21 redesignated amount is reduced to the unencumbered amount.

22 SECTION 42. For the fiscal year ending June 30, 2018, the
23 Office of the Attorney General is authorized to transfer an amount
24 not to exceed Three Hundred Twenty Thousand Four Hundred Thirty

14 SECTION 169. There is hereby appropriated to the Department of
15 Public Safety from any monies not otherwise appropriated from the
16 Special Cash Fund of the State Treasury, the sum of Five Million
17 Dollars (\$5,000,000.00) or so much thereof as may be necessary to
18 perform the duties imposed upon the Department of Public Safety by
19 law.

20 SECTION 170. Sections 2 through 165 of this act shall become
21 effective July 1, 2017.
