6 An Act relating to criminal justice reform; creating
7 a task force to study the sentencing throughout the
8 criminal justice process in the state; providing
9 expiration date; setting duties; providing for
10 membership; providing for naming of chair; providing
11 for quorum; providing for frequency of meetings;
12 subjecting meetings to the Oklahoma Open Meeting Act;
13 providing that members receive no compensation or
14 travel reimbursement; providing for staff support;
15 requiring certain report; providing for
16 noncodification; providing an effective date; and
17 declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law not to be
22 codified in the Oklahoma Statutes reads as follows:

23 A. There is hereby created until December 31, 2019, a task
24 force to oversee an assessment and analysis of existing laws,
policies and practices relating to sentencing throughout the
criminal justice process.

B. The task force shall submit a report of its findings and
recommendations by November 30, 2019, to the Governor, the President
Pro Tempore of the Senate and the Speaker of the House of
Representatives, which shall include, but not be limited to:

1 1. Recommendations on sentencing and sentence enhancements;

2 2. Recommendations designed to reduce recidivism and to
3 increase success for those people under probation and parole
4 supervision; and

5 3. Recommendations to improve access to reliable data to better
6 inform policy and practice.

7 C. The task force shall be comprised of thirteen (13) members
8 to be appointed as follows:

9 1. Four members appointed by the Governor as follows:

10 a. a member who is a representative of county government
11 in a county with a population over three hundred
12 thousand (300,000),

13 b. a member who is a representative of a chamber of
14 commerce,

15 c. a member who is a mental health professional, and

16 d. a member representing law enforcement or the
17 Department of Corrections;

18 2. Three members appointed by the President Pro Tempore of the
19 Senate as follows:

20 a. a member who is a currently elected member of the
21 Senate,

22 b. a member who is a public defender, and

1 c. a member who is a representative of county government
2 in a county with a population of less than three
3 hundred thousand (300,000);

4 3. Three members appointed by the Speaker of the House of
5 Representatives as follows:

6 a. a member who is a currently elected member of the
7 House of Representatives,

8 b. a member representing the District Attorneys Council,
9 and

10 c. a member representing an organized group advocating
11 for victims of crime;

12 4. The Administrative Director of the Court;

13 5. The Oklahoma Attorney General or designee; and

14 6. A district judge appointed by the Oklahoma Supreme Court
15 Chief Justice.

16 The Chair of the task force shall be selected by the Governor.

17 D. A quorum of the task force shall be required to approve any
18 final action of the task force. For purposes of this section, seven
19 (7) members shall constitute a quorum.

20 E. The task force may meet as often as may be required in order
21 to perform the duties imposed upon it. The chair shall call the
22 first meeting and all subsequent meetings shall be made at the call
23 of the chair.

1 F. The meetings of the task force shall be subject to the
2 Oklahoma Open Meeting Act.

3 G. The members of the task force shall receive no compensation
4 or travel reimbursement.

5 H. Staff support shall be provided by the Governor's office,
6 the Senate and the House of Representatives.

7 SECTION 2. This act shall become effective July 1, 2018.

8 SECTION 3. It being immediately necessary for the preservation
9 of the public peace, health or safety, an emergency is hereby
10 declared to exist, by reason whereof this act shall take effect and
11 be in full force from and after its passage and approval.
