7 A Concurrent Resolution relating to legislative
8 procedures; establishing a legislative procedure
9 schedule for the 57th Oklahoma Legislature.
10

11 BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION OF THE 56TH OKLAHOMA
12 LEGISLATURE, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

13 THAT the First Regular Session of the 57th Oklahoma Legislature
14 shall adhere to the following procedure schedule:

15 1. The First Regular Session of the 57th Oklahoma Legislature
16 shall convene at twelve noon on January 8, 2019, for the purposes
17 only of performing the duties set forth in Section 5 of Article VI
18 of the Oklahoma Constitution and organizing pursuant to the
19 provisions of Article V of the Oklahoma Constitution, and shall
20 recess no later than five p.m. on that same day until February 4,
21 2019, beginning at twelve noon.

22 2. December 7, 2018, shall be the final date for requesting the
23 drafting of bills and joint resolutions in the Senate and House of

1 Representatives for introduction for consideration during the First
2 Regular Session.

3 3. January 17, 2019, no later than 4:00 p.m., shall be the
4 deadline for introduction of bills and joint resolutions in the
5 Senate and House of Representatives for consideration on the floor
6 of the Senate or House during the First Regular Session. Bills and
7 joint resolutions subsequently introduced, if reported from
8 Committee, shall not be placed on the Calendar for consideration in
9 said house until the first legislative day of the Second Regular
10 Session.

11 4. March 14, 2019, shall be the final legislative day for third
12 reading and final passage of a bill or joint resolution in the house
13 of origin.

14 5. April 25, 2019, shall be the final legislative day for third
15 reading and final passage of a bill or joint resolution in the house
16 opposite the house of origin.

17 6. The First Regular Session shall adjourn sine die not later
18 than five p.m. on May 31, 2019.

19 7. Upon a two-thirds (2/3) vote of the membership of or
20 pursuant to joint rules adopted by both chambers, a bill or joint
21 resolution can be exempt from all deadline dates in both chambers.
22 Upon a two-thirds (2/3) vote of the membership of or pursuant to
23 rules adopted by a single chamber, a bill or joint resolution can be
24 exempt from all deadline dates in that chamber only.

1 THAT the Second Regular Session of the 57th Oklahoma Legislature
2 shall adhere to the following procedure schedule:

3 1. December 13, 2019, shall be the final date for requesting
4 the drafting of bills and joint resolutions in the Senate and House
5 of Representatives for introduction for consideration during the
6 Second Regular Session.

7 2. January 16, 2020, no later than 4:00 p.m., shall be the
8 deadline for introduction of bills and joint resolutions in the
9 Senate and House of Representatives for consideration on the floor
10 of the Senate or House during the Second Regular Session.

11 3. The Second Regular Session of the 57th Oklahoma Legislature
12 shall convene at twelve noon on February 3, 2020.

13 4. March 12, 2020, shall be the final legislative day for third
14 reading and final passage of a bill or joint resolution in the house
15 of origin.

16 5. April 23, 2020, shall be the final legislative day for third
17 reading and final passage of a bill or joint resolution in the house
18 opposite the house of origin.

19 6. The Second Regular Session shall adjourn sine die not later
20 than five p.m. on May 29, 2020.

21 7. Upon a two-thirds (2/3) vote of the membership of or
22 pursuant to joint rules adopted by both chambers, a bill or joint
23 resolution can be exempt from all deadline dates in both chambers.
24 Upon a two-thirds (2/3) vote of the membership of or pursuant to

1 rules adopted by a single chamber, a bill or joint resolution can be
2 exempt from all deadline dates in that chamber only.

3 THAT this schedule shall be inapplicable to any joint resolution
4 introduced for the purpose of disapproving or approving agency rules
5 pursuant to the provisions of the Administrative Procedures Act.

6 THAT this schedule shall be inapplicable to any bills introduced
7 for the purposes of incorporation and merging different versions of
8 a statute amended in more than one measure at the same or different
9 sessions of the Legislature as set forth in Section 23.1 of Title 75
10 of the Oklahoma Statutes.

11 THAT this schedule shall be inapplicable to any bill or joint
12 resolution introduced for the purpose of approving, disapproving,
13 repealing or modifying rules of the Ethics Commission pursuant to
14 the provisions of Section 3 of Article XXIX of the Oklahoma
15 Constitution.

16 THAT this schedule shall be inapplicable to any bill or joint
17 resolution which proposes a special or local law and for which
18 notice of intended introduction is published in a newspaper for four
19 (4) consecutive weeks pursuant to the provisions of Section 32 of
20 Article V of the Oklahoma Constitution.

21 THAT the dates specified in this resolution for introduction of
22 bills or joint resolutions shall be inapplicable to any bill or
23 joint resolution which contains an "RB" number pursuant to the
24 provisions of the Oklahoma Pension Legislation Actuarial Analysis

1 Act. Such measures shall be submitted to the legislative actuary
2 not later than such dates, and may be introduced not later than the
3 first Monday in February following such submission.

4 THAT this schedule shall be inapplicable to any bill or joint
5 resolution authored by the chairs and vice-chairs of the Senate
6 Appropriations Committee and the House Appropriations and Budget
7 Committee which affects the receipt, expenditure or budgeting of
8 state funds or funds under the control of an entity created by state
9 law.

10 THAT this schedule shall be inapplicable to any bill or joint
11 resolution authored by the President Pro Tempore of the Senate or
12 the Speaker of the House of Representatives which is deemed by them
13 to be necessary for the preservation of public peace, health or
14 safety.
