11 making appropriations to the Oklahoma Education
12 Lottery Trust Fund, State Board of Education, the

14 Technology Education, the Office of Educational
15 Quality and Accountability, the Oklahoma Educational
16 Television Authority, the Oklahoma State Regents for
17 Higher Education, the Commissioners of the Land

19 Physician Manpower Training Commission, the Board of
20 Trustees of the Oklahoma School of Science and
21 Mathematics, the Oklahoma Center for the Advancement
22 of Science and Technology, the Office of the Attorney
23 General, the Office of the State Auditor and
24 Inspector, the State Election Board, the Oklahoma
Department of Emergency Management, the Ethics
Commission, the Office of the Governor, the Oklahoma
House of Representatives, the Legislative Service
Bureau, the Office of the Lieutenant Governor, the
Office of Management and Enterprise Services, the
Oklahoma Merit Protection Commission, the Military
Department of the State of Oklahoma, the Oklahoma
State Senate, the Oklahoma Tax Commission, the Office
of the State Treasurer, the Oklahoma Space Industry
Development Authority, the Department of
Transportation, the State Department of Health, the
Oklahoma Health Care Authority, the J.D. McCarty
Center for Children with Developmental Disabilities,
the Department of Mental Health and Substance Abuse
Services, the Oklahoma State University Medical
Authority, the University Hospitals Authority, the

Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Disability Concerns, the Department of Human Services, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Department of Commerce, the Rural Economic Action Plan Fund, the Oklahoma Conservation Commission, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Court of Criminal Appeals, district attorneys and the District Attorneys Council, the Supreme Court, the Oklahoma Indigent Defense System and the Pardon and Parole Board; stating amounts of the appropriations; stating purposes and restrictions; reappropriating and redesignating certain funds; reappropriating certain funds; authorizing transfers; and repealing Sections 1 through 169, Chapter 371, O.S.L. 2017, which relate to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma Education Lottery Trust Fund from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the

1 sum of Ten Million One Hundred Forty-four Thousand One Hundred
2 Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be
3 necessary pursuant to the provisions of subsection E of Section 713
4 of Title 3A of the Oklahoma Statutes.

5 SECTION 2. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of One Billion Thirty-six Million Four
9 Hundred Twenty-nine Thousand Four Hundred Thirty-seven Dollars
10 (\$1,036,429,437.00) or so much thereof as may be necessary for the
11 financial support of public schools.

12 SECTION 3. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Education Reform Revolving Fund created in Section 34.89 of Title 62
15 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million
16 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars
17 (\$695,407,138.00) or so much thereof as may be necessary for the
18 financial support of public schools.

19 SECTION 4. The State Board of Education is hereby authorized to
20 expend during the fiscal year ending June 30, 2018, from the Common
21 Education Technology Revolving Fund of the State Treasury, the sum
22 of Forty-seven Million Three Hundred Seventy-two Thousand Two
23 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
24 may be necessary for the financial support of public schools.

1 SECTION 5. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Mineral Leasing Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-
5 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be
6 necessary for the financial support of public schools.

7 SECTION 6. There is hereby appropriated to the State Board of
8 Education from any monies not otherwise appropriated from the
9 Mineral Leasing Fund of the State Treasury for the fiscal year
10 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four
11 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as
12 may be necessary for the financial support of public schools.

13 SECTION 7. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the
16 fiscal year ending June 30, 2018, the sum of Twenty-five Million
17 Nine Hundred Thirty-nine Thousand Nine Hundred Ten Dollars
18 (\$25,939,910.00) or so much thereof as may be necessary for the
19 financial support of public schools.

20 SECTION 8. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the
23 fiscal year ending June 30, 2016, the sum of Five Million Four
24 Hundred Twenty-nine Thousand Eight Hundred Forty-four Dollars

1 (\$5,429,844.00) or so much thereof as may be necessary for the
2 financial support of public schools.

3 SECTION 9. Notwithstanding any other provision of law, the
4 State Board of Education is hereby authorized to expend during the
5 fiscal year ending June 30, 2018, from the School Consolidation
6 Assistance Fund (260 Fund), the sum of Two Million Five Hundred
7 Thousand Dollars (\$2,500,000.00) or so much thereof as may be
8 necessary for the financial support of public schools.

9 SECTION 10. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2018, the sum of Ninety-two Million Seventy-four
13 Thousand Thirty-three Dollars (\$92,074,033.00) or so much thereof as
14 may be necessary for the support of public schools activities.

15 SECTION 11. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 General Revenue Fund of the State Treasury for the fiscal year
18 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million
19 Three Hundred Twenty Thousand Three Hundred Forty Dollars
20 (\$299,320,340.00) or so much thereof as may be necessary for the
21 Certified Employee Health Benefit Allowance.

22 SECTION 12. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2018, the sum of One Hundred Sixty-three Million
2 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars
3 (\$163,375,627.00) so much thereof as may be necessary for the
4 Support Personnel Health Benefit Allowance.

5 SECTION 13. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of Fifteen Million Six Hundred Eighty-
9 one Thousand One Hundred Five Dollars (\$15,681,105.00) or so much
10 thereof as may be necessary for administrative and support functions
11 of the State Department of Education.

12 SECTION 14. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the
15 fiscal year ending June 30, 2018, the sum of Two Million Eight
16 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
17 (\$2,882,213.00) or so much thereof as may be necessary for transfer
18 to the School Consolidation Assistance Fund.

19 SECTION 15. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the
22 fiscal year ending June 30, 2016, the sum of Six Hundred Three
23 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
24

1 thereof as may be necessary for transfer to the School Consolidation
2 Assistance Fund.

3 SECTION 16. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2018, the sum of Two Million Eight
7 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
8 (\$2,882,213.00) or so much thereof as may be necessary for transfer
9 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

10 SECTION 17. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the
13 fiscal year ending June 30, 2016, the sum of Six Hundred Three
14 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
15 thereof as may be necessary for transfer to the Teachers' Retirement
16 System Dedicated Revenue Revolving Fund.

17 SECTION 18. There is hereby appropriated to the Oklahoma Arts
18 Council from any monies not otherwise appropriated from the General
19 Revenue Fund of the State Treasury for the fiscal year ending June
20 30, 2018, the sum of Two Million Seven Hundred Twenty-seven Thousand
21 Forty-two Dollars (\$2,727,042.00) or so much thereof as may be
22 necessary to perform the duties imposed upon the Oklahoma Arts
23 Council by law.

1 SECTION 19. There is hereby appropriated to the State Board of
2 Career and Technology Education from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2018, the sum of One Hundred Five
5 Million Four Hundred Thirty-eight Thousand Six Hundred Seventy-seven
6 Dollars (\$105,438,677.00) or so much thereof as may be necessary to
7 perform the duties imposed upon the State Board of Career and
8 Technology Education by law.

9 SECTION 20. There is hereby appropriated to the State Board of
10 Career and Technology Education from any monies not otherwise
11 appropriated from the Oklahoma Education Lottery Trust Fund of the
12 State Treasury for the fiscal year ending June 30, 2018, the sum of
13 Three Million One Hundred Seventy Thousand Four Hundred Thirty-three
14 Dollars (\$3,170,433.00) pursuant to paragraph 2 of subsection F of
15 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
16 the State Board of Career and Technology Education for the education
17 and general operating budgets of the institutions and for other
18 programs, construction, renovations or repairs administered by the
19 State Board of Career and Technology Education.

20 SECTION 21. There is hereby appropriated to the State Board of
21 Career and Technology Education from any monies not otherwise
22 appropriated from the Oklahoma Education Lottery Trust Fund of the
23 State Treasury for the fiscal year ending June 30, 2016, the sum of
24 Six Hundred Sixty-three Thousand Six Hundred Forty-eight Dollars

1 (\$663,648.00) pursuant to paragraph 2 of subsection F of Section 713
2 of Title 3A of the Oklahoma Statutes for allocation by the State
3 Board of Career and Technology Education for the education and
4 general operating budgets of the institutions and for other
5 programs, construction, renovations or repairs administered by the
6 State Board of Career and Technology Education.

7 SECTION 22. Notwithstanding any other provision of law, the
8 State Board of Career and Technology Education is hereby authorized
9 to expend during the fiscal year ending June 30, 2018, from the
10 State Board of Career and Technology Education Revolving Fund (200
11 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so
12 much thereof as may be necessary to perform the duties imposed upon
13 the State Board of Career and Technology Education by law.

14 SECTION 23. There is hereby appropriated to the Office of
15 Educational Quality and Accountability from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2018, the sum of One Million Ninety-
18 two Thousand Five Hundred Ninety-nine Dollars (\$1,092,599.00) or so
19 much thereof as may be necessary to perform the duties imposed upon
20 the Office of Educational Quality and Accountability by law.

21 SECTION 24. There is hereby appropriated to the Office of
22 Educational Quality and Accountability from any monies not otherwise
23 appropriated from the Special Cash Fund of the State Treasury the
24 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much

1 thereof as may be necessary to perform the duties imposed upon the
2 Office of Educational Quality and Accountability by law.

3 SECTION 25. There is hereby appropriated to the Oklahoma
4 Educational Television Authority from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2018, the sum of Two Million Six
7 Hundred Thirty-four Thousand One Hundred Eleven Dollars
8 (\$2,634,111.00) or so much thereof as may be necessary to perform
9 the duties imposed upon the Oklahoma Educational Television
10 Authority by law.

11 SECTION 26. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the General Revenue Fund of the State Treasury for
14 the fiscal year ending June 30, 2018, the sum of Six Hundred Twenty-
15 nine Million Four Hundred Sixty-three Thousand Five Hundred Six
16 Dollars (\$629,463,506.00) or so much thereof as may be necessary for
17 allocation by the Oklahoma State Regents for Higher Education
18 pursuant to the provisions of Article XIII-A of the Oklahoma
19 Constitution for the education and general operating budgets of the
20 institutions and for other programs, construction, renovations or
21 repairs administered by the Oklahoma State Regents for Higher
22 Education. Of those funds appropriated, the sum of Three Million
23 Thirteen Thousand One Hundred Thirty-nine Dollars (\$3,013,139.00)
24 shall be transferred to the Oklahoma Tuition Equalization Grant

1 Trust Fund to implement the provisions of the Oklahoma Tuition
2 Equalization Grant Act.

3 SECTION 27. The Oklahoma State Regents for Higher Education are
4 hereby authorized to expend during the fiscal year ending June 30,
5 2018, the sum of Forty-seven Million Three Hundred Seventy-two
6 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
7 Higher Education Capital Revolving Fund of the State Treasury for
8 allocation by the Oklahoma State Regents for Higher Education
9 pursuant to the provisions of Article XIII-A of the Oklahoma
10 Constitution for the education and general operating budgets of the
11 institutions and for other programs, construction, renovations or
12 repairs administered by the Oklahoma State Regents for Higher
13 Education.

14 SECTION 28. The Oklahoma State Regents for Higher Education are
15 hereby authorized to expend during the fiscal year ending June 30,
16 2018, the sum of Forty-seven Million Three Hundred Seventy-two
17 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
18 Oklahoma Student Aid Revolving Fund of the State Treasury for
19 allocation by the Oklahoma State Regents for Higher Education
20 pursuant to the provisions of Article XIII-A of the Oklahoma
21 Constitution for the education and general operating budgets of the
22 institutions and for other programs, construction, renovations or
23 repairs administered by the Oklahoma State Regents for Higher
24 Education.

1 SECTION 29. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2018, the sum Nine Hundred Forty-
5 five Thousand Eighty-seven Dollars (\$945,087.00) or so much thereof
6 as may be necessary for expenditures for concurrent enrollment
7 pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

8 SECTION 30. There is hereby appropriated to the Oklahoma State
9 Regents for Higher Education from any monies not otherwise
10 appropriated from the Oklahoma Education Lottery Trust Fund of the
11 State Treasury for the fiscal year ending June 30, 2018, the sum of
12 Twenty-two Million Seven Hundred Sixty-nine Thousand Four Hundred
13 Seventy-seven Dollars (\$22,769,477.00) pursuant to paragraph 2 of
14 subsection F of Section 713 of Title 3A of the Oklahoma Statutes for
15 allocation by the Oklahoma State Regents for Higher Education
16 pursuant to the provisions of Article XIII-A of the Oklahoma
17 Constitution for construction, renovations or repairs administered
18 by the Oklahoma State Regents for Higher Education or for any other
19 purpose authorized by paragraph 2 of subsection F of Section 713 of
20 Title 3A of the Oklahoma Statutes.

21 SECTION 31. There is hereby appropriated to the Oklahoma State
22 Regents for Higher Education from any monies not otherwise
23 appropriated from the Oklahoma Education Lottery Trust Fund of the
24 State Treasury for the fiscal year ending June 30, 2016, the sum of

1 Four Million Seven Hundred Sixty-six Thousand One Hundred Ninety-
2 seven Dollars (\$4,766,197.00) pursuant to paragraph 2 of subsection
3 F of Section 713 of Title 3A of the Oklahoma Statutes for allocation
4 by the Oklahoma State Regents for Higher Education pursuant to the
5 provisions of Article XIII-A of the Oklahoma Constitution for
6 construction, renovations or repairs administered by the Oklahoma
7 State Regents for Higher Education or for any other purpose
8 authorized by paragraph 2 of subsection F of Section 713 of Title 3A
9 of the Oklahoma Statutes.

10 SECTION 32. There is hereby appropriated to the Oklahoma State
11 Regents for Higher Education from any monies not otherwise
12 appropriated from the General Revenue Fund of the State Treasury for
13 the fiscal year ending June 30, 2018, the sum of Three Million Five
14 Hundred Sixty-six Thousand Four Hundred Ninety-one Dollars
15 (\$3,566,491.00) or so much thereof as may be necessary for the
16 general operating budget of the Administrative Offices of the
17 Oklahoma State Regents for Higher Education.

18 SECTION 33. There is hereby appropriated to the Commissioners
19 of the Land Office from any monies not otherwise appropriated from
20 the Commissioners of the Land Office Fund of the State Treasury for
21 the fiscal year ending June 30, 2018, the sum of Eight Million Five
22 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or
23 so much thereof as may be necessary to perform the duties imposed
24 upon the Commissioners of the Land Office by law.

1 SECTION 34. There is hereby appropriated to the Oklahoma
2 Department of Libraries from any monies not otherwise appropriated
3 from the General Revenue Fund of the State Treasury for the fiscal
4 year ending June 30, 2018, the sum of Four Million Two Hundred
5 Seventy-nine Thousand Eight Hundred Forty-three Dollars
6 (\$4,279,843.00) or so much thereof as may be necessary to perform
7 the duties imposed upon the Oklahoma Department of Libraries by law.

8 SECTION 35. There is hereby appropriated to the Physician
9 Manpower Training Commission from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2018, the sum of Two Million Eight
12 Hundred Thirty-four Thousand Thirty-four Dollars (\$2,834,034.00) or
13 so much thereof as may be necessary to perform the duties imposed
14 upon the Physician Manpower Training Commission by law.

15 SECTION 36. There is hereby appropriated to the Physician
16 Manpower Training Commission from any monies not otherwise
17 appropriated from the Special Cash Fund of the State Treasury the
18 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
19 thereof as may be necessary to perform the duties imposed upon the
20 Physician Manpower Training Commission by law.

21 SECTION 37. There is hereby appropriated to the Board of
22 Trustees of the Oklahoma School of Science and Mathematics from any
23 monies not otherwise appropriated from the General Revenue Fund of
24 the State Treasury for the fiscal year ending June 30, 2018, the sum

1 of Six Million One Hundred Twenty-one Thousand Seven Hundred Nine
2 Dollars (\$6,121,709.00) or so much thereof as may be necessary to
3 perform the duties imposed upon the Board of Trustees of the
4 Oklahoma School of Science and Mathematics by law.

5 SECTION 38. There is hereby appropriated to the Oklahoma Center
6 for the Advancement of Science and Technology from any monies not
7 otherwise appropriated from the General Revenue Fund of the State
8 Treasury for the fiscal year ending June 30, 2018, the sum of
9 Thirteen Million Ninety-five Thousand Six Hundred Eighty-one Dollars
10 (\$13,095,681.00) or so much thereof as may be necessary to perform
11 the duties imposed upon the Oklahoma Center for the Advancement of
12 Science and Technology by law. Of those funds appropriated, the sum
13 of Five Million One Hundred Twenty Thousand Two Hundred Eighty
14 Dollars (\$5,120,280.00) shall be deposited in the Research Support
15 Revolving Fund, created pursuant to Section 5060.11 of Title 74 of
16 the Oklahoma Statutes. Of those funds appropriated, the sum of Two
17 Million Eight Hundred Sixteen Thousand One Hundred Fifty-four
18 Dollars (\$2,816,154.00) shall be deposited in the Seed-capital
19 Revolving Fund, created pursuant to Section 5060.21 of Title 74 of
20 the Oklahoma Statutes.

21 GENERAL GOVERNMENT AND TRANSPORTATION

22 SECTION 39. There is hereby appropriated to the Office of the
23 Attorney General from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2018, the sum of Eight Million Nine Hundred Forty-
2 four Thousand Six Hundred Fifty Dollars (\$8,944,650.00) or so much
3 thereof as may be necessary to perform the duties imposed upon the
4 Office of the Attorney General by law.

5 SECTION 40. There is hereby appropriated to the Office of the
6 Attorney General from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of Nine Hundred Four Thousand Seven
9 Hundred Twenty-six Dollars (\$904,726.00) to transfer to the Legal
10 Services Revolving Fund, created pursuant to subsection G of Section
11 921.1 of Title 12 of the Oklahoma Statutes.

12 SECTION 41. REAPPROPRIATION AND REDESIGNATION The amount
13 of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) of the
14 original appropriation of Five Million Dollars (\$5,000,000.00),
15 appropriated to the Office of the Attorney General by Section 154,
16 Chapter 311, O.S.L. 2012, from any monies not otherwise appropriated
17 from the Special Cash Fund of the State Treasury, for the
18 prosecution and defense of claims related to water and water rights
19 in Oklahoma, is hereby reappropriated and redesignated to perform
20 the duties imposed upon the Office of the Attorney General by law.
21 If, on the date this act is approved, any of the amount originally
22 appropriated, as adjusted by expenditures, encumbrances and
23 transfers, results in an unencumbered balance less than the
24

1 reappropriated and redesignated amount, that reappropriated and
2 redesignated amount is reduced to the unencumbered amount.

3 SECTION 42. For the fiscal year ending June 30, 2018, the
4 Office of the Attorney General is authorized to transfer an amount
5 not to exceed Three Hundred Twenty Thousand Four Hundred Thirty
6 Dollars (\$320,430.00) from the Office of the Attorney General's

16 SECTION 93. There is hereby appropriated to the State
17 Department of Rehabilitation Services from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2018, the sum of Twenty-nine Million
20 Five Hundred Sixty-three Thousand Six Hundred Thirty-one Dollars
21 (\$29,563,631.00) or so much thereof as may be necessary to perform
22 the duties imposed upon the State Department of Rehabilitation
23 Services by law.

7 amount that has been expended upon the effective date of this act.

8 SECTION 165. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Special Cash Fund of the State Treasury, the sum of Nine Million
11 Eight Hundred Fifteen Thousand Dollars (\$9,815,000.00) to be
12 transferred to the Ad Valorem Reimbursement Fund, created pursuant
13 to Section 193 of Title 62 of the Oklahoma Statutes, for the purpose
14 of reimbursing counties for school districts that claim a loss of
15 revenue due to a tax exemption granted pursuant to the provisions of

5 may be necessary to perform the duties imposed upon the Oklahoma
6 Historical Society by law.

7 SECTION 168. There is hereby appropriated to the Department of
8 Public Safety from any monies not otherwise appropriated from the
9 Special Cash Fund of the State Treasury, the sum of Five Million
10 Dollars (\$5,000,000.00) or so much thereof as may be necessary to
11 perform the duties imposed upon the Department of Public Safety by
12 law.

13 SECTION 169. There is hereby appropriated to the State
14 Department of Health from any monies not otherwise appropriated from
15 the General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2017, the sum of Thirty Million Dollars
17 (\$30,000,000.00) or so much thereof as may be necessary to perform
18 the duties imposed upon the State Department of Health by law.

19 SECTION 170. Sections 1 through 169, Chapter 371, O.S.L. 2017,
20 are hereby repealed.
