BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

An Act relating to the Oklahoma Health Care

providing an effective date; and declaring an

Authority; making appropriations; stating purposes;

SECTION 1. There is hereby appropriated to the Oklahoma Health Care Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2017, the sum of Thirty-one Million Seven Hundred Seventy Thousand Three Hundred Eleven Dollars (\$31,770,311.00) or so much thereof as may be necessary to replace federal funds withheld due to the deferred federal financial participation expenditures claimed on the Quarterly Medicaid Statement of Expenditure (Form CMS-64) for the fourth quarter of the federal fiscal year 2017, for the Deans Graduate Medical Education Program.

1 SECTION 2. There is hereby appropriated to the Oklahoma Health 2 Care Authority from any monies not otherwise appropriated from the 3 General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Hundred Ten Million Forty-four 5 Thousand Three Hundred Nineteen Dollars (\$110,044,319.00) or so much 6 thereof as may be necessary to replace federal financial 7 participation expenditures, to be distributed to Oklahoma State 8 University and the University of Oklahoma for the benefit of the 9 Deans Graduate Medical Education Program, in the same ratio as such 10 funds were provided for such purpose by the Oklahoma Health Care 11 Authority in fiscal year 2017. 12 SECTION 3. Section 2 of this act shall become effective July 1, 13 2018. 14 It being immediately necessary for the preservation SECTION 4. 15

SECTION 4. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
