AMENDATORY Section 2, Chapter 20, O.S.L. 2013 16 (63 O.S. Supp. 2016, Section 1-1331), is amended to read as follows: 17 Section 1-1331. A. Beekeepers with annual production of less 18 than five hundred (500) gallons shall be exempt from regulation and 19 inspection by the State Department of Health for the manufacture, 20 sale, and distribution of honey and honeycomb products in Oklahoma 21 if they meet the following requirements: 22 The beekeeper shall only sell or distribute honey or 23 honeycomb produced from hives located wholly within the State of 24 Oklahoma which are owned and managed by the beekeeper;

- 2. The honey, honeycomb, or combination thereof is raw and not blended with other products or otherwise adulterated. The honey may be in liquid or solid form or a combination of the two;
- 3. The honey or honeycomb shall only be sold or distributed in person to the end-use customer at the beekeeper's home, farmer's markets, roadside stands, county fairs, or similar events+ by the beekeeper or members of the beekeeper's immediate family; and
- 4. Honey products shall be labeled with the common food product name, net weight of the honey, the beekeeper's name, current ten (10) digit phone number, an address where the honey or honeycomb was produced, and shall include the statement, "Bottled or packaged in a facility not inspected by the Oklahoma Department of Health." The statement shall be in 10-point type or greater in a color that provides clear contrast to the background label.
- B. No county, municipal corporation, consolidated government, or political subdivision of this state shall adopt or continue in effect any ordinance, rule, regulation, or resolution prohibiting, impeding, or restricting honey sales or distribution in compliance with this law. A county, municipal corporation, consolidated government or political subdivision of this state is authorized to charge a reasonable fee for the rental of booth space or for the reservation of a space at a temporary retail food establishment where honey is sold or distributed in compliance with this section at a single event or celebration. A county, municipal corporation,

2	not require an inspection of condition or wholesomeness of honey
3	sold or distributed pursuant to this section or charge a fee related
4	to an inspection.
5	SECTION 2. This act shall become effective November 1, 2017.
