13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 74 O.S. 2011, Section 941, as last
15	amended by Section 1, Chapter 301, O.S.L. 2015 (74 O.S. Supp. 2016,
16	Section 941), is amended to read as follows:
17	Section 941. A. There is hereby created the Oklahoma State
18	Pension Commission. The Commission shall consist of seven (7)
19	members as follows:
20	1. The State Auditor and Inspector or that person's designee;
21	2. The Director of the Office of Management and Enterprise
22	Services or that person's designee;
23	3. The State Treasurer or that person's designee;

- 1 4. One member who shall be a member of the Senate appointed by the President Pro Tempore of the Senate who shall serve at the pleasure of the appointing authority and who shall be a nonvoting member have demonstrated experience in the investment of private or public funds;
  - 5. One member who shall be a member of the House Representatives appointed by the Speaker of the House of Representatives who shall serve at the pleasure of the appointing authority and who shall be a nonvoting member have demonstrated experience in the investment of private or public funds;
  - 6. One person to be appointed by the Governor who shall have at least ten (10) years of demonstrated experience in the financial services industry; and
  - 7. One person to be appointed by the Governor who shall have at least ten (10) years of experience in retirement planning, including demonstrated experience with retirement plan designs.
- 17 No member of the governing body of a state retirement system shall 18 be eligible to be appointed to the Commission.
  - The Commission shall hold regular meetings at least once each quarter, the dates, time and place to be set by the Commission. The Commission shall hold its first meeting prior to September 30, 1988.
- 23 C. The Office of the State Auditor and Inspector shall provide 24 the administrative support required by the Commission.
