6 An Act relating to public finance; amending Section
7 2, Chapter 325, O.S.L. 2017 (62 O.S. Supp. 2017,
8 Section 8002), which relates to the Agency
9 Performance and Accountability Commission;
10 authorizing Commission to contract with Attorney
11 General for legal advice; and declaring an emergency.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY Section 2, Chapter 325, O.S.L.
14 2017 (62 O.S. Supp. 2017, Section 8002), is amended to read as
15 follows:

16 Section 8002. A. There is hereby created the Agency
17 Performance and Accountability Commission which shall consist of:

18 1. Three members appointed by the Governor:

19 a. at least one of whom shall be the president, owner,
20 chief executive officer or chief financial officer of
21 an Oklahoma-based company, and

22 b. at least one of whom shall be an auditor who is
23 employed as an internal auditor by a company or who is
24 employed by a private auditing firm;

1 2. Three members appointed by the President Pro Tempore of the
2 Oklahoma Senate, at least one of whom shall be a business efficiency
3 expert;

4 3. Three members appointed by the Speaker of the Oklahoma House
5 of Representatives, at least one of whom shall be a business
6 efficiency expert; and

7 4. The Director of the Office of Management and Enterprise
8 Services, or his or her designee who is an employee of the Office of
9 Management and Enterprise Services, who shall be an ex officio and
10 nonvoting member.

11 B. No person shall be appointed to the Commission who at the
12 time of his or her appointment is an elected official. Any person
13 who is appointed to the Commission who subsequently becomes an
14 elected official during his or her term on the Commission shall be
15 required to vacate his or her position on the Commission.

16 C. The Senate and the House of Representatives shall provide
17 staff and administrative support to the Commission. The Commission
18 shall contract with the Attorney General who shall provide legal
19 advice on any matter related to the powers and duties of the
20 Commission.

21 SECTION 2. It being immediately necessary for the preservation
22 of the public peace, health or safety, an emergency is hereby
23 declared to exist, by reason whereof this act shall take effect and
24 be in full force from and after its passage and approval.
