8 An Act relating to education funding; making
9 appropriations to the State Board of Education;
10 authorizing expenditure of certain funds; identifying
11 sources; identifying amounts; stating purposes;
12 requiring certain designations; providing an
13 effective date; and declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 General Revenue Fund of the State Treasury for the fiscal year
18 ending June 30, 2019, the sum of One Billion Four Hundred Thirty-one
19 Million Five Hundred Thirty-one Thousand One Hundred Thirty-six
20 Dollars (\$1,431,531,136.00) or so much thereof as may be necessary
21 for the financial support of public schools. Of those funds
22 appropriated, the State Board of Education shall designate adequate
23 amounts for increased compensation for certified personnel as
24 provided in the provisions of Enrolled House Bill No. 1023 of the
2nd Extraordinary Session of the 56th Oklahoma Legislature, and for

1 increased compensation for support employees as provided in the
2 provisions of Enrolled House Bill No. 1026 of the 2nd Extraordinary
3 Session of the 56th Oklahoma Legislature.

4 SECTION 2. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 Education Reform Revolving Fund created in Section 34.89 of Title 62
7 of the Oklahoma Statutes, the sum of Seven Hundred Sixty-two Million
8 Seven Hundred Twenty-Six Thousand One Hundred Twenty-five Dollars
9 (\$762,726,125.00) or so much thereof as may be necessary for the
10 financial support of public schools.

11 SECTION 3. The State Board of Education is hereby authorized to
12 expend during the fiscal year ending June 30, 2019, from the Common
13 Education Technology Revolving Fund of the State Treasury, the sum
14 of Forty-seven Million Three Hundred Seventy-two Thousand Two
15 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
16 may be necessary for the financial support of public schools.

17 SECTION 4. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Mineral Leasing Fund of the State Treasury for the fiscal year
20 ending June 30, 2019, the sum of Two Million Eight Hundred Fifty
21 Thousand Dollars (\$2,850,000.00) or so much thereof as may be
22 necessary for the financial support of public schools.

23 SECTION 5. There is hereby appropriated to the State Board of
24 Education from any monies not otherwise appropriated from the

1 Mineral Leasing Fund of the State Treasury for the fiscal year
2 ending June 30, 2017, the sum of One Million One Hundred Twenty
3 Thousand Eight Hundred Eighty-eight Dollars (\$1,120,888.00) or so
4 much thereof as may be necessary for the financial support of public
5 schools.

6 SECTION 6. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 Oklahoma Education Lottery Trust Fund of the State Treasury for the
9 fiscal year ending June 30, 2019, the sum of Thirty Million Three
10 Hundred Twenty-six Thousand Seven Hundred Thirty-four Dollars
11 (\$30,326,734.00) or so much thereof as may be necessary for the
12 financial support of public schools.

13 SECTION 7. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the
16 fiscal year ending June 30, 2017, the sum of One Million Nine
17 Hundred Eighty-five Thousand Six Hundred Thirty-seven Dollars
18 (\$1,985,637.00) or so much thereof as may be necessary for the
19 financial support of public schools.

20 SECTION 8. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 General Revenue Fund of the State Treasury for the fiscal year
23 ending June 30, 2019, the sum of Ninety-one Million Three Hundred
24 Nineteen Thousand Twenty-six Dollars (\$91,319,026.00) or so much

1 thereof as may be necessary for the support of public schools
2 activities.

3 SECTION 9. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2019, the sum of Thirty-three Million Dollars
7 (\$33,000,000.00) or so much thereof as may be necessary for the
8 purchase of textbooks and instructional materials.

9 SECTION 10. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2019, the sum of Three Hundred Fifteen Million Four
13 Hundred Seventy-eight Thousand Thirty Dollars (\$315,478,030.00) or
14 so much thereof as may be necessary for the Certified Employee
15 Health Benefit Allowance.

16 SECTION 11. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2019, the sum of One Hundred Seventy-one Million
20 Nine Hundred Five Thousand Eighty-six Dollars (\$171,905,086.00) so
21 much thereof as may be necessary for the Support Personnel Health
22 Benefit Allowance.

23 SECTION 12. There is hereby appropriated to the State Board of
24 Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2019, the sum of Fifteen Million Five Hundred Fifty-
3 two Thousand Five Hundred Twenty Dollars (\$15,552,520.00) or so much
4 thereof as may be necessary for administrative and support functions
5 of the State Department of Education.

6 SECTION 13. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 Oklahoma Education Lottery Trust Fund of the State Treasury for the
9 fiscal year ending June 30, 2019, the sum of Three Million Three
10 Hundred Sixty-nine Thousand Six Hundred Thirty-eight Dollars
11 (\$3,369,638.00) or so much thereof as may be necessary for transfer
12 to the School Consolidation Assistance Fund.

13 SECTION 14. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the
16 fiscal year ending June 30, 2017, the sum of Two Hundred Twenty
17 Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much
18 thereof as may be necessary for transfer to the School Consolidation
19 Assistance Fund.

20 SECTION 15. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the
23 fiscal year ending June 30, 2019, the sum of Three Million Three
24 Hundred Sixty-nine Thousand Six Hundred Thirty-eight Dollars

1 (\$3,369,638.00) or so much thereof as may be necessary for transfer
2 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

3 SECTION 16. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2017, the sum of Two Hundred Twenty
7 Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much
8 thereof as may be necessary for transfer to the Teachers' Retirement
9 System Dedicated Revenue Revolving Fund.

10 SECTION 17. This act shall become effective July 1, 2018.

11 SECTION 18. It being immediately necessary for the preservation
12 of the public peace, health or safety, an emergency is hereby
13 declared to exist, by reason whereof this act shall take effect and
14 be in full force from and after its passage and approval.
