An Act relating to judicial districts; amending 20 O.S. 2011, Sections 92.25 and 92.27, which relate to district judges; and modifying composition of judges in certain districts after specified date; updating language.

SUBJECT: Judicial districts

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 20 O.S. 2011, Section 92.25, is amended to read as follows:

Section 92.25 District No. 24. The counties of Okfuskee, Okmulgee and Creek. Said

- A. For elections occurring before January 1, 2018, the district shall have five (5) district judges to be nominated and elected as follows: One candidate to be nominated and elected at large and a legal resident of Okfuskee County; two candidates to be nominated and elected at large and legal residents of Okmulgee County; and two candidates to be nominated and elected at large and legal residents of Creek County, all of whom shall be elected at large.
- B. For elections occurring on or after January 1, 2018, the district shall have four (4) district judges to be nominated and elected as follows: One candidate to be nominated and elected at large and a legal resident of Okfuskee County; one candidate to be nominated and elected at large and a legal resident of Okmulgee

$\underline{\text{County;}}$ and two candidates to be nominated and elected at large and $\underline{\text{legal}}$ residents of Creek County.

SECTION 2. AMENDATORY 20 O.S. 2011, Section 92.27, is amended to read as follows:

Section 92.27 District No. 26. The county of Canadian. Said

- A. For elections before January 1, 2018, the district shall have one district judge to be nominated and elected at large.
- B. For elections occurring on or after January 1, 2018, the district shall have two (2) district judges to be nominated and elected at large.
