

# An Act

An Act relating to education funding; making appropriations to the State Board of Education; authorizing expenditure of certain funds; identifying sources; identifying amounts; stating purposes; requiring certain designations; providing an effective date; and declaring an emergency.

SUBJECT: Education funding

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Billion Four Hundred Thirty-one Million Five Hundred Thirty-one Thousand One Hundred Thirty-six Dollars (\$1,431,531,136.00) or so much thereof as may be necessary for the financial support of public schools. Of those funds appropriated, the State Board of Education shall designate adequate amounts for increased compensation for certified personnel as provided in the provisions of Enrolled House Bill No. 1023 of the 2nd Extraordinary Session of the 56th Oklahoma Legislature, and for increased compensation for support employees as provided in the provisions of Enrolled House Bill No. 1026 of the 2nd Extraordinary Session of the 56th Oklahoma Legislature.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the

Education Reform Revolving Fund created in Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of Seven Hundred Sixty-two Million Seven Hundred Twenty-Six Thousand One Hundred Twenty-five Dollars (\$762,726,125.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2019, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Two Million Eight Hundred Fifty Thousand Dollars (\$2,850,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2017, the sum of One Million One Hundred Twenty Thousand Eight Hundred Eighty-eight Dollars (\$1,120,888.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Thirty Million Three Hundred Twenty-six Thousand Seven Hundred Thirty-four Dollars (\$30,326,734.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2017, the sum of One Million Nine Hundred Eighty-five Thousand Six Hundred Thirty-seven Dollars (\$1,985,637.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Ninety-one Million Three Hundred Nineteen Thousand Twenty-six Dollars (\$91,319,026.00) or so much thereof as may be necessary for the support of public schools activities.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof as may be necessary for the purchase of textbooks and instructional materials.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Three Hundred Fifteen Million Four Hundred Seventy-eight Thousand Thirty Dollars (\$315,478,030.00) or so much thereof as may be necessary for the Certified Employee Health Benefit Allowance.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Hundred Seventy-one Million Nine Hundred Five Thousand Eighty-six Dollars (\$171,905,086.00) or so much thereof as may be necessary for the Support Personnel Health Benefit Allowance.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Fifteen Million Five Hundred Fifty-two Thousand Five Hundred Twenty Dollars (\$15,552,520.00) or so much thereof as may be necessary for administrative and support functions of the State Department of Education.

SECTION 13. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Three Million Three Hundred Sixty-nine Thousand Six Hundred Thirty-eight Dollars

(\$3,369,638.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 14. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2017, the sum of Two Hundred Twenty Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 15. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of Three Million Three Hundred Sixty-nine Thousand Six Hundred Thirty-eight Dollars (\$3,369,638.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 16. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2017, the sum of Two Hundred Twenty Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 17. This act shall become effective July 1, 2018.

SECTION 18. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
