Notwithstanding the levies in subparagraphs a and b of this paragraph, the production of oil, gas, or oil and gas from wells spudded:

- (1) wells spudded on or after July 1, 2015 and prior to the effective date of this act, shall be taxed at a rate of five percent (5%) thirty-six (36) months, provided that such period shall be reduced by the number of months where the reduced rate in subparagraph c applied, and
- (2) wells on or after the effective date of this act, shall be taxed at a rate of five percent (5%) commencing with the month of first production
