"1. Any person who is eligible for a mentor or lead teaching certificate described in this section shall make application with the board of education. The board of education and superintendent shall review applications to determine if the teaching certificate candidate meets the criteria for the certificate level requested. In reviewing an application, the board of education shall consider the ability of the school district to fulfill the conditions described in subsection I of this section before making a recommendation to the State Board of Education.

2. The board of education and superintendent shall provide a recommendation to the State Board of Education within sixty (60) days of receipt of the application.

3. The Board shall develop an application and make it available to school districts.
