Prior to the final opportunity for each 8 school board member who has not completed the continuing education 9 requirements to complete the same, the Board shall notify the school 10 board member and the school district superintendent by mail before 11 March 1 of each year of any final opportunity to complete these 12 requirements and the consequences of not completing the 13 requirements. Upon determining that a school board member did not 14 complete the continuing education requirements of Sections 5-110 or 15 5-110.1 within the respective period of time, the Board shall 16 immediately notify by certified mail the school district board of 17 education member and the school district superintendent that and 18 inform the member of the violation of the continuing education 19 requirements. The school board member shall have sixty (60) days 20 after the date of receipt of the certified notice to complete the
