And Page 4, Section 1, Line 19 by inserting before the word "notice" the words: "that the member has to complete the requirements as indicated by receipt of the certified"

And Page 4, Section 1, Lines 19-20 by striking all of the words beginning with "that" through the word "requirements"

And Page 7, Section 2, Lines 13-14 by striking "thirty (30)" and inserting "sixty (60)"

And Page 7, Section 2, Line 14 by inserting "final" before the word "date"

And Page 7, Section 2, Line 14 by striking "of receipt of"

And Page 7, Section 2, Line 14 by inserting before the word "notice" the words: "that the member has to complete the requirements as indicated by receipt of the certified"

And Page 7, Section 2, Line 15 by striking all of the words beginning with "that" through the word "requirements"

And Pages 8-10, Section 3, Line 19 by removing Section 3 of the bill in its entirety and inserting in lieu thereof Section 3 [see attached]

1 "SECTION 3. AMENDATORY 70 O.S. 2011, Section 5-110.2, as
2 amended by Section 4, Chapter 356, O.S.L. 2016 (70 O.S. Supp. 2017,
3 Section 5-110.2), is amended to read as follows:

4 Section 5-110.2 The State Board of Education shall maintain
5 records of attendance by school board members at continuing
6 education events required pursuant to Sections 5-110 and 5-110.1 of
7 this title ~~and prior~~. Prior to the final opportunity for each
8 school board member who has not completed the continuing education
9 requirements to complete the same, the Board shall notify the school
10 board member and the school district superintendent by mail before
11 March 1 of each year of any final opportunity to complete these
12 requirements and the consequences of not completing the
13 requirements. Upon determining that a school board member did not
14 complete the continuing education requirements of Sections 5-110 or
15 5-110.1 within the respective period of time, the Board shall
16 immediately notify by certified mail the school ~~district~~ board of
17 ~~education member~~ member and the school district superintendent ~~that~~ and
18 inform the member of the violation of the continuing education
19 requirements. The school board member shall have sixty (60) days
20 after the date of receipt of the certified notice to complete the
21 requirements. If the school board member ~~did~~ does not complete the
22 requirements and that by the end of the sixty-day time period, the
