FLOOR SUBSTITUTE

An Act relating to education funding; making appropriations to the State Board of Education; authorizing expenditure of certain funds; identifying sources; identifying amounts; stating purposes; requiring certain designations; providing an effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2019, the sum of One Billion Four Hundred Thirty-one Million Five Hundred Thirty-one Thousand One Hundred Thirty-six Dollars (\$1,431,531,136.00) or so much thereof as may be necessary for the financial support of public schools. Of those funds

1 appropriated, the State Board of Education shall designate adequate
2 amounts for increased compensation for certified personnel as
3 provided in the provisions of Enrolled House Bill No. 1023 of the
4 2nd Extraordinary Session of the 56th Oklahoma Legislature, and for
5 increased compensation for support employees as provided in the
6 provisions of Enrolled House Bill No. 1026 of the 2nd Extraordinary
7 Session of the 56th Oklahoma Legislature.

8 SECTION 2. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Education Reform Revolving Fund created in Section 34.89 of Title 62
11 of the Oklahoma Statutes, the sum of Seven Hundred Sixty-two Million
12 Seven Hundred Twenty-Six Thousand One Hundred Twenty-five Dollars
13 (\$762,726,125.00) or so much thereof as may be necessary for the
14 financial support of public schools.

15 SECTION 3. The State Board of Education is hereby authorized to
16 expend during the fiscal year ending June 30, 2019, from the Common
17 Education Technology Revolving Fund of the State Treasury, the sum
18 of Forty-seven Million Three Hundred Seventy-two Thousand Two
19 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
20 may be necessary for the financial support of public schools.

21 SECTION 4. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 Mineral Leasing Fund of the State Treasury for the fiscal year
24 ending June 30, 2019, the sum of Two Million Eight Hundred Fifty

1 Thousand Dollars (\$2,850,000.00) or so much thereof as may be
2 necessary for the financial support of public schools.

3 SECTION 5. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Mineral Leasing Fund of the State Treasury for the fiscal year
6 ending June 30, 2017, the sum of One Million One Hundred Twenty
7 Thousand Eight Hundred Eighty-eight Dollars (\$1,120,888.00) or so
8 much thereof as may be necessary for the financial support of public
9 schools.

10 SECTION 6. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the
13 fiscal year ending June 30, 2019, the sum of Thirty Million Three
14 Hundred Twenty-six Thousand Seven Hundred Thirty-four Dollars
15 (\$30,326,734.00) or so much thereof as may be necessary for the
16 financial support of public schools.

17 SECTION 7. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the
20 fiscal year ending June 30, 2017, the sum of One Million Nine
21 Hundred Eighty-five Thousand Six Hundred Thirty-seven Dollars
22 (\$1,985,637.00) or so much thereof as may be necessary for the
23 financial support of public schools.

1 SECTION 8. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2019, the sum of Ninety-one Million Three Hundred
5 Nineteen Thousand Twenty-six Dollars (\$91,319,026.00) or so much
6 thereof as may be necessary for the support of public schools
7 activities.

8 SECTION 9. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2019, the sum of Thirty-three Million Dollars
12 (\$33,000,000.00) or so much thereof as may be necessary for the
13 purchase of textbooks and instructional materials.

14 SECTION 10. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2019, the sum of Three Hundred Fifteen Million Four
18 Hundred Seventy-eight Thousand Thirty Dollars (\$315,478,030.00) or
19 so much thereof as may be necessary for the Certified Employee
20 Health Benefit Allowance.

21 SECTION 11. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 General Revenue Fund of the State Treasury for the fiscal year
24 ending June 30, 2019, the sum of One Hundred Seventy-one Million

1 Nine Hundred Five Thousand Eighty-six Dollars (\$171,905,086.00) so
2 much thereof as may be necessary for the Support Personnel Health
3 Benefit Allowance.

4 SECTION 12. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2019, the sum of Fifteen Million Five Hundred Fifty-
8 two Thousand Five Hundred Twenty Dollars (\$15,552,520.00) or so much
9 thereof as may be necessary for administrative and support functions
10 of the State Department of Education.

11 SECTION 13. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the
14 fiscal year ending June 30, 2019, the sum of Three Million Three
15 Hundred Sixty-nine Thousand Six Hundred Thirty-eight Dollars
16 (\$3,369,638.00) or so much thereof as may be necessary for transfer
17 to the School Consolidation Assistance Fund.

18 SECTION 14. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the
21 fiscal year ending June 30, 2017, the sum of Two Hundred Twenty
22 Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much
23 thereof as may be necessary for transfer to the School Consolidation
24 Assistance Fund.

1 SECTION 15. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2019, the sum of Three Million Three
5 Hundred Sixty-nine Thousand Six Hundred Thirty-eight Dollars
6 (\$3,369,638.00) or so much thereof as may be necessary for transfer
7 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

8 SECTION 16. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2017, the sum of Two Hundred Twenty
12 Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much
13 thereof as may be necessary for transfer to the Teachers' Retirement
14 System Dedicated Revenue Revolving Fund.

15 SECTION 17. This act shall become effective July 1, 2018.

16 SECTION 18. It being immediately necessary for the preservation
17 of the public peace, health or safety, an emergency is hereby
18 declared to exist, by reason whereof this act shall take effect and
19 be in full force from and after its passage and approval.
