"SECTION 7. AMENDATORY 59 O.S. 2011, Section 328.51a, as amended by Section 17, Chapter 405, O.S.L. 2013 (59 O.S. Supp. 2016, Section 328.51a), is amended to read as follows:

Section 328.51a A. The Board of Dentistry is authorized to establish, by rule, fees to be charged for the purpose of implementing and enforcing the State Dental Act. The penalty and late fee shall be twice the amount of the original fee for license renewals. Notwithstanding any other provisions of the State Dental Act, the fees established by the Board shall be not less nor more than the range created by the following schedule:
