1 "75. Air Medal License Plate - such plates shall be designed and
2 issued to Air Medal recipients. An individual requesting the plate
3 is required, at the time of application, to show proof he or she is
4 a recipient of the Air Medal or sign an attestation stating that he
5 or she is a medal recipient. The plates shall be designed to
6 include the Air Medal emblem and shall include the words "Air Medal"
7 on the plate;

8 76. Oklahoma Institute for Child Advocacy Plate - such plates
9 shall be designed and issued to any person wishing to demonstrate
10 support for the Oklahoma Institute for Child Advocacy. The plates
11 shall be issued to any person in any combination of numbers and
12 letters from one to a maximum of seven, as for personalized license
13 plates. The plates shall contain the official Oklahoma Institute
14 for Child Advocacy logo;

15 77. The Pride of Oklahoma Marching Band License Plate - such
16 plates shall be designed and issued to any person wishing to
17 demonstrate support for the Pride of Oklahoma marching band. The
18 plates shall be designed in consultation with the University of
19 Oklahoma;

20 78. The Spirit of Oklahoma State Marching Band License Plate -
21 such plates shall be designed and issued to any person wishing to
22 demonstrate support for the Spirit of Oklahoma State marching band.
23 The plates shall be designed in consultation with Oklahoma State
24 University; and

1 79. Pittsburg State University License Plate - such plates
2 shall be designed and issued to any person wishing to demonstrate
3 support for Pittsburg State University. The plates shall be
4 designed in consultation with Pittsburg State University."

6 On page 40, Section 2, line 17 after the word "be" and before
7 the word "designed" insert the phrase "authorized to be";
8

9 On page 40, Section 2, line 18 after the word "for" and before
10 the word "Folds" insert the words "the Oklahoma City Chapter of";
11

12 On page 40, Section 2, lines 20-21 strike the phrase "academic
13 and vocational training" and insert the word "educational" before
14 the word "scholarships";
15

16 On page 40, Section 2, line 21 strike the word "dependents" and
17 insert the words "spouses and children" before the word "of";
18

19 On page 40, Section 2, lines 21-23 strike the words "military
20 servicemen and servicewomen who were either killed or wounded in
21 action due to military service in the war in Iraq or Afghanistan"
22 and insert before the period on line 23 the words "America's fallen
23 and disabled military service members";

1 On page 41, section 2, line 2 after the word "with" and before
2 the word "Folds" insert the words "the Oklahoma City Chapter of";
3 and
4

5 On page 41, section 2, line 10 after the word "issued" and
6 before the semicolon insert the following ". Subject to the
7 provisions of subsection A of this section, the Folds of Honor
8 Supporter License Plate is hereby reauthorized effective November 1,
9 2018"
