FLOOR SUBSTITUTE

An Act relating to motor vehicle license plates;
amending 47 O.S. 2011, Section 1135.3, as last
amended by Section 2, Chapter 331, O.S.L. 2017 (47
O.S. Supp. 2017, Section 1135.3), which relates to
specialty license plates; creating the Southeast
Spartans license plate; providing for design of
plates; amending 47 O.S. 2011, Section 1135.5, as
last amended by Section 1, Chapter 339, O.S.L. 2017
(47 O.S. Supp. 2017, Section 1135.5), which relates
to specialty license plates; updating and clarifying
references; creating Navajo School Foundation license
plate; creating the Oklahoma Music Hall of Fame Inc.
license plate; creating Techlahoma Foundation license
plate; creating Bethany Public Schools Foundation
license plate; creating Cystic Fibrosis license
plate; providing for design of plates; providing for
codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.3, as
2 last amended by Section 2, Chapter 331, O.S.L. 2017 (47 O.S. Supp.
3 2017, Section 1135.3), is amended to read as follows:

4 Section 1135.3. A. The Oklahoma Tax Commission is hereby
5 authorized to design and issue appropriate official special license
6 plates to persons wishing to demonstrate support, interest, or
7 membership to or for an organization, occupation, cause or other
8 subject as provided by this section.

9 Special license plates shall not be transferred to any other
10 person but shall be removed from the vehicle upon transfer of
11 ownership and retained. The special license plate may then be used
12 on another vehicle but only after such other vehicle has been
13 registered for the current year.

14 Special license plates shall be renewed each year by the Tax
15 Commission or a motor license agent. The Tax Commission shall
16 annually notify by mail all persons issued special license plates.
17 The notice shall contain all necessary information and shall contain
18 instructions for the renewal procedure upon presentation to a motor
19 license agent or the Tax Commission. The license plates shall be
20 issued on a staggered system.

21 The Tax Commission is hereby directed to develop and implement a
22 system whereby motor license agents are permitted to accept
23 applications for special license plates authorized under this
24 section. The motor license agent shall confirm the applicant's

1 eligibility, if applicable, collect and deposit any amount
2 specifically authorized by law, accept and process the necessary
3 information directly into such system and generate a receipt
4 accordingly. For performance of these duties, motor license agents
5 shall retain the fee provided in Section 1141.1 of this title for
6 registration of a motor vehicle. The motor license agent fees for
7 acceptance of applications and renewals shall be paid out of the
8 Oklahoma Tax Commission Reimbursement Fund.

9 If fewer than one hundred of any type of special license plates
10 authorized prior to January 1, 2004, are issued prior to January 1,
11 2006, the Tax Commission shall discontinue issuance and renewal of
12 that type of special license plate. Any such authorized special
13 license plate registrant shall be allowed to display the license
14 plate upon the designated vehicle until the registration expiration
15 date. After such time the expired special license plate shall be
16 removed from the vehicle.

17 Except as otherwise provided in this section, for special
18 license plates authorized on or after July 1, 2004, no special
19 license plates shall be developed or issued by the Tax Commission
20 until the Commission receives one hundred (100) prepaid applications
21 therefor. The prepaid applications must be received by the Tax
22 Commission within one hundred eighty (180) days of the effective
23 date of the authorization or the authority to issue shall be null
24 and void. In the event one hundred (100) prepaid applications are

1 not received by the Tax Commission within such prescribed time
2 period any payment so received shall be refunded accordingly.

3 B. The special license plates provided by this section are as
4 follows:

5 1. Round and Square Dance License Plate - such plates shall be
6 designed and issued to any person wishing to demonstrate support for
7 round and square dancing;

8 2. National Association for the Advancement of Colored People
9 License Plate - such plates shall be designed, subject to the
10 criteria to be presented to the Tax Commission by the NAACP, and
11 issued to any person wishing to demonstrate support for the NAACP;

12 3. National Rifle Association License Plate - such plates shall
13 be designed, subject to the criteria to be presented to the Tax
14 Commission by the National Rifle Association, and issued to any
15 person wishing to demonstrate support for the National Rifle
16 Association;

17 4. Masonic Fraternity License Plate - such plates shall be
18 designed and issued to any resident of this state who is a member of
19 a Masonic Fraternity of Oklahoma. Such persons may apply for a
20 Masonic Fraternity license plate for each vehicle with a rated
21 carrying capacity of one (1) ton or less upon proof of a Masonic
22 Fraternity membership or upon the presentment of an application for
23 a Masonic Fraternity license plate authorized and approved by the
24 Grand Lodge of Oklahoma. The license plates shall be designed in

1 consultation with the Masonic Fraternities of Oklahoma and shall
2 contain the Masonic emblem;

3 5. Shriner's Hospitals for Burned and Crippled Children License
4 Plate - such plates shall be designed to demonstrate support for
5 Shriner's Hospitals for Burned and Crippled Children and shall be
6 issued to any resident of this state who is a member of a Shriner's
7 Temple in Oklahoma. The license plate shall be designed in
8 consultation with the Shriner's Temples in Oklahoma and shall
9 contain the Shriner's emblem;

10 6. Balloonists License Plate - such plates shall be designed
11 and issued to any person wishing to demonstrate support for hot air
12 ballooning in this state;

13 7. Order of the Eastern Star License Plate - such plates shall
14 be designed and issued to any resident of this state who is a member
15 of an Order of the Eastern Star. Such persons may apply for an
16 Order of the Eastern Star license plate for each vehicle with a
17 rated carrying capacity of one (1) ton or less upon proof of an
18 Order of the Eastern Star membership or upon the presentment of an
19 application for an Order of the Eastern Star license plate
20 authorized and approved by the organization. The license plate
21 shall be designed in consultation with the Order of the Eastern Star
22 and shall contain the Order of the Eastern Star emblem;

23 8. Knights of Columbus License Plate - such plates shall be
24 designed and issued to any resident of this state who is a member of

1 the Knights of Columbus. Such persons may apply for a Knights of
2 Columbus license plate for each vehicle with a rated carrying
3 capacity of one (1) ton or less upon proof of a Knights of Columbus
4 membership or upon the presentment of an application for a Knights
5 of Columbus license plate authorized and approved by the
6 organization. The license plate shall be designed in consultation
7 with the Knights of Columbus and shall contain the Knights of
8 Columbus emblem;

9 9. Jaycees License Plate - such plates shall be designed and
10 issued to members of the Jaycees. Persons applying for such license
11 plate must show proof of membership in the Jaycees. The license
12 plates shall be designed in consultation with the Jaycees;

13 10. Kiwanis International License Plate - such plates shall be
14 designed and issued to members of Kiwanis International. Persons
15 applying for such license plate must show proof of membership in
16 Kiwanis International. The license plates shall be designed in
17 consultation with Kiwanis International;

18 11. Certified Public Accountants License Plate - such plates
19 shall be designed and issued to any resident of this state who is a
20 Certified Public Accountant. Such persons may apply for a Certified
21 Public Accountant license plate for each vehicle with a rated
22 carrying capacity of one (1) ton or less upon proof of status as a
23 Certified Public Accountant. The license plates shall be designed
24

1 in consultation with the Oklahoma Society of Certified Public
2 Accountants;

3 12. Civil Emergency Management License Plate - such plates
4 shall be designed and issued to persons wishing to demonstrate
5 support for the state civil emergency management system. Persons
6 applying for such license plate must show proof of official
7 affiliation by presenting a nonexpired proof of employment,
8 affiliation or retirement in the form of an identification card or
9 letter on official letterhead from a municipal, county or state
10 emergency management department head;

11 13. Civilian Conservation Corps License Plate - such plates
12 shall be designed, subject to criteria to be presented to the Tax
13 Commission, by the Civilian Conservation Corps Association, and
14 issued to any person wishing to demonstrate support of the Civilian
15 Conservation Corps;

16 14. Rotarian License Plate - such plates shall be designed and
17 issued to any resident of this state who is a member of a Rotarian
18 Club of Oklahoma. Such persons may apply for a Rotarian license
19 plate for each vehicle with a rated carrying capacity of one (1) ton
20 or less upon proof of a Rotarian Club membership or upon the
21 presentment of an application for a Rotarian license plate
22 authorized and approved by a Rotarian Club of Oklahoma. The license
23 plates shall be designed in consultation with the five Rotarian
24 District Governors and shall contain the Rotarian emblem;

1 15. Benevolent Protective Order of Elks License Plate - such
2 plates shall be designed, subject to criteria to be presented to the
3 Tax Commission, by the Benevolent Protective Order of Elks, and
4 issued to any resident of this state who is a member of the
5 Benevolent Protective Order of Elks;

6 16. Humane Society License Plate - such plates shall be
7 designed and issued to any person wishing to demonstrate support for
8 the Humane Society of the United States. The plates shall be issued
9 to any person in any combination of numbers and letters from one to
10 a maximum of seven, as for personalized license plates. The plate
11 shall contain the official Humane Society logo;

12 17. Oklahoma Mustang Club License Plate - such plates shall be
13 designed, subject to criteria to be presented to the Tax Commission,
14 by the Oklahoma Mustang Club, and issued to any resident of this
15 state who is a member of the Oklahoma Mustang Club. Such persons
16 may apply for an Oklahoma Mustang Club license plate upon
17 presentment of proof of membership in the Oklahoma Mustang Club.
18 The plates shall be issued to any person in any combination of
19 numbers and letters from one to a maximum of seven, as for
20 personalized license plates;

21 18. American Business Clubs (AMBUCS) License Plate - such
22 plates shall be designed and issued to members of American Business
23 Clubs. Persons applying for such license plate must show proof of
24

1 membership in AMBUCS. The license plates shall be designed in
2 consultation with American Business Clubs;

3 19. West Point 200th Anniversary License Plate - such plates
4 shall be designed and issued to any person wishing to commemorate
5 the Two Hundredth Anniversary of the founding of the United States
6 Military Academy at West Point, New York. The license plates shall
7 be designed in consultation with the West Point Society of Central
8 Oklahoma;

9 20. Oklahoma Aquarium License Plate - such plates shall be
10 designed and issued to persons wishing to demonstrate support for
11 the Oklahoma Aquarium. The license plates shall be designed in
12 consultation with the Oklahoma Aquarium;

13 21. The Pride of Broken Arrow License Plate - such plates shall
14 be designed and issued to any person wishing to demonstrate support
15 for The Pride of Broken Arrow marching band. The plates shall be
16 designed in consultation with the Broken Arrow Public School System;

17 22. Fellowship of Christian Athletes License Plate - such
18 plates shall be designed in consultation with the Fellowship of
19 Christian Athletes and issued to members and supporters of the
20 Fellowship of Christian Athletes;

21 23. Parrothead Club License Plate - such plates shall be
22 designed and issued to members and supporters of the Parrothead
23 Club. The license plate shall be issued to any person in any
24

1 combination of numbers and letters from one to a maximum of seven as
2 for personalized license plates;

3 24. Oklahoma Bicycling Coalition License Plate - such plates
4 shall be designed and issued to any person who is a member of the
5 Oklahoma Bicycling Coalition. The license plates shall be designed
6 in consultation with the Oklahoma Bicycling Coalition;

7 25. Electric Lineman License Plate - such plates shall be
8 designed and issued to persons wishing to demonstrate support for
9 Oklahoma's electric linemen. The license plates shall be designed
10 in consultation with the Oklahoma Electric Superintendent's
11 Association;

12 26. Alpha Kappa Alpha License Plate - such plates shall be
13 designed and issued to any person who is a member of Alpha Kappa
14 Alpha Sorority. The license plates shall be designed in
15 consultation with the Oklahoma Chapter of Alpha Kappa Alpha
16 Sorority;

17 27. The National Pan-Hellenic Council Incorporated License
18 Plate - such plates shall be designed and issued to any person
19 wishing to demonstrate support to any of the nine sororities and
20 fraternities recognized by the National Pan-Hellenic Council
21 Incorporated. The license plates shall be designed in consultation
22 with the Oklahoma Chapter of the National Pan-Hellenic Council
23 Incorporated;

1 28. Organ, Eye and Tissue License Plate - such plates shall be
2 designed and issued to persons wishing to demonstrate support and
3 increase awareness for organ, eye and tissue donation. The license
4 plates shall be designed in consultation with the State Department
5 of Health;

6 29. Central Oklahoma Habitat for Humanity License Plate - such
7 plates shall be designed and issued to persons wishing to
8 demonstrate support and increase awareness for Habitat for Humanity.
9 The license plate shall be designed in consultation with Central
10 Oklahoma Habitat for Humanity;

11 30. Family Career and Community Leaders of America Incorporated
12 License Plate - such plates shall be designed and issued to persons
13 wishing to demonstrate support for Family Career and Community
14 Leaders of America Incorporated. The license plates shall be
15 designed in consultation with Family Career and Community Leaders of
16 America Incorporated;

17 31. Delta Sigma Theta License Plate - such plates shall be
18 designed and issued to any person who is a member of Delta Sigma
19 Theta Sorority. The license plates shall be designed in
20 consultation with the Oklahoma Chapter of Delta Sigma Theta Sorority
21 Incorporated;

22 32. Omega Psi Phi License Plate - such plates shall be designed
23 and issued to any person who is a member of Omega Psi Phi
24

1 Fraternity. The license plates shall be designed in consultation
2 with the Oklahoma Chapter of Omega Psi Phi Fraternity Incorporated;

3 33. Alpha Phi Alpha License Plate - such plates shall be
4 designed and issued to any person who is a member of Alpha Phi Alpha
5 Fraternity. The license plates shall be designed in consultation
6 with the Oklahoma Chapter of Alpha Phi Alpha Fraternity
7 Incorporated;

8 34. 50th Anniversary of the Interstate System of Highways
9 License Plate - such plates shall be designed and issued to persons
10 wishing to commemorate the 50th Anniversary of the Interstate System
11 of Highways. The license plates shall be designed in consultation
12 with the American Association of State Highway and Transportation
13 Officials;

14 35. Kappa Alpha Psi License Plate - such plates shall be
15 designed and issued to any person who is a member of Kappa Alpha Psi
16 Fraternity. The license plates shall be designed in consultation
17 with the Oklahoma Chapter of Kappa Alpha Psi Fraternity
18 Incorporated;

19 36. Sigma Gamma Rho License Plate - such plates shall be
20 designed and issued to any person who is a member of Sigma Gamma Rho
21 Sorority. The license plates shall be designed in consultation with
22 the Oklahoma Chapter of Sigma Gamma Rho Sorority Incorporated.
23 Subject to the provisions of subsection A of this section, the Sigma
24

1 Gamma Rho License Plate is hereby reauthorized effective November 1,
2 2013;

3 37. Multiple Sclerosis License Plate - such plates shall be
4 designed and issued to persons wishing to demonstrate support for
5 and increase awareness of multiple sclerosis. The license plates
6 shall be designed in consultation with the Oklahoma Chapter of the
7 National Multiple Sclerosis Society;

8 38. Frederick Douglass High School License Plate - such plates
9 shall be designed and issued to any person wishing to demonstrate
10 support for Frederick Douglass High School located in Oklahoma City.
11 The plates shall be designed in consultation with representatives of
12 Frederick Douglass High School National Alumni Association;

13 39. United States Air Force Academy License Plate - such plates
14 shall be designed and issued to any person wishing to demonstrate
15 support for the United States Air Force Academy;

16 40. In God We Trust License Plate - such plates shall be
17 designed to include the motto, "In God We Trust", and shall be
18 issued to any person wishing to demonstrate support for the motto;

19 41. National Weather Center License Plate - such plates shall
20 be designed and issued to any person wishing to demonstrate support
21 for the National Weather Center in Norman. The plates shall be
22 designed in consultation with representatives of the National
23 Weather Center Directors;

24

1 42. Make-A-Wish Foundation License Plate - such plates shall be
2 designed and issued to persons wishing to demonstrate support for
3 the Make-A-Wish Foundation. The license plates shall be designed in
4 consultation with the Oklahoma Chapter of the National Make-A-Wish
5 Foundation;

6 43. South Central Section PGA Foundation License Plate - such
7 plates shall be designed and issued to persons wishing to
8 demonstrate support for the South Central Section PGA Foundation.
9 The license plates shall be designed in consultation with the South
10 Central Section PGA Foundation;

11 44. Putnam City High School License Plate - such plates shall
12 be designed and issued to any person wishing to demonstrate support
13 for Putnam City High School. The plates shall be designed in

1 51. Historic Greenwood District License Plate - such plates
2 shall be issued to persons wishing to demonstrate support for music

20 be designed and issued to any person wishing to demonstrate support
21 for the BMW Car Club of America. The plates shall be issued to any
22 person in any combination of numbers and letters from one to a
23 maximum of seven, as for personalized license plates. The license
24 plate shall be designed in consultation with the Sunbelt Chapter of

1 the BMW Car Club of America. Subject to the provisions of
2 subsection A of this section, the BMW Car Club of America License
3 Plate is hereby reauthorized effective November 1, 2013;

4 56. Don't Tread On Me License Plate - such plates shall be
5 designed to include the yellow background and rattlesnake emblem
6 above the motto "DON'T TREAD ON ME" as found on the historic Gadsden
7 flag, and shall be issued to any person wishing to demonstrate
8 support for the freedom and liberty of the Republic;

9 57. Oklahomans for the Arts License Plate - such plates shall
10 be designed and issued to any person wishing to demonstrate support
11 for arts, culture and creative industries as well as arts education.
12 The plates shall be designed in consultation with Oklahomans for the
13 Arts;

14 58. Oklahoma City Barons License Plate - such plates shall be
15 designed and issued to any person wishing to demonstrate support for
16 the Oklahoma City Barons. The license plate shall be designed in
17 consultation with the Oklahoma City Barons organization. The
18 license plates shall be issued to any person in any combination of
19 numbers and letters from one to a maximum of six;

20 59. Oklahoma City Redhawks License Plate - such plates shall be
21 designed and issued to any person wishing to demonstrate support for
22 the Oklahoma City Redhawks. The license plate shall be designed in
23 consultation with the Oklahoma City Redhawks organization;

1 60. Tulsa Shock License Plate - such plates shall be designed
2 and issued to any person wishing to demonstrate support for the
3 Tulsa Shock. The license plate shall be designed in consultation
4 with the Tulsa Shock organization;

5 61. Tulsa Oilers License Plate - such plates shall be designed
6 and issued to any person wishing to demonstrate support for the
7 Tulsa Oilers. The license plate shall be designed in consultation
8 with the Tulsa Oilers organization;

9 62. Tulsa Drillers License Plate - such plates shall be
10 designed and issued to any person wishing to demonstrate support for
11 the Tulsa Drillers. The license plate shall be designed in
12 consultation with the Tulsa Drillers organization;

13 63. Millwood School District License Plate - such plates shall
14 be designed and issued to any person wishing to demonstrate support
15 for the Millwood School District. The license plate shall be
16 designed in consultation with representatives of the Millwood School
17 District;

18 64. Booker T. Washington High School License Plate - such
19 plates shall be issued to persons wishing to demonstrate support for
20 Booker T. Washington High School and shall be designed in
21 consultation with the Booker T. Washington High School National
22 Alumni Association;

23 65. Oklahoma Current State Flag License Plate - such plates
24 shall be designed to include the current Oklahoma state flag and

1 issued to any person wishing to demonstrate support for the current
2 Oklahoma state flag. The plates shall be designed in consultation
3 with the Friends of the Oklahoma History Center;

4 66. Oklahoma Original State Flag License Plate - such plates
5 shall be designed to include the original Oklahoma state flag and
6 issued to any person wishing to demonstrate support for the original
7 Oklahoma state flag. The plates shall be designed in consultation
8 with the Friends of the Oklahoma History Center. The plates shall
9 be issued to any person in any combination of numbers and letters
10 from one to a maximum of seven, as for personalized plates. Subject
11 to the provisions of subsection A of this section, the Oklahoma
12 Original State Flag license plate is hereby reauthorized effective
13 November 1, 2015;

14 67. Tulsa 66ers License Plate - such plates shall be designed
15 and issued to any person wishing to demonstrate support for the
16 Tulsa 66ers. The plates shall be designed in consultation with the
17 Tulsa 66ers Organization;

18 68. Frederick Bombers License Plate - such plates shall be
19 issued to persons wishing to demonstrate support for the Frederick
20 School District and shall be designed in consultation with
21 representatives of the Frederick School District;

22 69. 911 Dispatcher License Plate - such plates shall be issued
23 to persons wishing to demonstrate support for 911 dispatchers.
24 Persons applying for such license plate must show proof of current

1 employment as a 911 dispatcher or sign an attestation that they are
2 a currently employed or retired 911 dispatcher;

3 70. Oklahoma Fosters License Plate - such plates shall be
4 issued to persons wishing to demonstrate support for the Oklahoma
5 Fosters Initiative and shall be designed in consultation with the
6 Oklahoma Fosters Initiative; ~~and~~

7 71. Red Dirt Jeeps - such plates shall be designed and issued
8 to any person wishing to demonstrate support for Red Dirt Jeeps and
9 such plates shall be designed in consultation with Red Dirt Jeeps,

11 72. Southeast Spartans Plate - such plates shall be designed
12 and issued to any person wishing to demonstrate support for
13 Southeast Spartans High School and such plates shall be designed in
14 consultation with the Southeast High School Alumni Association.

15 C. The fee for such plates shall be Fifteen Dollars (\$15.00)
16 and shall be in addition to all other registration fees provided by
17 the Oklahoma Vehicle License and Registration Act. Unless otherwise
18 provided in this section, the fee shall be apportioned as follows:
19 Eight Dollars (\$8.00) of the special license plate fee shall be
20 deposited in the Oklahoma Tax Commission Reimbursement Fund to be
21 used for the administration of the Oklahoma Vehicle License and
22 Registration Act and the remaining Seven Dollars (\$7.00) of the
23 special license plate fee shall be apportioned as provided in
24 Section 1104 of this title.

1 SECTION 2. AMENDATORY 47 O.S. 2011, Section 1135.5, as
2 last amended by Section 1, Chapter 339, O.S.L. 2017 (47 O.S. Supp.
3 2017, Section 1135.5), is amended to read as follows:

4 Section 1135.5. A. The Oklahoma Tax Commission is hereby
5 authorized to design and issue appropriate official special license
6 plates to persons wishing to demonstrate support and provide
7 financial assistance as provided by this section.

8 Special license plates shall not be transferred to any other
9 person but shall be removed from the vehicle upon transfer of
10 ownership and retained. The special license plate may then be used
11 on another vehicle but only after such other vehicle has been
12 registered for the current year with a motor license agent.

13 Special license plates shall be renewed each year by the Tax
14 Commission or a motor license agent. The Tax Commission shall
15 annually notify by mail all persons issued special license plates.
16 The notice shall contain all necessary information and shall contain
17 instructions for the renewal procedure upon presentation to a motor
18 license agent or the Tax Commission. The license plates shall be
19 issued on a staggered system.

20 The Tax Commission is hereby directed to develop and implement a
21 system whereby motor license agents are permitted to accept
22 applications for special license plates authorized under this
23 section. The motor license agent shall confirm the applicant's
24 eligibility, if applicable, collect and deposit any amount

1 specifically authorized by law, accept and process the necessary
2 information directly into such system and generate a receipt
3 accordingly. For performance of these duties, motor license agents
4 shall retain the fee provided in Section 1141.1 of this title for
5 registration of a motor vehicle. The motor license agent fees for
6 acceptance of applications and renewals shall be paid out of the
7 Oklahoma Tax Commission Reimbursement Fund.

8 If fewer than one hundred of any type of special license plates
9 authorized prior to January 1, 2004, are issued prior to January 1,
10 2006, the Tax Commission shall discontinue issuance and renewal of
11 that type of special license plate. Any such authorized special
12 license plate registrant shall be allowed to display the license
13 plate upon the designated vehicle until the registration expiration
14 date. After such time the expired special license plate shall be
15 removed from the vehicle.

16 For special license plates authorized on or after July 1, 2004,
17 no special license plates shall be developed or issued by the Tax
18 Commission until the Commission receives one hundred prepaid
19 applications therefor. The prepaid applications must be received by
20 the Tax Commission within one hundred eighty (180) days of the
21 effective date of the authorization or the authority to issue shall
22 be null and void. In the event one hundred prepaid applications are
23 not received by the Tax Commission within such prescribed time
24 period any payment so received shall be refunded accordingly.

1 B. The special license plates provided by this section are as
2 follows:

3 1. University or College Supporter License Plates - such plates
4 shall be designed and issued to any person wishing to demonstrate
5 support to any state-supported or private university or college. As
6 provided in this section, an amount of the fee collected shall be
7 apportioned as provided in Section 1104.1 of this title;

8 2. Environmental Awareness License Plates - such plates shall
9 be designed, subject to the criteria to be presented to the Tax
10 Commission by the Department of Environmental Quality in
11 consultation with the Oklahoma Arts Council, and issued to any
12 person wishing to demonstrate support to implement the statewide
13 general public environmental education program created pursuant to
14 the provisions of the Oklahoma Environmental Quality Code. Such
15 plates shall be designed and issued to any person in any combination
16 of numbers and letters from one to a maximum of seven, as for
17 personalized license plates. A dealer's license plate issued
18 pursuant to Section 1116.1 or 1128 of this title may be designated
19 an Environmental Awareness License Plate upon payment of the fee
20 imposed by this section and any other registration fees required by
21 the Oklahoma Vehicle License and Registration Act. As provided in
22 this section, an amount of the fee collected shall be apportioned
23 pursuant to Section 1104.2 of this title;

1 3. Firefighter License Plates - such plates shall be designed
2 for any career or retired firefighter, volunteer or paid.
3 Firefighters may apply for firefighter plates for up to four
4 vehicles with a rated capacity of one (1) ton or less or for a
5 motorcycle upon proof of a fire department membership by either an
6 identification card or letter from the chief of the fire department.
7 Retirees who are eligible for such plates shall provide proof of
8 eligibility upon initial application, but shall not be required to
9 provide proof of eligibility annually. The surviving spouse of any
10 deceased firefighter, if the spouse has not since remarried, may
11 apply for a firefighter license plate for one vehicle with a rated
12 carrying capacity of one (1) ton or less or for a motorcycle upon
13 proof that the deceased firefighter was a member of a fire
14 department by either an identification card or letter from the chief
15 of the fire department. The license plate shall be designed in
16 consultation with the Oklahoma Firefighters Association.

17 As provided in this section, an amount of the fee collected
18 shall be deposited to the Oklahoma State Firemen's Museum Building &
19 Memorial Fund for support of the Oklahoma Firefighters Museum and
20 the Oklahoma Fallen and Living Firefighters Memorial;

21 4. Wildlife Conservation License Plates - such plates shall be
22 designed, subject to the criteria to be presented to the Tax
23 Commission by the Oklahoma Department of Wildlife Conservation in
24 consultation with the Oklahoma Arts Council, and issued to any

1 person wishing to demonstrate support for wildlife conservation in
2 this state through the Wildlife Diversity Fund, provided for in
3 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
4 be designed and issued to any person as for personalized license
5 plates.

6 As provided in this section, an amount of the fee collected
7 shall be apportioned pursuant to subsection D of Section 3-310 of
8 Title 29 of the Oklahoma Statutes;

9 5. Child Abuse Prevention License Plates - such plates shall be
10 designed, subject to the criteria to be presented to the Tax
11 Commission by the Office of Child Abuse Prevention in the State
12 Department of Health and the Oklahoma Committee to Prevent Child
13 Abuse, and issued to any person wishing to demonstrate support for
14 the prevention of child abuse.

15 As provided in this section, an amount of the fee collected
16 shall be deposited in the Child Abuse Prevention Fund;

17 6. United States Olympic Committee Supporter License Plates -
18 such plates shall be designed and issued to any person wishing to
19 demonstrate support for the United States Olympic Committee. The
20 plates shall be issued to any person in any combination of numbers
21 and letters from one to a maximum of seven, as for personalized
22 license plates. The plate shall contain the official United States
23 Olympic Committee logo. The Tax Commission shall be authorized, if
24 necessary, to enter into a licensing agreement with the United

1 States Olympic Committee for any licensing fees which may be
2 required in order to use the United States Olympic Committee logo or
3 design. The licensing agreement shall provide for a payment of not
4 more than Twenty-five Dollars (\$25.00) for each license plate
5 issued;

6 7. Oklahoma History License Plates - such plates shall be
7 designed and issued to any person wishing to demonstrate interest in
8 Oklahoma history. As provided in this section, an amount of the fee
9 collected shall be deposited to the Oklahoma Historical Society
10 Revolving Fund to be used for educational purposes;

11 8. Historic Route 66 License Plates - such plates shall be
12 designed to honor historic Route 66, also known as the "Mother
13 Road". As provided in this section, an amount of the fee collected
14 shall be apportioned to the Oklahoma Historical Society Revolving
15 Fund to be distributed to the Route 66 Museum located in Clinton,
16 Oklahoma;

17 9. Heart of the Heartland License Plates - such plates shall be
18 designed and issued to any person wishing to honor the victims of
19 the terrorist bombing attack on the Alfred P. Murrah Federal
20 Building in downtown Oklahoma City on April 19, 1995. As provided
21 in this section, an amount of the fee collected shall be deposited
22 in the Heart of the Heartland Scholarship Fund, as established in
23 Section 2282 of Title 70 of the Oklahoma Statutes;

1 10. Emergency Medical Technician License Plates - such plates
2 shall be designed and issued to any person who is an emergency
3 medical technician. Such persons may apply for an emergency medical
4 technician license plate for each vehicle with a rated carrying
5 capacity of one (1) ton or less upon proof of an emergency medical
6 technician's license. The license plate shall be designed in
7 consultation with the state association of emergency medical
8 technicians. As provided in this section, an amount of the fee
9 collected shall be apportioned to the Emergency Medical Personnel
10 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
11 of the Oklahoma Statutes;

12 11. Fight Breast Cancer License Plates - such plates shall be
13 designed to demonstrate support for the prevention and treatment of
14 breast cancer in this state. As provided in this section, an amount
15 of the fee collected shall be apportioned to the Breast Cancer Act
16 Revolving Fund;

17 12. Crime Victims Awareness License Plates - such plates shall
18 be designed and issued to any person wishing to demonstrate
19 awareness of and support for victims of crimes. The license plates
20 shall be designed in consultation with the Oklahoma Crime Victims
21 Centre. As provided in this section, an amount of the fee collected
22 shall be apportioned to the Attorney General's Revolving Fund for
23 the Office of the Attorney General, which is hereby directed to use
24

1 such funds to contract with a statewide nonprofit organization to
2 provide services to crime victims;

3 13. Oklahoma Safe Kids Association License Plates - such plates
4 shall be designed and issued to any person wishing to demonstrate
5 support and awareness of the Oklahoma Safe Kids Association. The
6 license plate shall be designed in consultation with the Oklahoma
7 Safe Kids Association. As provided in this section, an amount of
8 the fee collected shall be deposited in the Children's Hospital -
9 Oklahoma Safe Kids Association Revolving Fund to be distributed to
10 the Oklahoma Safe Kids Association program;

11 14. Four-H Club License Plates - such plates shall be designed,
12 subject to criteria to be presented to the Tax Commission by the
13 Four-H Foundation, and issued to any person wishing to demonstrate
14 support of the Four-H Club. Such plates may be designed and issued
15 to any person as for personalized license plates. As provided in
16 this section, an amount of the fee collected shall be apportioned to
17 the OSU Extension Service License Plate Revolving Fund created in
18 Section 1104.4 of this title;

19 15. Agricultural Awareness License Plates - such plates shall
20 be designed, subject to criteria to be presented to the Tax
21 Commission, by the Oklahoma Department of Agriculture, Food, and
22 Forestry in consultation with the Oklahoma Arts Council, and issued
23 to any person wishing to demonstrate support of the Department's Ag
24 in the Classroom Education Program. As provided in this section, an

1 amount of the fee collected shall be apportioned as provided in
2 Section 1104.3 of this title;

3 16. Oklahoma Statehood Centennial License Plates - such plates
4 shall be designed and issued to any person wishing to commemorate
5 the centennial of Oklahoma's admission to statehood in 1907. The
6 license plates shall be designed in consultation with the Oklahoma
7 Capitol Complex and Centennial Commemoration Commission. As
8 provided in this section, an amount of the fee collected shall be
9 deposited in the Oklahoma Capitol Complex and Centennial
10 Commemoration Commission Revolving Fund created in Section 98.5 of
11 Title 73 of the Oklahoma Statutes;

12 17. Support Education License Plates - such plates shall be
13 designed, subject to criteria to be presented to the Tax Commission
14 by the State Department of Education in consultation with the
15 Oklahoma Arts Council, and issued to any person wishing to
16 demonstrate support for education in this state. All motor license
17 agents shall display a sample of the Support Education License plate
18 in the area of the business accessed by the public. Twenty-three
19 Dollars (\$23.00) of the fee collected shall be apportioned as
20 follows:

- 21 a. five percent (5%) shall be deposited to the Education
22 Reform Revolving Fund,
- 23 b. five percent (5%) shall be deposited to the Higher
24 Education Revolving Fund,

- 1 c. five percent (5%) shall be deposited to the State
2 Career Technology Fund, and
- 3 d. eighty-five percent (85%) of the fee shall be
4 deposited to the Teachers' Retirement Benefit Fund as
5 set forth in Section 17-108 of Title 70 of the
6 Oklahoma Statutes.

7 However, when the Teachers' Retirement Benefit Fund attains a
8 seventy percent (70%) funded ratio based on an annual actuarial
9 valuation as required by law, the amount of the fee shall be
10 apportioned equally pursuant to subparagraphs a, b and c of this
11 paragraph;

12 18. Retired Oklahoma Highway Patrol Officers License Plates -
13 such plates shall be designed and issued to any retired officer of
14 the Oklahoma Highway Patrol. The license plate shall have the
15 legend "Oklahoma" and shall contain, in the center of the plate, the
16 Highway Patrol Officers patch using the same colors and pattern as
17 used in the patch. Centered on the bottom of the license plate
18 shall be the word "Retired". The letters "TRP" shall be used in
19 combination with three numbers on either side of the insignia or
20 emblem. The color of the letters and numbers shall be brown.

21 Retirees who are eligible for such plates shall provide proof of
22 eligibility upon initial application, but shall not be required to
23 provide proof of eligibility annually. The surviving spouse of any
24 deceased retired officer of the Oklahoma Highway Patrol, if the

1 spouse has not since remarried, or if remarried, the remarriage is
2 terminated by death, divorce, or annulment, may apply for a Retired
3 Oklahoma Highway Patrol Officers license plate. As provided in this
4 section, an amount of the fee collected shall be deposited into the
5 Law Enforcement Retirement Fund;

6 19. Boy Scouts of America Supporter License Plates - such
7 plates shall be designed and issued to any person wishing to
8 demonstrate support for the Boy Scouts of America. The plates shall
9 be issued to any person in any combination of numbers and letters
10 from one to a maximum of seven, as for personalized license plates.
11 The plate shall contain the official Boy Scouts of America logo.
12 The Tax Commission shall be authorized, if necessary, to enter into
13 a licensing agreement with the Boy Scouts of America for any
14 licensing fees which may be required in order to use the Boy Scouts
15 of America logo or design. The licensing agreement shall provide
16 for a payment to the Boy Scouts of America of not more than Twenty
17 Dollars (\$20.00) for each license plate issued;

18 20. Urban Forestry and Beautification License Plates - such
19 plates shall be designed, subject to criteria to be presented to the
20 Tax Commission, by the Oklahoma Department of Agriculture, Food, and
21 Forestry in consultation with nonprofit organizations in this state
22 that develop and operate programs to encourage urban forestry and
23 beautification, and issued to any person wishing to demonstrate
24 support of such programs. As provided in this section, an amount of

1 the fee collected shall be apportioned as provided in Section 1104.5
2 of this title;

3 21. Oklahoma State Parks Supporter License Plates - such plates
4 shall be designed, subject to criteria to be presented to the Tax
5 Commission by the Oklahoma Tourism and Recreation Department, and
6 issued to any person wishing to demonstrate support for the Oklahoma
7 state parks system. Twenty-three Dollars (\$23.00) of the fee
8 collected shall be deposited in the Oklahoma Tourism and Recreation
9 Department Revolving Fund. Such money shall be designated for and
10 may only be expended for the support of Oklahoma state parks;

11 22. Adoption Creates Families License Plates - such plates
12 shall be issued to any person wishing to demonstrate support of
13 pregnant women who are committed to placing their children for
14 adoption and wishing to provide assistance to guardians, adoptive
15 parents and other created families to assist in the adoption and
16 placement of children in permanent, safe homes. The license plates
17 shall be designed and final terminology delivered in consultation
18 with the Oklahoma Adoption Coalition and the Department of Human
19 Services. Twenty-five Dollars (\$25.00) of the fee collected shall
20 be deposited in a revolving fund established in the State Treasury
21 for and to be used by the Department of Human Services for the
22 implementation of the Investing in Stronger Oklahoma Families Act
23 specifically for created families;

1 23. Choose Life License Plates - such plates shall be designed,
2 subject to criteria presented to the Tax Commission, by Choose Life,
3 Inc., and issued to any person who wishes to demonstrate support of
4 organizations that encourage adoption as a positive choice for women
5 with unplanned pregnancies. As provided in this section, an amount
6 of the fee collected shall be deposited in the Choose Life
7 Assistance Program Revolving Fund established in Section 1104.6 of
8 this title;

9 24. Future Farmers of America License Plate - such plates shall
10 be designed and issued to persons wishing to demonstrate support for
11 the Oklahoma FFA (formerly known as Future Farmers of America). The
12 license plates shall be designed in consultation with the Oklahoma
13 FFA Foundation Board of Directors. As provided in this section, an
14 amount of the fee collected shall be apportioned as provided in
15 Section 1104.7 of this title;

16 25. Lions Club License Plates - such plates shall be designed
17 and issued to persons wishing to demonstrate support for the Lions
18 Club of Oklahoma. The plates shall be issued to any person in any
19 combination of numbers and letters from one to a maximum of seven,
20 as for personalized license plates. The license plates shall be
21 designed in consultation with the Oklahoma Lions Service Foundation
22 and shall contain the official logo of the International Association
23 of Lions Clubs. The Tax Commission shall be authorized to enter
24 into a licensing agreement with the Oklahoma Lions Service

1 Foundation. The licensing agreement shall provide for a payment to
2 the Oklahoma Lions Service Foundation of not more than Ten Dollars
3 (\$10.00) for each license plate issued;

4 26. Color Oklahoma License Plates - such plates shall be
5 designed, subject to criteria to be presented to the Tax Commission
6 by the Oklahoma Native Plant Society, and issued to any person
7 wishing to demonstrate support for preserving and planting
8 wildflowers and native plants in Oklahoma and to promote Oklahoma's
9 wildflower heritage through education. As provided in this section,
10 an amount of the fee collected shall be apportioned as provided in
11 Section 1104.8 of this title;

12 27. Girl Scouts of the United States of America Supporter
13 License Plates - such plates shall be designed and issued to any
14 person wishing to demonstrate support for the Girl Scouts of the
15 United States of America. The plates shall be issued to any person
16 in any combination of numbers and letters from one to a maximum of
17 seven, as for personalized license plates. The plate shall contain
18 the official Girl Scouts of the United States of America logo. The
19 Tax Commission shall be authorized, if necessary, to enter into a
20 licensing agreement with the Girl Scouts of the United States of
21 America for any licensing fees which may be required in order to use
22 the Girl Scouts of the United States of America logo or design. The
23 licensing agreement shall provide for a payment to the Girl Scouts
24 of Magic Empire Council, acting on behalf of all Oklahoma Girl Scout

1 councils, of not more than Twenty Dollars (\$20.00) for each license
2 plate issued;

3 28. Oklahoma City Memorial Marathon License Plates - such
4 plates shall be designed and issued to any person wishing to
5 demonstrate support for the Oklahoma City Memorial Marathon. The
6 plate shall be designed in consultation with the Oklahoma City
7 Memorial Marathon. The Tax Commission shall be authorized to enter
8 into a licensing agreement with the Oklahoma City Memorial Marathon
9 for any licensing fees which may be required in order to use the
10 Oklahoma City Memorial Marathon logo or design. The licensing
11 agreement shall provide for a payment to the Oklahoma City Memorial
12 Marathon of not more than Twenty Dollars (\$20.00) for each license
13 plate issued;

14 29. Oklahoma Scenic Rivers License Plate - such plates shall be
15 designed to demonstrate support for the Oklahoma Scenic Rivers. The
16 plates shall be designed in consultation with the Oklahoma Scenic
17 Rivers Commission. Twenty-five Dollars (\$25.00) of the fee shall be
18 apportioned to the Oklahoma Scenic Rivers Commission;

19 30. Fight Cancer License Plate - such plates shall be designed
20 to demonstrate support for the Oklahoma Central Cancer Registry.
21 The plate shall contain the American Cancer Society logo. The
22 American Cancer Society logo shall be used in accordance with the
23 American Cancer Society's branding guidelines and shall only be
24 utilized to support the Oklahoma Central Cancer Registry. Twenty

1 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
2 Central Cancer Registry Revolving Fund;

3 31. Animal Friendly License Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate support for
5 controlling the overpopulation of dogs and cats through educational
6 and sterilization efforts. The plates shall be designed in
7 consultation with the Veterinary Medical Association. Twenty
8 Dollars (\$20.00) of the fee collected shall be designated by the
9 purchaser of the plate to be deposited in the Oklahoma Pet
10 Overpopulation Fund created in Section 2368.13 of Title 68 of the
11 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
12 Section 1104.10 of this title;

13 32. Patriot License Plate - such plates shall be designed in
14 consultation with the Military Department of Oklahoma and issued to
15 any person wishing to demonstrate support for Oklahoma residents who
16 are members of the Oklahoma National Guard and deployed on active
17 duty. The plates shall be issued to any person in any combination
18 of numbers and letters from one to a maximum of seven, as for
19 personalized license plates. As provided in this section, a portion
20 of the fee collected shall be deposited in the Patriot License Plate
21 Revolving Fund created in Section 1104.11 of this title;

22 33. Global War on Terrorism License Plate - such plate shall be
23 designed in consultation with the Military Department of Oklahoma
24 and issued to any person wishing to demonstrate support for Oklahoma

1 residents who are members of the Armed Forces of the United States
2 or Oklahoma National Guard that have served in the Global War on
3 Terrorism. The plate shall be issued to any person in any
4 combination of numbers and letters from one to a maximum of six. As
5 provided in this section, a portion of the fee collected shall be
6 deposited in the 45th Infantry Division Museum Fund created in
7 Section 235.1 of Title 44 of the Oklahoma Statutes;

8 34. Boys and Girls Clubs of America Supporter License Plates -
9 such plates shall be designed and issued to any person wishing to
10 demonstrate support for the Boys and Girls Clubs of America. The
11 plates shall be issued to any person in any combination of numbers
12 and letters from one to a maximum of seven, as for personalized
13 license plates. The plate shall contain the official Boys and Girls
14 Clubs of America logo. The Tax Commission, if necessary, may enter
15 into a licensing agreement with the Boys and Girls Clubs of America
16 for any licensing fees which may be required in order to use the
17 Boys and Girls Clubs of America logo or design. The licensing
18 agreement shall provide for a payment to the Boys and Girls Clubs of
19 America of not more than Twenty Dollars (\$20.00) for each license
20 plate issued;

21 35. Oklahoma Quarter Horse License Plates - such plates shall
22 be designed and issued to any person wishing to demonstrate support
23 for the American Quarter Horse in Oklahoma. The plate shall be
24 designed in consultation with the Oklahoma Quarter Horse

1 Association. As provided in this section, a portion of the fee
2 collected shall be deposited in the Oklahoma Quarter Horse Revolving
3 Fund created in Section 1104.12 of this title;

4 36. Oklahoma Association for the Deaf License Plate - such
5 plates shall be designed in consultation with the Oklahoma
6 Association for the Deaf and issued to any person wishing to
7 demonstrate support for Oklahoma residents who are deaf. The plates
8 shall be issued to any person in any combination of numbers and
9 letters from one to a maximum of seven, as for personalized license
10 plates. As provided in this section, a portion of the fee collected
11 shall be deposited in the Oklahoma Association for the Deaf License
12 Plate Revolving Fund created in Section 1104.15 of this title;

13 37. Oklahoma City Zoo License Plate - such plates shall be
14 issued to any person wishing to demonstrate support for the Oklahoma
15 City Zoo. The license plates shall be designed in consultation with
16 the Oklahoma Zoological Society, Inc. As provided in this section,
17 an amount of the fee collected shall be deposited in the Oklahoma
18 Zoological Society Revolving Fund created in Section 1104.13 of this
19 title;

20 38. March of Dimes License Plate - such plates shall be issued
21 to persons wishing to demonstrate support for the March of Dimes
22 mission to improve the health of babies by preventing birth defects,
23 premature birth and infant mortality. The license plates shall be
24 designed in consultation with the Oklahoma Chapter March of Dimes.

1 As provided in this section, an amount of the fee collected shall be
2 deposited in the Oklahoma Prevent Birth Defects, Premature Birth and
3 Infant Mortality Fund established in Section 1104.14 of this title;

4 39. Support Our Troops Supporter License Plates - such plates
5 shall be designed and issued to any person wishing to demonstrate
6 support for Support Our Troops Incorporated. The plates shall be

17 40. Folds of Honor Supporter License Plate - such plates shall
18 be designed and issued to any person wishing to demonstrate support
19 for Folds of Honor Incorporated, a nonprofit charitable organization
