requirements on any profession if the political subdivision does not already impose occupational fees or licensing requirements on that profession. Notwithstanding the above, the political subdivision may continue to so regulate any profession or occupation that is subject to occupational fees or licensing requirements on or before November 1, 2018, if the occupational fees do not exceed Twenty-five Dollars (\$25.00) per year. If a profession is already subject to political subdivision occupational fees that exceed Twenty-five Dollars (\$25.00) per year, the existing occupational fees imposed do not apply and the licensing authority shall immediately reduce occupational fees in accordance with the limits set by this act.

- 2. With regard to professions subject to licensing requirements imposed by a state licensing authority, a political subdivision of this state shall not impose any regulations on such professions that add additional licensing requirements to those already imposed by a state licensing authority.
- 3. Beginning on November 1, 2018, if a state licensing authority imposes any new licensing requirements on any profession that was previously unregulated by the state, and if the political subdivision regulates the profession when the state regulations take effect, the political subdivision may not continue to require occupational fees or licensing requirements for the profession on or after the date when the state regulations take effect.

B. Waiver of licensing fees for low-income individuals and military families.

- 1. All state and political subdivision licensing authorities shall waive all initial occupational fees and fees for licensing requirements for low-income individuals. These initial fees shall also be waived for military families, and young workers.
- 2. Individuals seeking a waiver of initial occupational fees and fees for licensing requirements must apply to the appropriate licensing authority in a format prescribed by the licensing authority. The licensing authority shall process the application within thirty (30) days of receiving it from the applicant, unless there is a reasonable cause for delay including, but not limited to, additional time requirements to obtain fingerprints and a national or state criminal history records check or to obtain additional documentation required for consideration of the application or to complete license requirements.
- 3. The licensing authority shall adopt necessary rules for the implementation of this section.
- 4. For purposes of this section the following definitions shall apply:
 - a. "low-income individual" means an individual whose taxable family income for the preceding year did not exceed one hundred percent (100%) of the state poverty level amount,

b. "military families" means:

- (1) a current member of the U.S. Armed Forces who is on active duty in this state or claims permanent residency in this state for the six (6) months prior to assignment to active duty or during the period of active duty or their spouse who is subject to a military transfer to this state or who claims permanent residency in this state at the time of application for waiver of occupational or license fees, or
- (2) a person honorably discharged from active duty in the U.S. Armed Forces within the previous three-year period and who claims permanent residency in this state for at least one (1) year preceding an application for waiver of occupational or license fees or their spouse who claims permanent residency in this state for at least one (1) year preceding an application for waiver of occupational or license fees, or
- (3) the spouse of a deceased active duty member or honorably discharged member of the U.S. Armed

 Forces if the service member's death occurred not more than three (3) years prior to an application for waiver of occupational or license fees and

1 the spouse claims permanent residency in this 2 state for at least one (1) year preceding an 3 application for waiver of occupational or license fees, and 4 5 "young workers" means an individual aged sixteen (16) years through twenty (20) years. 6 7 5. The provisions of this section authorizing application for waiver of occupational or license fees shall not apply to students 8 9 enrolled in an institution of higher education, career and 10 technology center or occupational trade school that is required to 11 collect or routinely collects occupational fees or license fees as 12 part of tuition, educational requirements, practicum, provisional 13 license, pre-license requirements, organizational membership, or the 14 graduation process.
